Proceeding No. 69/2018

Inquiry Report

Taking suo motu cognizance of the report which appeared in the daily 'Lokmat' dated 02-04-2018, under the caption "Vizvahinyamule Gharala Dhoka" (Danger to the house on account of electrical wires), this Commission issued notice to the Executive Engineer, Electricity Department, Division XVII, Mapusa-Goa, to submit detailed report. In pursuance to the notice, the Respondent submitted a detailed report dated 30-04-2018.

2. We have perused the entire records of this case. The records indicate that there is danger to human life due to electrical cables passing through the house of Shri Uday Tamhankar. The records also indicate that the electric cables were installed after the construction of the house of Shri Uday Tamhankar.

3. As per the report submitted by the Respondent, a public grievance meeting was held on 23-09-2017, which was called by the Minister for WRD & Fisheries, Government of Goa at Oxel Panchayat hall and at that time, the said Shri Uday Tamhankar raised the point about the passing of LT line over his house at Bhatiwada, Oxel, Siolim, Goa. It is stated that the inspection of the site was carried out along with Shri Uday Tamhankar and the estimate for the work of shifting of LT line near the house of Shri Uday Tamhankar as per the request of Shri Uday Tamhankar was prepared to execute the said work through licensed electrical contractor. The said Shri Tamhankar was informed to make necessary payment of supervision charges as per the estimate. However, the said Shri Tamhankar has not paid the necessary supervision charges nor intimated the name of the licensed electrical contractor through whom he will be executing the said work of shifting of LT line passing over his house, hence the work of shifting could not be taken up.

4. According to the Respondent, considering all the aspects such as technical feasibility for shifting of electrical line, objection from the neighbour for shifting the line and safety aspect of the line, the immediate solution is to convert the existing line with bare aluminium conductor with PVC insulated aluminium single core cable of size 50 sqmm. each for 6 Nos. bare conductor between pole No. LT173-80/2/1 and LT173-80/2/2 without disturbing the existing route of the line. We agree with suggestion made by the Respondent.

5. In view of the above, we make the following recommendation:-

The Respondent shall take immediate action to convert the existing line with bare aluminium conductor with PVC insulated aluminium single core cable of size 50 sqmm. each for 6 Nos. bare conductor between pole No. LT173-80/2/1 and LT173-80/2/2 without disturbing the existing route of the line.

Sir,

With respect to the enquiry report of Proceeding No. 69/2018 and as per the reply received by Assistant Engineer, Elect. S/D-III, Agarwada vide letter No. Est-04/O&M-II/Siolim/Agar-III/2018-19/598 dated 06-07-2018 (copy enclosed), it is amply

clear that Shri Uday Tamankar has constructed his house beneath the existing line. The LT 3 phase line existed since 1972 and the house of Shri Uday Tamankar was constructed beneath the line in 1989. This is evident since the electric connection to Shri Uday Tamankar was released in 1989.

As per your suggestions, the existing bare 3 phase line passing over the house of Shri Uday Tamankar will be proposed to be replaced with insulated conductor between Pole No. LT 173-80/2/1 and LT/173-80/2/2, however as per the procedures of the Department, Shri Uday Tamankar has to bear the cost of the work since he has not maintained proper clearances as per I.E. Act.

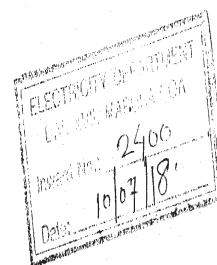
Panaji-Goa. Vide letter No. AE/III/O&M/18-19/Tech-42/174 dated 30-4-2017. The Under Secretary, Goa Human Rights Commission was informed that the said LT 3 phase 6 wire bare conductor line at Bhatiwadi, Oxel existed since August, 1972 (refer para 6 & 7 of reply to Notice dated 02-04-2018 & Late Mr. Vasant Tamankar, r/o H. No. 469/7, father of Shri Uday Tamankar applied for electrical connection in August, 1989 which indicates that he has constructed his house beneath the existing LT 3 phase line. This is in contravention with the Indian Electricity Rules.

During the public grievance meeting held on 22-9-2017, held by Hon'ble Minister for WRD at Panchayat Hall and as per the request of Shri Uday Tamankar, s/o Shri Vasant Tamankar, an estimate for shifting of LT line was prepared and sanctioned vide Order No. Est-23(17-18)Dept-II/Agr-III/17-18/684 dated 23-11-2017 intimation was forwarded to Shri Uday Tamankar vide No. Est23(17-18)Dep-II/Agr-III/17-18/1231 dated 26-03-2018 and vide No. Est23(17-18)Dep-II/Agr-III/17-18/25 dated 06-04-2018 effect payment, however he has not paid the said shifting charges.

Besides it is to bring to your kind notice that Shri Uday Tamankar has verbally claimed that his house is in existence before the erection of LT line at Bhatiwada, Oxel, Siolim (i.e. prior to year 1972) but no evidentiary proof such as Construction Licensed, House Tax Receipt of Occupancy Certificate from Village Panchayat Oxel had been produced by him to support his claim that line was forcebally strung over his house.

This is for information and further needful action.
