**Under Section 144 of Criminal
Procedure Code, 1973**

Whereas, the General Elections to Ponda Municipal Council, is scheduled to be held on 29th April, 2018 and accordingly the Election Code of Conduct is announced and directions issued from the office of the Goa State Election Commissioner, Althino, Panjim, Goa to ensure free, fair and peaceful elections, are in force;

And whereas, there is sufficient ground for proceeding under sub-section (1) of Section 144 of Criminal Procedure Code, 1973 and impose ban for carrying of any type of arms and firearms and other lethal weapons, to ensure free, fair and peaceful conduct of the said elections and also to prevent obstruction/annoyance/injury to any person; danger to human life/security; or disturbance of public tranquility; or riot/affray during the complete election process.

And whereas, I am satisfied that the circumstances do not permit serving of the notices individually to all concerned.

Now therefore, I, Anjali Sehrawat, IAS, District Magistrate, South Goa District, Margao in exercise of the powers vested in me under Section 144 of Cr. P. C., 1973 do hereby prohibit all the arms licence holders of Ponda Taluka, from carrying any type of arms/firearms/ammunition/lethal weapons, etc. in any public place/street/road squares/through-

fare/by lanes, or in any open place in entire Ponda Taluka of South Goa, with immediate effect until further orders.

Further, all the arm licence holders of Ponda Taluka in South Goa District are directed to deposit all their firearms at the Police Stations of their respective jurisdiction positively before 12th day April, 2018. All the firearms deposited will be returned to the licence holders five days after the completion of counting of votes.

Further, any person from outside Ponda Taluka is also prohibited to carry his/her licenced weapons within the territorial jurisdiction of Ponda Taluka with immediate effect till further orders.

The above restrictions shall not apply to on-duty (election) Public Servants/Police/Defence Personnel and Security Personnel and any other person especially exempted from the purview of this order.
