The above Speed Breakers shall be painted with white thermoplastic fluorescent paint and fixed with blinkers for better visibility.

Further, in exercise of the powers conferred on me under Section 116 of the above Act, I also authorize the erection of cautionary signboards "Speed Breaker", at about 40 mts. on either side of the speed breaker in advance of the speed breaker and traffic signboard showing the sign "Speed Breaker" at the placement of the speed breaker in order to regulate the motor vehicular traffic.

The Secretary, Village Panchayat Pomburpa-Olaulim, Bardez and P.W.D. (Engineering Cell) is directed to publish this notification through the Director of Information and Publicity in local newspapers and to make necessary arrangements to construct the Speed Breakers and to erect the signboards at the places indicated above as per the specification laid down by the Ministry of Road Transport and Highways and as published in the Official Gazette, Series I No. 15 dated 15-07-2005 by the Government of Goa and report compliance within fifteen days time.

In exercise of the powers conferred on me under the provisions of Motor Vehicles Act, 1988 (Central Act 59 of 1988) read with Govt. Notification No. 5/28/88/TPT(part), dated 26th September, 1989, and in the interest of Tourist in particular and public in general, I, Levinson J. Martins, District Magistrate, North Goa District, Panaji hereby "prohibit the movement of all kinds of Motor Vehicles on the beaches within the jurisdiction of North Goa District except the following vehicles as used:-

- 1) Vehicles deployed for the purpose of comprehensive Management of cleanliness on beaches as authorized by Director of Tourism from time to time.

- 2) Vehicles for beach lifeguarding service as authorized by Director of Tourism from time to time.
- 3) Vehicles of Tourist Security Force as authorized by Director of Tourism from time to time.
- 4) Vehicles of Police Department as authorized by the undersigned after receipt of N.O.C. from Tourism Department.

Subject to the condition that care should be taken to avoid turtle nesting sites during patrolling and also no sanddune vegetation and turtles should be disturbed whenever required all such vehicles authorized to ply on the beaches only for official purpose shall also take prior permission from Goa Coastal Zone Management Authority and such other Statutory Authority whose permissions are mandatory.

The Director of Tourism shall furnish to the undersigned list of the vehicles which are permitted by the Department to ply in the beaches in the North Goa District with copy to Supdt. of Police and also periodically endorse a copy of all permissions in future.

Further, in exercise of the powers conferred on me under section 116 of the Motor Vehicles Act, I authorize the Director of Tourism to erect the sign boards at all the designated beaches at every motorable exit and entry points and other vantage points at a distance of at least 500 meters apart for information of all.
