#### (Section 144 of the Code of Criminal Procedure of 1973)

Read No. 1. SP/S-Goa/Reader/10498/2018 dated 13-11-2018 from the Supdt. of Police, South Goa, Margao.

2. This office Order No. 37/113/2008/Mag/10979 dated 20-09-2018.

Whereas, it is reported by the Superintendent of Police, South Goa District, Margao, that criminals with an intention of committing crime in Goa, usually stay in hotels/rented premises with fictitious names and bogus residential/official address and telephone numbers and after commission of crime, it becomes difficult to identify culprits, as the details furnished by them to the hotels/landlords, are found fictitious/bogus.

And whereas, the terrorists/anti-social elements can camouflage their identity for their operations, as hotel owners/landlords neither follow the procedures of verifying the antecedents of the person to whom they rent their premises nor inform the same to the local police. Further, there are cases where the tenants further sublet the premises without the knowledge of landlords.

And whereas, it is imperative to take preventive action particularly during the impending peak tourist season in Goa.

Therefore, on being satisfied with the report of the Superintendent of Police, South Goa District, Margao, I, Dr. Tariq Thomas, IAS, District Magistrate, South Goa District, Margao in exercise of the powers vested in me under Section 144 of the Code of Criminal Procedure, 1973, do hereby:-

a) Order that Owners/Management of all Hotels, Lodging & Boarding, Private Guest Houses, Paying Guest Accommodation, Temporary Residential Accommodation including that of religious bodies to prohibit any visitors/guest to check-in without providing any photo identity proof such as Election Card, Driving License, Smart Card, Employment Card, Adhar Card or any other duly issued by Government. A self attested copy of same may be retained for record.

b) Order that no landlords/tenants/owner/person of any house/property which falls under the territorial jurisdiction of South Goa District, Goa shall let/sublet/rent out any accommodation to any person unless and until he/she has furnished the particulars of the tenants to the Police In-charge of the concerned area.

c) Order that the Incharges of such accommodation shall provide such facilities for inspection of the record to the Police authorities or any other authority authorized by the undersigned if so desired by them.

The circumstances do not permit serving of the notice individually to the concerned in due time. Therefore, the order is hereby passed ex-parte. It shall be published for information of public through Press and also by affixing copies on the Notice Boards of the offices of all Sub-Divisional Magistrates, Mamlatdars and Police Stations.

This order shall come into force with effect from 22-11-2018 and shall remain in operation for a period of 60 days (both days inclusive) unless withdrawn earlier.

Note—Violation of this order is punishable u/s 188 IPC.

3. This office letter dated 21-05-2018.
4. Minutes of the meeting of the District Level Road Digging Co-ordination Committee for South Goa held in this office on 04-10-2018 at 4.30 p.m.
5. Corrigendum No. 1/1/17/2018-RD/2348 dated 05-11-2018 issued by the Revenue Department Secretariat, Porvorim, Goa.

Whereas, the Sewerage & Infrastructural Development Coporation of Goa Ltd., Margao vide letters dated 24-03-2018 and 09-08-2018 had informed that their office had laid the Sewerage pipeline by trenchless (HDD) method from Laxmi Bakery to Babu Naik House and that the SIDCGL was taking up the work of construction of manholes (11 nos.) balance work. The road stretch is about 470 mtrs. which is very narrow and requested to issue permission for traffic diversion including road cutting and temporary road closure from Laxmi Bakery to Babu Naik house at Aquem, Margao.

And whereas, the Superintendent of Police, South Goa, Margao, vide letter dated 07-05-2018 has submitted no objection for temporary closure of road.

And whereas, the Sewerage & Infrastructural Development Corporation of Goa Ltd., Margao vide this office letter dated 21-05-2018 was informed to take up the work after monsoons.

And whereas, it is revealed that the work mentioned above is of urgent nature and it requires to divert the traffic;

And whereas, I am satisfied that the diversion of traffic is essential during execution of the above work;

Therefore, I, Dr. Tariq Thomas, IAS, District Magistrate, South Goa, Margao, in exercise of powers conferred under Sections 115 and 116 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) read with Government Notification No. 5/28/88/TPT (part) dated 26th September, 1989 being satisfied that it is necessary in the interest of public safety and convenience do hereby permit for temporary closure of road from Laxmi Bakery to Babu Naik House at Aquem, Margao and to also temporarily divert, all type of vehicular traffic as per annexed plan for 75 days and erect the signages accordingly subject to compliance with the conditions mentioned below:-

1. The applicant/contractor is directed to ensure that no annoyance is caused to the general public and nearby residents.
2. Should adhere to all the rules and regulation in force.
3. The applicant/contractor is directed to obtain necessary permission from other competent authorities.
4. The applicant/contractor is directed to take necessary precautions and engage all safety measures during the execution of the work.
5. The applicant/contractor is directed to ensure the safety and security of the road commuters.
6. The applicant/contractor is directed to deploy sufficient number of security guards/traffic marshals/volunteers with retro reflective jackets at either side of the culvert for traffic control and regulation.
7. The applicant/contractor is directed to display proper signages of "Road Closed", "No Entry", "Take Diversion/work in progress" etc. on both the sides of road closure, flash light for guidance of the motorists, pedestrians and other road users.
8. If any untoward incident arises due to poor barricading/non-applying of glowing/reflective tapes then the concerned contractor/PWD authorities shall be held responsible for the same and be liable for criminal proceedings.
9. The applicant/contractor is directed to ensure that there are no loose gravels of soil/stones, leftovers on the road/shoulder of the road after the completion of work.
10. All safety measures shall be adopted by the applicant/contractor for ensuring safety of the workers engaged for the construction work and of the motorists, pedestrians, etc.
11. The area around the work should be properly/strongly barricaded and illuminated with red light, glowing/reflective tapes to prevent accidental falling of pedestrians, motorists, cattle and other road users.
12. The applicant/contractor is directed to approach IC Traffic Cell, Margao, with a formal request for deployment of Traffic Police, if required for traffic regulation, on advance payment basis as per prevailing Govt. rates/service tax, etc. The same shall be provided as per availability.
13. The equipments/material if any kept on the proposed road shall be covered with illuminating warning sign during night time, so as to avoid from any untoward incident.
14. The applicant/contractor is directed to restore the original condition of the road soon after the completion of the work by all means.
15. The applicant/contractor is directed to ensure that alternate road made available for diversion is left free for vehicular traffic without any obstruction.
16. The applicant is directed to ensure that one officer is present to oversee the entire work till its completion.
17. The applicant/contractor is directed to carry out work of road cutting during late night hours or on public holidays so as to avoid traffic jams and inconvenience to public in general.
18. The applicant/contractor is directed to publish an advertisement in advance in the local newspaper and over social media about the commencement of the said work to create awareness among the general public/motorist.
19. The applicant/contractor is directed to undertake the work of repair and reconstruction in phases and after completion of phase work the said portion shall be asphalted for the movement of vehicular traffic.
20. The one side traffic i.e. vehicular traffic from Pandav Chapel junction towards Babu Naik House should be allowed and oncoming traffic i.e. traffic from Aquem should be diverted via Power House side.

21. If the applicant/contractor fails to abide by the conditions laid above or if the NOC issuing authority feels so, the NOC is subject to cancellation/revocation at any given time.

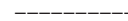
