**Notification**

14/27/2014-RD (Part 2)

Whereas, the draft rules, namely, the Goa Land Revenue (Disposal of Government Lands) (Ninth Amendment) Rules, 2018, which the Government of Goa proposed to make in exercise of the powers conferred by sub-sections (1) and (2) of section 199 of the Goa Land Revenue Code, 1968 (Act No. 9 of 1969) so as to further amend the Goa, Daman and Diu Land Revenue (Disposal of Government Lands) Rules, 1971, were pre-published as required by sub-section (3) of section 199 of the said Act, vide the Government Notification No. 14/27/2014-RD(Part 2), dated 10-04-2018, in the Official Gazette, Series I No. 3, dated 19-04-2018, inviting objections and suggestions from all persons likely to be affected thereby before the expiry of fifteen days from the date of publication of the said Notification in the Official Gazette;

And whereas, the said Official Gazette was made available to the public on 19-04-2018;

And whereas, no objections and suggestions have been received from the public on the said draft Rules by the Government.

Now, therefore, in exercise of the powers conferred by sub-sections (1) and (2) of section 199 of the Goa Land Revenue Code, 1968 (Act No. 9 of 1969) and all other powers enabling it in this behalf, the Government of Goa hereby makes the following rules so as to further amend the Goa, Daman and Diu Land Revenue (Disposal of Government Lands) Rules, 1971, namely:—

1. *Short title and commencement.*— (1) These rules may be called the Goa Land Revenue (Disposal of Government Lands) (Ninth Amendment) Rules, 2018.

(2) They shall come into force from the commencement of the Goa Land Revenue Code (Amendment) Act, 2017 (Goa Act 2 of 2018).

2. *Insertion of new rules 48 to 50.*— In the Goa, Daman and Diu Land Revenue (Disposal of Government Lands) Rules, 1971 (hereinafter referred to as the “Principal Rules”), after rule 47, the following rules shall be inserted, namely:—

“48. *Fees to be accompanied with application.*— The applicant shall pay fee of Rs. 100/- (Rupees one hundred only) while making an application under sub-section (4) of section 37A by affixing a Court fee stamp or a Special Adhesive stamp of Rs. 100/- (Rupees one hundred only) on such application.

49. *Form of application.*— The application referred to in sub-section (1) of section 37A shall be in Form XX hereto and the application referred to in sub-section (4) of section 37A shall be in Form XXI hereto.

50. *Form of Certificate of confirmation of definitive title.*— The Certificate of Confirmation of definitive title referred to in sub-section (3) of section 37A shall be in Form XXII hereto.”.

3. *Insertion of new Forms.* — After Form XIX of the principal Rules, the following Forms shall be inserted, namely:—
