In exercise of the powers vested in me under sub-section (1) of Section 11 of the Goa Municipalities Act, 1968 amended from time to time, I, R. K. Srivastava, Commissioner, Goa State Election Commission, Panaji, hereby notify that the Electoral Roll of the Goa Legislative Assembly prepared under the provisions of Representation of People Act, 1950 for the time being in force as on 1st January, 2018 (published on 10th January, 2018) for such constituency of the Assembly or any part thereof as is included in Sanguem Municipal area shall be divided into different sections corresponding to Ward No. IX of Sanguem Municipal Council fixed by the Director of Municipal Administration under Section 10 of the Goa Municipalities Act, 1968.

The division of Electoral Roll into different section corresponding to Ward No. IX of Sanguem Municipal Council shall be prepared by the Mamlatdar of Sanguem Taluka in which the

Municipal Council is situated and the List of Voter so prepared shall be authenticated by the Mamlatdar of the respective Taluka.
