The Goa Investment Promotion and Facilitation Board (hereinafter referred as the "Board") is designated as the "Single Windows" for all investment made in the State under sub-section 3 and 4 of Section 3 of Goa Investment Promotion Act, 2014 (hereinafter referred as the "said Act") read with Clause (r) of Section 2 of said Act.

However, in terms of Section 8 of the said Act, the Board shall not recommend cases for setting up of projects or for investment promotion in the areas mentioned therein.

The Government now therefore directs that the Board shall act as a Single Window for projects proposals received by them for projects covered under Section 8 of the said Act. However, the role of the board shall be limited to that of a facilitator in obtaining requisite clearances/approvals from the Central Government/State Government Departments and other agencies.

The Board shall within 07 days from the receipt of the orders of the Competent Authority either sanctioning or rejecting the clearance, as the case may be forward the same to the applicant which shall result into disposal of the application.
