Under Section 144 of the Code of Criminal Procedure of 1973

Whereas, it is apprehended that assemblies, processions and morchas are likely to be carried out during the 08th Session, 2019 of the Seventh Legislative Assembly of the State of Goa convened on 20-03-2019 at 11.30 a.m. and such activities are likely to create not only traffic congestion but also disturbance to the smooth and peaceful functioning of the Assembly;

And whereas, I am satisfied that adoption of immediate preventive measures are necessary for the maintenance of public peace, order and tranquillity;

And whereas, I am satisfied that there are sufficient grounds for proceeding under Section 144 (1) of the Code of Criminal Procedure, 1973 and that the circumstances do not allow the serving of notice individually.

Now, therefore, in exercise of the powers vested in me under Section 144 (1) of the Code of Criminal Procedure, 1973, I, R. Menaka, IAS, District Magistrate, North Goa, do hereby prohibit:—

- Assembly and gathering of five or more persons and taking out or organizing of processions.
- The carrying of firearms or weapons of offences such as lathis, swords, daggers or spears.

- The use of loudspeakers.
- The shouting of slogans.
- Burning of fire crackers near the petrol pumps and at the venues of meetings, etc.

in any public place, street, road, square, thoroughfare, by-lane or in any open space within the radius of 500 metres around the Assembly Complex at Porvorim and the area under the jurisdiction of Panaji Police Station. I further direct that the above restriction shall not apply to public servants on duty and to bonafide marriage or funeral processions or any special occasion or occasions which in the opinion of the District Magistrate/Additional District Magistrate/Sub-Divisional Magistrates, are genuine and for which prior permission in writing has/have been obtained from the District Magistrate/Additional District Magistrate or the Sub-Divisional Magistrate concerned.

This order shall come into force w.e.f. 11.00 a.m. on 20-03-2019 and shall remain in force till the Assembly Session is over.

Whereas, the Election Commission of India has announced General Election to the House of People and 2 Bye-Election in 01—Mandrem and 05—Mapusa Assembly Constituencies. In view of this, the Election Commission of India has appointed Observers for the smooth conduct of General Election to Lok Sabha, 2019.

And whereas, this office has booked the rooms in Panjim Residency for the accommodation of the Election Observers and also to set up their office. The vehicles for the Observers has been

requisitioned for election purpose and there is urgent requirement for parking space in front of Panjim Residency till Directorate of Accounts at Panaji.

Therefore, in exercise of the powers conferred on me under Section 117 of the Motor Vehicles Act, 1988 and Rule 264A of the Motor Vehicles Rules, 1991 as amended in 2005, I, R. Menaka, IAS, District Magistrate, North Goa hereby notify the space in front of Panjim Residency till Directorate of Accounts at Panaji as "Parking for Election duty vehicles only" within the jurisdiction of Corporation of the City of Panaji in Tiswadi taluka w.e.f. 04-04-2019 upto 25-04-2019.

Further, in exercise of the powers conferred on me under Section 116 of the above Act, I also authorize the erection of traffic signboards "Parking for Election duty Vehicles only" in order to regulate the motor vehicular traffic.

The Superintendent of Police (Traffic), Altinho to erect the temporary signboards at the places indicated above and deploy sufficient Traffic Police personnel to regulate the parking and movement of vehicular traffic and report compliance latest by 04-04-2019.

This notification shall come into force with immediate effect and shall remain in force till 25-04-2019.
