#### ORDER

(Passed on this 13th day of April, 2011)

- 1. By order dated 22-09-2000, the Government of Goa in exercise of the powers conferred by clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 has referred the following dispute to this Tribunal for its adjudication.
  - "(1) Whether the action of the management of M/s. MRF Ltd., Usgao, Ponda, Goa in awarding punishment to Shri Adam Makandar of two days suspension from work on 7-2-1997 and 8-2-1997 without wages, is legal and justified?
  - (2) If not, to what relief the Workman is entitled?"
- 2. Notices were issued to both parties. The Party I/Workman filed his claim statement at Exb. 5, the Party II filed its written statement at Exb. 6. The rejoinder of the Party I is at Exb. 6.
- 3. The Party I/Workman was employed with the Party II. By letter dated 31-8-1996, the Party I was issued charge-sheet-cum-suspension order alleging that on 14-12-1995, while he was on duty on Band Building m/c No. 13 as a serviceman, the machine had broken down and that the supervisor had given to him a maintenance form to be given to the Electrical Department. It was alleged that the Party I had refused to hand over the maintenance request form to the Electrical Department as per the normal practice. The enquiry was conducted

and by order dated 3-2-1997 the Party I/Workman was suspended for two days by way of punishment.

- 4. The Party I has claimed that the enquiry was not fair and proper and that it was conducted in violation of principles of natural justice. The Party I has further claimed that the charges of misconduct were not proved and that order of suspension by way of punishment is illegal and unjustified. The Party I has claimed that he is being victimized for Union activities.
- 5. The Party II cleared that the enquiry was conducted in violation of rules of natural justice. The Party II has cleared that the charges of misconduct have been proved and that the penalty imposed is justified and legal.
- 6. Based on the aforesaid pleadings, following issues were framed:
  - Whether the Party I proves that the domestic enquiry held against the Workman, Shri Adam Makandar is not fair and proper?
  - 2. Whether the charges of misconduct levelled against the Workman, Shri Adam Makandar are proved to the satisfaction of the Tribunal by acceptable evidence?
  - 3. Whether the Party I proves that the punishment of two days suspension from work on 7-2-97 and 8-2-97 without wages awarded to the Workman Shri Adam Makandar is by way of victimization and unfair labour practice?
  - 4. Whether the Party I proves that the punishment of two days suspension from work on 7-2-97 and 8-2-97 without wages awarded to the Workman, Shri Adam Makandar is illegal and unjustified?
  - 5. Whether the Workman, Shri Adam Makandar is entitled to any relief?
  - 6. What Award?

7. Issue Nos. 1 and 2 were treated as preliminary issues. Evidence on these issues was recorded. On 17-3-2011, when the matter was at the stage of arguments on preliminary issues, the Party I filed an application at Exb. 22, stating that he has voluntarily resigned from service vide resignation letter dated 27-1-2001. The Party I has stated that the Party II Company has accepted his resignation and that he does not wish to pursue the dispute. The Party I has stated that he does not have any claim against the Party II, including

the relief sought in the present dispute. The Party I has prayed that the matter be treated as closed.

8. The Party I has confirmed the contents of the said application at Exb. 22. The application at Exb. 22 clearly indicates that the Party I is no longer interested in proving that the act of management in awarding two days suspension on 7-2-97 and 8-2-97, without wages is illegal and unjustified. Since the Party I is not interested in perusing the dispute, he is not entitled for any relief.

Under the circumstances I pass the following order.

#### ORDER

The action of the management of M/s. MRF Ltd., Usgaon, Ponda in awarding punishment to Shri Adam Makandar of two days suspension from work on 7-2-97 and 8-2-97 without wages is held to be legal and justified. The Party I is not entitled for any relief. No orders as to costs.
