Whereas, the Executive Engineer, WD XIV (NH), PWD, Fatorda, Margao vide letter dated 01-08-2019

has informed that the construction work of missing link on NH17-B connecting Loutolim village to Verna IDC is in progress which consists of flyover over MDR No. 44 at Angadi Loutolim having a height of 20.00 mtrs. from ground level. The placement of precast girders over the already constructed piers requires closure of traffic below the flyover for facilitating safety of the traffic to avoid any mishaps during placement as heavy crane is being used and requested to issue permission for closure of road between 2.00 p.m. to 5.00 p.m. for 20 days.

And whereas, the Superintendent of Police, South Goa, Margao, vide letter dated 05-08-2019 has submitted no objection for diversion of traffic;

And whereas, it is revealed that the work mentioned above is of urgent nature and it requires to divert the traffic;

And whereas, I am satisfied that the diversion of traffic is essential during execution of the above work;
