- 1. Short title and commencement.— (1) These rules may be called the Goa, Succession, Special Notaries and Inventory Proceeding Rules, 2019.
  - (2) They shall come into force at once on publication in the Official Gazette.
  - 2. Definition.— (1) In these rules, unless the context otherwise requires,—
  - (a) "Act" means the Goa Succession, Special Notaries and Inventory Proceeding Act, 2012 (Goa Act 23 of 2016);
    - (b) "section" means a section of the Act.
- (2) Words and expressions used, but not defined in these rules shall have the meanings respectively assigned to them in the Act.
- 3. Payment of fees.— The fees payable under the Act shall be as specified in the table below:—
