#### Notification

New Delhi, the 13th March, 2020

**S.O. 1087(E).**— In exercise of the powers conferred by sub-section (2) of section 2A, of the Essential Commodities Act, 1955 (10 of 1955), the Central Government, hereby makes the following Order, to regulate the production, quality, distribution, logistics of masks (2ply & 3ply surgical masks, N95 masks) & hand sanitizers (for COVID 19 management) namely:—

1. (1) This order may be called the Essential Commodities Order, 2020.

(2) It shall come into force from the date of its publication in the Official Gazette.

2. In the Essential Commodities Act, 1955, in the Schedule, after serial No. (7), the following item shall be added, namely:—

“(8) masks (2ply & 3ply surgical masks, N95 masks) & hand sanitizers”.

3. This Notification shall remain in force for a period up to 30th June, 2020 from the date of its publication in the Official Gazette.

New Delhi, the 19th March, 2020

**S.O. 1169(E).**— In exercise of the powers conferred by sub-section 2A and section 3, of the Essential Commodities Act, 1955 (10 of 1955), the Central Government, hereby makes the following Order, to regulate the production, quality, distribution, prices and other aspects of alcohols used in manufacturing the Hand Sanitizers for preventing infections due to virus and bacteria, namely:—

1.(1) This order may be called the ingredients and prices of the ingredients as raw materials of Essential Commodities Order, 2020.

(2) It shall come into force from the date of its publication in the Official Gazette.

2. (1) In the Essential Commodities Act, 1955, the raw material used in manufacturing as essential commodity shall be treated as essential commodity.

(2) The prices of the alcohols used in manufacturing the hand sanitizers shall not exceed from those prevailing on 05-03-2020 without concurrence of the Central Government.

3. This Notification shall remain in force for a period up to 30th June, 2020 from the date of its publication in the Official Gazette.
