Whereas, the Executive Engineer, WDXVII (PHE),
PWD, Alto Porvorim, Bardez-Goa vide letter referred
at Sr. No. (1) has requested for partially closing the
CHOGM road to carryout digging of road near Bata
showroom for laying pipeline on 4-11-2020.

And whereas, the Dy. Supdt. of Police Traffic
(North), Altinho, Panaji has recommended partially
closing the CHOGM road to carry out digging of
road near Bata showroom for laying pipeline on
4-11-2020 and the traffic moving from Saligao
towards O'Coqueiro Circle would be diverted via
Holy Family Church Junction

Now therefore, in exercise of the powers
conferred on me under Sections 115 & 116 of the
Motor Vehicles Act, 1988, and as recommended by
the Dy. Superintendent of Police (Traffic), Altinho
Panaji, I, R. Menaka, IAS, District Magistrate, North
Goa hereby order partial closing of CHOGM Road
and the traffic moving from Saligao towards
O'Coqueiro shall be diverted via Holy Family Church
Junction during the work. On 04-11-2020 from 6:30
am to 8:30 pm, subject to the following conditions:

- 1) Vehicular traffic on the surrounding and the adjacent roads shall not be affected.
- 2) The proper barricading shall be done around cutting/digging machine.
- 3) Sufficient traffic signages regarding closure of above stretch of road and directional boards shall be erected on both ends of the closure for the information of the motorists.
- 4) The PWD Officials Contractor carrying out the said work shall deploy sufficient Traffic Marshals for guiding the motorist accordingly.
- 5) Wide publicity about the above closure shall be given in all the local dailies for the information of the motorists in general and the residents in particular.

- 6) Material used for barricading the above stretch shall be pasted with fluorescent tape for better and clear visibility.
- 7) The debris should not be dumped on the road causing obstruction to road users and the motorist.
- 8) The work should be completed within the time frame and the road should be resurfaced for normal use.
- 9) The contact No. of the Contractor/Supervisor or the responsible person should be displayed at all closure/diversion points so as to enable him/her to contact if any emergency situation arises.
- 10) Permission from other competent authorities should be obtained well in advance.
- 11) NOC from concerned Police Station should be obtained well in advance.
- 12) This permission is subject to cancellation/revocation at any moment.

The Executive Engineer, WD-XVII(PHE), P.W.D., Alto Porvorim, Bardez-Goa is directed to publish this Order through the Director of Information and Publicity in press/media/social media regarding the traffic diversion and to make necessary arrangements to erect the signboards at the required places. The Executive Engineer is also directed to convey the dates of scheduled work to the Traffic Police.
