#### Order

No. 8/8/2021-MAG/L&amp;O/(VOL-II)/96

#### Under Section 144 of the Code of Criminal Procedure of 1973

Whereas, it has been brought to the notice of the undersigned by the Director of Animal Husbandry & Veterinary Services of Government of Goa that there is confirmation of Avian Influenza (H5N1) in Chicken in State of Maharashtra and Karnataka;

And whereas, on perusal of the facts brought to light by the Director of Animal Husbandry & Veterinary Services, I am of the considered opinion that there is a serious risk to the health of the people in North Goa District if the transportation and entry of birds and eggs from Maharashtra and Karnataka States are not stopped forthwith.

Now, therefore, I, R. Menaka, IAS, District Magistrate, North Goa, in exercise of the powers conferred upon me by Section 144 of the Code of Criminal Procedure, 1973, do hereby prohibit the transportation and entry of birds and eggs from Maharashtra and Karnataka States into North Goa District either directly or indirectly.

This order shall come into force with immediate effect till further orders.

As the notice cannot be served individually on all concerned, the order is hereby passed ex-parte.

Any person contravening this order shall be punishable under Section 188 of the Indian Penal Code.

#### Order

No. 8/8/2021-MAG/L&amp;O/(VOL-II)/170

#### Under Section 144 of the Code of Criminal Procedure of 1973

Whereas, it has been brought to the notice of the undersigned by the Superintendent of Police North, Porvorim-Goa that the supporters of various organizations may demonstrate/take out agitation/morchas etc. during the 51st International Film Festival of India in Goa, Panaji from 16-01-2021 to 24-01-2021 within the jurisdiction of Panaji Police Station and Agacaim Police Station, in support of their demands and hence disturbance of public peace cannot be ruled out.

And whereas I am satisfied that adoption of immediate preventive measures are necessary for the maintenance of public peace, order and tranquility;

And whereas I am satisfied that there are sufficient grounds for proceeding under Section 144 (1) of the Code of Criminal Procedure, 1973 and that the circumstances do not allow the serving of notice individually.

Now, therefore, in exercise of the powers vested in me under Section 144 (1) of the Code of Criminal Procedure, 1973, I, R. Menaka, IAS, District Magistrate, North Goa, do hereby prohibit:-

- (a) Assembly and gathering of five or more persons and taking out or organizing of processions.
- (b) The carrying of firearms or weapons of offences such as lathis, swords, daggers or spears.
- (c) The use of loudspeakers.
- (d) The shouting of slogans.
- (e) Burning of fire crackers near the petrol pumps and at the venues of meetings, etc.

in any public place, street, road, square, thoroughfare, by-lane or in any open space within the radius of 500 metres around the place of function of 51st International Film Festival of India in Goa area under the jurisdiction of Panaji Police

Station and Agacaim Police Station. I further direct that the above restriction shall not apply to public servants on duty and to bonafide marriage or funeral processions or any special occasion or occasions which in the opinion of the District Magistrate/Additional District Magistrate/Sub-Divisional Magistrates, are genuine and for which prior permission in writing has/have been obtained from the District Magistrate/Additional District Magistrate or the Sub-Divisional Magistrate concerned.

This order shall come into force from 15-01-2021 and shall remain in force till 24-01-2021.
