Whereas, vide Orders referred at Sr. No. 1, restrictions were imposed on VPK Urban Co-operative Credit Society Ltd., Mardol, Ponda-Goa, on accepting any forms of deposits and disbursement of any loans/advances, collection of pigmy accounts for initial period of six months.

And whereas, the "TAFBUS" Committee appointed by the Government for reviewing the progress of the society during the meeting held on 8-01-2021 has made various recommendation in respect of society after reviewing the financial position.

Now therefore, the Government on recommendation of "TAFBUS" Committee and in exercise of powers conferred under Section 68 of the Goa Co-operative Societies Act, 2001, hereby extend restriction imposed vide order dated 5-06-2020 on ex-post facto for the further period of six months with retrospective effect from 6-12-2020 subject to following relaxations to reduce administrative cost and streamline affairs of the society:

1. Present withdrawal limit is enhanced from existing Rs. 40,000/- to Rs. 60,000/- per month per person.

- (a) Society is permitted to sanction loan/advances from existing limit of Rs 5.00 lakhs to maximum limit of Rs. 15.00 lakhs against secured collateral security.
- (b) Society is permitted to allow withdrawals of matured pigmy deposits without any restrictions.
2. On medical and educational grounds, the society is allowed to sanction loan on case to case basis against the total accumulated deposits as on the date of application, with a upper limit of Rs. 20.00 lakhs and as per loaning policy of the society.
3. The Board is refrain from claiming any honorarium or remuneration.
4. The old and unused vehicles having high maintenance cost shall be disposed off and also explore the possibilities of hiring/outsourcing the vehicles required for day today business activities.
5. The society shall prepare branch-wise viability reports of all the 38 branches and retort to merger of non viable branches with the nearest branch offices.
6. Staff assessment and selection committee shall be constituted as per the guidelines of the Registering Authority to assess the total staff requirement and if found in excess, formulate a staff retrenchment scheme to reduce the staff strength and also explore the possibilities of floating Voluntary Retirement Scheme.
7. The society shall reevaluate its immovable assets by appointing Certified Valuer.
8. The society shall increase its net worthiness by reducing the administrative and other costs. The society shall come up with the strategic plan to review the financial position of the society as much as the society shall undertake comparative study of the financial status for three months pre and post restrictions period and submit the compliance report to the committee.
9. The NPA percentage being on the higher side, the society shall put all out efforts to recover the outstanding loan amount on time bound manner.

All other terms and conditions of above referred order at Sr. No. 1 remain unchanged.

Government is hereby pleased to appoint Shri Bhagirath G. Shetye, Deputy Director of Education, as Chairman of the Goa Board of Secondary and Higher Secondary Education with immediate effect subject to the following terms and conditions:-

1. That the said officer shall serve in the said Board as its Chairman for a period of four years from date on which he assumes the charge of the office or till he completes the age of 60 years whichever is earlier.
2. That the said officer will submit himself to the order of the Government and authorities under whom he may from time to time be placed by the Government and will at all times obey the rules prescribed for the time being for regulation of the public service to which he may belong and will from time to time proceed to any part of India to which he may be required to proceed.
3. That the said officer will employ himself efficiently and diligently and to the best of his ability as the Chairman of the Board and that

- he will devote his whole time to the duties of the service and will not engage directly or indirectly in any trade, business or occupation on his own account. He will not except in case of accident or sickness certified by the competent medical authority absent himself from duties without having first obtained permission from the Government through the Directorate of Education, Government of Goa.
4. That the Government may terminate his agreement at any time by giving three calendar months notice in writing if the said Officer is found guilty of any breach of any of the terms and conditions herein specified.
 5. That the said Officer may terminate this agreement by giving to the Government ninety days advance notice in writing and on expiration of such notice this agreement shall stand terminated. In the absence of such notice to the Government the said Officer shall refund to the Government an amount equivalent to the pay of three months in lieu of the said notice.
 6. That the Government shall pay to the said Officer so long as he shall remain in office and actually perform his duties, in "Level 13" of the Pay Matrix of 7th Pay Commission (corresponding scale PB-4, Rs. 37,400-67,000/- + Grade Pay of Rs. 8,700/- in the 6th Pay Commission Scale) and his salary shall be fixed as per the rules in the aforesaid Scale with right for increment as and when they fall due. He shall also be paid dearness allowance, house rent allowance and other allowances admissible to a Government servant in the service of Goa State as admissible under the rules. He shall be entitled to travelling allowance and dearness allowance as admissible to a Grade I Officer of the Government whenever the said Officer has to perform tours for effective discharge of duties attached to the post of Chairman of the Board.
 7. The said officer shall be entitled to, subject to exigencies of Public service, leave and leave salary as are admissible to an Officer of the Government and further that he shall be allowed encashment of leave as per rules.
 8. The said Officer shall be eligible for medical attendance and treatment as are admissible to a Grade-I Officer of the Government.
 9. The said Officer shall so long as he continues to be the Chairman of the Board, subscribe to the General Provident Fund and shall be subjected to the rules of such fund.
 10. The said Officer shall in the matters in respect of which no specified provision has been made in this agreement, be governed by the rules and regulations which are applicable to a Government servant of equal status.
 11. The said Officer shall be entitled to benefits of L.T.C., the Children Education Allowance, Medical Reimbursement, Tuition Fees, etc. as are enjoyed by the Government servant of equal status.
 12. The period during which the said Officer serves as Chairman of the Board shall be counted as qualifying service for the benefits under the pension and scheme and also to such other benefits which are applicable to the said Officer immediately before the date of his assuming office of Chairman of the Board and the Government undertaking to make contribution for leave salary and pension which may be payable under the said scheme for the period for which the said Officer continues to function as Chairman of the said Board.
 13. The Government has no objection if said officer retains his lien on the post held by him immediately prior to his appointment as Chairman of the Board, during the period for which this agreement shall be in force.
 14. In the event of any question, dispute or difference arising under or out of or in connection with the conditions herein contained or touching or concerning the meaning or operation or and as to the rights, liabilities of the parties hereto, the same shall be referred to the sole arbitration of the person nominated by the Governor of Goa. There will be no objection to any appointment that the arbitrator so appointed is a Government servant and that in course of his duties as such Government servant had expressed his view in all or any of the matter or disputes and differences. The award of the arbitrator so appointed shall be final and binding on the parties to those presents. Subject as aforesaid, the provisions of Indian Arbitration Act, 1940 for the time being in force shall apply to the arbitration proceedings under the Clause.
