In exercise of the powers conferred by sub-section (2) of section 46 of the Police Act, 1861 (5 of 1861), the Government of Goa hereby makes the following rules, namely:—

1. *Short title and commencement.*—(1) These rules may be called the Goa Police (Maintenance of Record) Rules, 2021.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. *Definitions.*— (1) In these rules, unless the context otherwise requires,—

(a) “Act” means the Police Act, 1861 (5 of 1861);

(b) “Form” means the form appended to these Rules;

(c) “Government” means the Government of Goa;

(d) “State” means the State of Goa;

(e) “Subordinate rank” means police officer below the rank of Deputy Superintendent of Police.

(2) The words and expressions used but not defined in these rules, shall have the same meanings respectively assigned to them in the Act.

3. *Police records in Police Station.*— (1) In order to develop sound criminal intelligence system the following registers/books/records shall be maintained in the police stations, namely:—

- i. FIR Register
- ii. NC Register
- iii. Arrest Register
- iv. Crime Register
- v. Village Statistics (village crime note book part I)
- vi. Village crime Register (Village crime note book part II)
- vii. Village conviction Register (Village crime note book part III)
- viii. Notes of crimes in village (Village crime note book part IV)

- ix. Surveillance Register
- x. History Sheets
- xi. Known Criminal Register
- xii. Station Diary
- xiii. A-Roll Register
- xiv. B-Roll Register
- xv. General Conviction Register
- xvi. Summons/Warrant Register
- xvii. Unnatural Death Register
- xviii. Missing Person Register
- xix. Muddemal/Case Property Register
- xx. Road Certificate Register
- xxi. Fire Arm License and Deposit Register (Civil)
- xxii. Government Fire Arms and Ammunitions Stock Register

(i) *FIR Register.*— Details of all FIRs registered in the Police Station shall be maintained in FIR Register in Form – I hereto.

(ii) *NC Register.*— This register is maintained in accordance with section 155 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974). On receipt of information about a non cognizable offence, the officer incharge of a police station or the duty officer on his behalf, shall record the information in the non-cognizable register. A copy of the report shall be given to the complainant in Form–II hereto. No police officer shall investigate a non-cognizable case without the order of a Magistrate having power to try such case or commit the case of trial.

(iii) *Arrest Register.*— The Arrest Register shall be maintained for recording the details of arrests of persons in the Police Station. The Arrest Register shall be maintained in Form– III hereto.

(iv) *Crime Register.*— In this register all the ingredients of the Offences registered in the Police Station shall be written in brief, right from the registration of the offence till its disposal by the Court. The cross entries in respect of all relevant registers are noted down in this Register. The Crime Register shall be maintained in Form– IV hereto.

(v) *Village Statistics (Village Crime Note Book, Part-I).*— This register shall contain information about a village such as population, markets, important places, vital installations and institutions of the village, etc. A separate register shall be maintained for each village. The Village Statistics (Village Crime Note Book, Part-I) shall be maintained in Form-V hereto.

(vi) *Village Crime Register (Village Crime Note Book, Part-II).*— Any crime registered in the area of the village shall be entered in this register. A separate register shall be maintained for each village. This Village Crime Register (Village Crime Note Book, Part-II) shall be maintained in Form – VI hereto.

(vii) *Village Conviction Register (Village Crime Note Book, Part-III).*— This register shall include names and information of the persons who are residing within the jurisdiction of the Police Station and are convicted in any offence whether committed within or outside the jurisdiction of that Police Station. The Village Conviction Register (Village Crime Note Book, Part-III) shall be maintained in Form-VII hereto.

(viii) *Notes on Crime in Village (Village Crime Note Book, Part-IV).*— This is a confidential register and shall remain in the personal custody of the Station House Officer of the Police Station. It shall contain notes on important factions and important disputes, disputes in connection with festivals, disputes especially between castes and communities, political groups, and the commission of serious breaches of the peace and records of Police bandobast for important festivals, and matters known incidentally during investigation of crime, etc. The following matters shall be entered in this Register/Book, namely.—

(a) Notes regarding influential individuals residing in or having connection with the area who habitually abet or share in the proceeds of crime or shelter criminals.

(b) Special types of lawlessness or crime to which the inhabitants of the area are addicted.

(c) Notes regarding gangs operating in the area.

(d) Notes on personal, land, communal and other feuds, which are liable to cause breach of peace.

(e) Agrarian issues and disputes; Tribal/ Non-tribal issues, Agitations by farmers, etc.

(f) Industrial problems; student agitations; other caste-based agitations and any other important agitations.

(g) Notes regarding fairs and similar occasions requiring the special attention of the officer incharge of the Police Station.

(h) Notes regarding criminals of other areas.

(i) A list of respectable inhabitants of the area who can provide important information regarding proclaimed offenders and absconders.

(j) Any other important information having bearing on law and order and policing as felt necessary by the officer in charge of the police station. The Notes on Crime in Village (Village Crime Notebook, Part-IV) shall be maintained in Form-VIII hereto.

(ix) *Surveillance Register.*— (1) This Register shall consist of the following two parts, A and B. The Surveillance Register shall be written by the Officer Incharge of the Police Station personally.

(I) PART A.— Part A shall include the names of persons commonly residing within the limits of the jurisdiction of the Police Station. No entry in this part shall be made except by the order of Sub-Divisional Police Officer/Deputy Superintendent of Police and every entry shall be attested by Sub-Divisional Police Officer/Deputy Superintendent of Police. Entry in this part shall be made in all cases deemed necessary for surveillance by the Sub-Divisional Police Office out of following categories, namely:—

(i) Person who have been proclaimed under section 82 of the Code of Criminal Procedure, 1973 (Central Act No. 2 of 1974).

(ii) All released convicts in regard to whom an order under section 356 of the Code of Criminal Procedure, 1973 (Central Act No. 2 of 1974) has been made.

(iii) All persons registered as habitual offenders under the provisions of the Goa, Daman and Diu Habitual Offenders Act, 1976 (Act No. 16 of 1976).

(iv) All convicts the execution of whose sentence is suspended in the whole or any part or whose punishment has been remitted conditionally under section 432 of the Code of Criminal Procedure, 1973 (Central Act No. 2 of 1974).

(II) PART B.— (1) Entry in this part shall be made in all cases deemed necessary for surveillance by the Superintendent of Police out of following categories. It shall be written under the specific written order of the Superintendent of Police, who shall not delegate such power to any officer.

(a) Such persons who have been convicted twice or more of offences whose entry is to be made in Village Conviction Register (Village Crime Note Book, Part—III) and whose surveillance is deemed necessary by the Superintendent of Police.

(b) Persons who are reasonably believed to be repeat offenders or receivers of stolen property whether they have been convicted or not.

(c) Persons found for keeping under security under section 110 of the Code of Criminal Procedure, 1973 (Central Act No. 2 of 1974).

(d) Convicts released before the expiry of their sentences under the Prisons Act, 1894 (Act No. 9 of 1894) and Rules framed thereunder without imposition of conditions.

(2) A copy of the Surveillance Register maintained at the Police Station shall be kept in the office by the concerned Superintendent of Police and the Sub-Divisional Police Officer/Deputy Superintendent of Police. The Surveillance Register shall be maintained in Form – IX hereto.

(x) *History Sheets*.— (1) History Sheets shall be maintained in Form X hereto and they shall contain details and history of persons residing permanently or temporarily within the limits

of police station who are involved in crimes or aid and abet the commission of crime. The officer incharge of the Police Station to be responsible for preparing History Sheets of the criminals residing within the Police Station limits. History Sheets are to be opened by the specific orders of the Superintendent of Police.

(2) History Sheets to be opened of all persons whose names are recorded in part B of the Surveillance Register.

(3) All History Sheets shall be numbered serially in each police station. The History Sheets should contain a recent photograph of the person concerned.

(4) The History Sheet of a person, who changes his residence to another police station limits within the State of Goa shall be forwarded to that police station through the District Superintendent of Police.

(5) History sheet will be opened for 2 years. Where the retention of a History Sheet is considered necessary after two years of opening of history sheet, orders of the District Superintendent of Police must be taken for the extension, in the first instance up to the end of the next December and for further annual extension from January to December every year. The officer in charge of the police station shall put up the history sheet for review before the District Superintendent of Police.

(6) History Sheets shall be closed by the orders of a District Superintendent of Police and shall be filed in the records of the police station. The History Sheets of persons, who have died, shall be destroyed by the order of Superintendent of Police. The Superintendent of Police may order the closure of a History Sheet at any time by recording the reasons thereof.

(7) The District Superintendent of Police and the Sub-Divisional Police Officer should ensure updation of History Sheets regularly.

(xi) *Known Criminals Register (KCR)*.— This register is an index to the criminals of the area. In this register the names of persons residing in the jurisdiction of the police station who have been arrested in criminal cases whether the case occurred in the jurisdiction of the

police station or outside, shall be entered alphabetically. A separate entry shall be made for each criminal case with a separate serial number. When the criminal is again arrested, a fresh entry shall bear the previous serial number and shall be entered below it. The Known Criminals Register (KCR) Register shall be maintained in Form—XI hereto.

(xii) *Station Diary*.— Every officer incharge of a police station shall maintain a station diary in Form – XII hereto.

(xiii) *A-Roll Register*.— A Roll register shall be maintained in Form—XIII hereto for reporting the absence or departure of a bad character from the jurisdiction of the police station to the jurisdiction of another police station.

(xiv) *B-Roll Register*.— B Roll register shall be maintained in Form XIV hereto for reporting the arrival of a suspicious stranger in the jurisdiction of the police station to the police station from which he has come for the purpose of verification of the antecedents of the suspicious stranger.

(xv) *General Conviction Register (GCR)*.— The General Conviction Register shall contain a complete record of all persons convicted in cognizable cases reported directly to the Police Station or referred to the Police under section 202 of the Code of Criminal Procedure, 1973 (Central Act No. 2 of 1974) and of persons residing within the limits of Police Station though convicted elsewhere. This register is maintained alphabetically with the names of the accused. The General Conviction Register (GCR) shall be maintained in Form—XV hereto.

(xvi) *Summons/Warrant Register*.— In this Register the receipt and return of summons and warrants shall be entered. The Summons/Warrant Register shall be maintained in Form—XVI hereto.

(xvii) *UD Register*.— A register regarding Unnatural Deaths shall be maintained in Form XVII hereto at the police station to keep a proper record of unnatural deaths.

(xviii) *Missing Person Register*.— A register regarding Missing person shall be maintained in Form XVIII hereto at all the police station to keep a proper record of missing person, and also about the action taken to trace them.

(xix) *Muddemal/Case Property Register*.— The details of all properties attached by police in relation to any crime shall be entered in this register. The Muddemal/Case Property Register shall be maintained in Form XIX hereto.

(xx) *Road Certificate Register*.— Road Certificate Register shall be maintained in Form XX hereto for recording details of certificate issued by the Police Station while filing the chargesheet. Each Road Certificate shall be given a serial number and details of receipt at concerned court will be entered in the register.

(xxi) *Fire Arm License and Deposit Register (Civil)*.— This Register shall be maintained for recording details of all civil Fire Arm licenses issued and deposited in the jurisdiction of the police station. The Fire Arm License and Deposit Register (Civil) shall be maintained in Form XXI hereto.

(xxii) *Government Fire Arms and Ammunition Stock Register*.— This Register shall be maintained for recording the details of the Government stock of fire arms and ammunitions. The Government Fire Arms and Ammunition Stock Register shall be maintained in Form XXII hereto.

(2) All the registers/books/records mentioned in sub-rule (1) shall be treated and marked as confidential so as to give them the status of privileged documents.

(3) In addition to above, any other register/ /book/record may be maintained by Police Stations as per requirement of Goa Police.

Whereas, the draft rules, namely, the Goa Land Revenue (Property Register) Rules, 2020 which the Government, of Goa proposed to make in exercise of the powers conferred by sub-sections (1) and (2) of section 199 of the Goa Land Revenue Code, 1968 (Act No. 9 of 1969) were pre-published as required by sub-section (3) of section 199 of the said Act vide the Government Notification No. 16/1/13/2019-REV-I dated 4-11-2020 of the Department of Revenue, Government of Goa in the Official Gazette, Series I No. 32, dated 5-11-2020 inviting objections and suggestions from all the persons likely to be affected thereby within a period of fifteen days from the date of publication of the said Notification in the Official Gazette;

And whereas, the said Official Gazette was made available to the public on 05-11-2020;

And whereas, objections and suggestions received from the public on the said draft Rules have been considered by the Government.

Now, therefore, in exercise of the powers conferred by sub-sections (1) and (2) of section 199 of the Goa Land Revenue Code, 1968 (Act 9 of 1969) and all other powers enabling it in this behalf, the Government of Goa hereby makes the following rules, namely:—

1. *Short title and commencement.*— (1) These rules may be called the Goa Land Revenue (Property Register) Rules, 2020.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. *Definitions.*— (1) In these rules, unless the context otherwise requires,—

(a) “Code” means the Goa Land Revenue Code, 1968 (Act 9 of 1969);

(b) “Director” means the Director of Settlement and Land Records;

(c) “Form” means a form appended to these Rules;

(d) “land” means the Government land and land held by any person, and includes things attached to the earth, or permanently by fastened to any thing attached to the earth or other defined portions thereof;

(e) “Property Register” means a digital register created and maintained under rule 3, in relation to land;

(f) “State” means the State of Goa;

(g) “Unique property identification number” means an unique number as generated under sub-rule 3 of rule 3 in relation to property;

(2) Words and expressions used and not defined in these rules but defined in the Code shall have the meanings respectively assigned to them in the Code.

3. *Preparation of Property Register.*— (1) The Director shall prepare and maintain a property Register in Form-I hereto.

(2) The first preparation of Property Register shall be made by the Director by filling up details in column (1) to column (6) of the Property Register on the basis of Land Revenue records, and column (8) and column (9) on the basis of records obtained from the local bodies or field survey.

(3) In column (7) of the Property Register, the Director shall assign to each property a computer generated unique number for the purpose of its identification, through any algorithm as deemed fit by him.

(4) The Director shall also prepare a Property Plan by marking general boundaries of each holding within the Survey Plan only for indicative purpose and to show the general position.

(5) The Property Register so prepared shall be displayed online for the public by the Director and a notice inviting public comments to such Property Register shall be published in the Official Gazette and in at least two newspapers, one in English and one in vernacular language having wide circulation in the State.

(6) The Director shall, after expiration of a period of fifteen days from the date of publication of the notice under sub-rule (5) and after consideration of public comments, if any, finalise the Property Register in Form I, with or without any changes.

4. Maintenance and updation of Property Register.— (1) The Director shall be the custodian of the Property Register.

(2) The Director may create additional Unique property identification numbers and change the Property Plan on the request of any Government Department or local body or applicant, as per such procedure as may be specified by the Government.

(3) The Director shall provide an appropriate access to the Government departments, local bodies or other agencies to be notified for entering and updating the information held by them, in column (10) of the Property Register.

(4) The Director shall undertake efforts to integrate the database with other Government departments, local bodies or other agencies to be notified to capture changes made by

them in their database for collating realtime property related information.

(5) The Government department, local body or other agency who is updating property related information in the Property Register shall be,—

(a) liable and responsible for accuracy, completeness and updating of their respective information; and

(b) free to change the information so entered as per the relevant laws, rules, regulations or practices, without seeking any consent or approval of the Director.

(6) All Government departments, local bodies and other agencies shall endeavour to include Unique property identification number in their databases and official communications and dealings.

5. Duties of Government department, local bodies or other agencies.— All Government departments, local bodies or other agencies shall endeavor to keep the Property Register updated by recording any encumbrances, zoning, lieu, mortgage, lease, court order, proceeding restriction dispute or other information possessed or received by them related to the properties, in the manner as specified by the Director from time to time.

6. Fee.— An extract of Property Register can be downloaded on payment of Rs. 200 per Unique property identification number. The extract shall bear a time stamp and/or special features as may be decided by the Director.
