In pursuance of the directions issued by the Hon'ble Supreme Court of India in the Judgment passed on 22-09-2006, in Writ Petition (Civil) No. 310/of 1996, in the matter of Prakash Singh & Ors. versus Union of India and Ors. and in supersession of all earlier orders, the Government of Goa hereby constitute State Police Complaints Authority for the State of Goa, on the following terms:

1. The State Police Complaints Authority shall be composed of one Chairperson and Member.
  2. The State Level Police Complaints Authority would take cognizance of only allegations of serious misconduct by the police personnel's, which would include incidents involving death, grievous hurt or rape in police custody.
  3. The State Level Police Complaints Authority may utilize the services of retired investigator from the CID, Intelligence and Vigilance of any other organization for conducting field inquiries.
  4. The recommendations of the State Level Police Complaints Authority for any action, department or criminal, against a delinquent Police Officer shall be binding on the concerned authority.
  5. The terms and conditions with regards to appointment of Chairperson shall be as under,-
    - i. The Chairperson shall be entitled for salaries and allowances last drawn by him as Judge of High Court. Provided that if the Chairperson at the time of appointment is in receipt of Pension in respect of any previous service, his/her salary in respect of the service as the Chairperson, shall be reduced by the amount of that pension.
    - ii. The Chairperson shall hold office for the term of five years from the date on which he/she enters office provided that no Chairperson shall hold office after he/she has attained the age of 70 years.
    - iii. The Chairperson may be removed from his or her office only by order of the Governor on one or more of the following circumstances:-
      - a) Proven misbehavior; or
      - b) Persistent and willful neglect to perform official duties; or
      - c) Being adjudged an insolvent; or
      - d) Conviction of an offence involves moral turpitude; or
      - e) Acquisition of such financial or other interest as is likely to affect prejudicially his or her functions as the Chairperson.
- An order of removal shall not be issued against any person without providing such person an opportunity of being heard.
- iv. Chairperson Police Complaints Authority shall be entitled to a monthly sumptuary allowance of Rs. 6000/- (Rupees six thousand only) per month.

- v. The Chairperson Police Complaints Authority may be granted leave in accordance with such rules as are applicable to a member of the Indian Administrative Service.

The power to grant or refuse leave to the Chairperson Police Complaints Authority and to revoke or curtail leave granted to him shall vest in the Government of Goa.

- vi. The Governor of Goa shall be the leave sanctioning Authority for the Chairperson Police Complaints Authority.
- vii. The Chairperson Police Complaints Authority shall be entitled without payment of rent to the use of an official residence. He is entitled to free furnishing including electrical appliance in his official residence, the value of which does not exceed Rs. 1.5 lakh. He is also entitled without payment of rent to the use of furnished residence throughout the term of his office and for a period of one month immediately thereafter and no charge shall fall on him personally in respect of the maintenance of such residence.

For this purpose, residence includes the staff quarters and other buildings appurtenant thereto and the garden thereof and maintenance in relation to a residence includes the payment of local rates and taxes and electricity and water. The reimbursement/payment of charges on account of water and electricity consumed at his official residence shall not exceed 3600 kilolitres of water and 10,000 units of power per annum. Where, for any reason, the Chairperson Police Complaint Authority does not avail himself of the use of an official residence, he may be paid every month an allowance equivalent of an amount of 30% of his pay plus dearness pay as HRA in lieu of rent-free official residence.

- viii. The Chairperson Police Complaints Authority and the dependent members of his family shall be entitled to such facilities for medical treatment and for accommodation in hospitals as prescribed as per Rule 2 of High Court Judges Rules, 1956, the rules and provisions as applicable to a cabinet Minister of the State of Goa.
- ix. The Chairperson Police Complaints Authority shall be entitled to a staff car and 200 litres fuel per month or the actual consumption of fuel whichever is less.

- x. The Chairperson Police Complaints Authority shall be entitled to avail LTC for himself, his wife and dependent family members for visiting any place in India, in accordance with rules applicable to IAS Officers.
- xi. The Chairperson Police Complaints Authority shall be entitled for the service of three muster roll peons of his choice as given to the State Chief Secretary by order No. 7/3/90-FIN(EXP) dated 24-09-2003 issued by the Finance (Exp.) Department, Government of Goa.
- xii. The Chairperson Police Complaints Authority shall be entitled to subscription of three daily newspapers and three monthly magazine of his choice.

6. The terms and condition with regards to appointment of Member shall be as under,-

- i. Member shall be entitled for salaries and allowances last drawn by him/she in the service rendered under the State Government/Central Government, earlier if any. Provided that if the Member at the time of appointment is in receipt of Pension in respect of any previous service, his/her salary in respect of the service as Member, shall be reduced by the amount of that pension. If the member who is appointed belongs to Civil Society and has not served in civil service of either State/Central Government earlier, he/she shall be entitled to pay and allowance same as that of Junior Administration Grade Officer of Goa Civil Service.
- ii. The member shall hold office for the term of 3 years from the date on which he/she enters office provided that no member shall hold office after he/she has attained the age of 65 years.
- iii. The Member may be removed from his or her office only by order of the Governor on one or more of the following circumstances:-
- Proven misbehavior; or
  - Persistent and willful neglect to perform official duties; or

- c) Being adjudged an insolvent; or
- d) Conviction of an offence which involves moral turpitude; or
- e) Acquisition of such financial or other interest as is likely to affect prejudicially his or her functions as the Member.

An order of removal shall not be issued against any person without providing such person an opportunity of being heard.

- iv Member shall be entitled to draw all other allowance such as DA, HRA, CCA etc. as applicable to Junior Administration Grade Officer of Goa Civil Services.
- v. Member shall be entitled to draw TA/DA as admissible to Group A Officer as per their pay, when required to go out of Headquarters on official duties.
- vi. Member shall not be entitled to the benefit of contributory Provident Fund.
- vii. Member shall be entitled to subject to exigencies of public service to leave and leave salary as is admissible to Government servant of corresponding status under the Central Civil Service (leave) Rules, 1972 as amended from time to time. However, encashment of leave shall not be admissible.
- viii. Member shall be entitled to the reimbursement of medical expenses as applicable to the Government official of corresponding status under the Central Services (Medical) Attendance Rules, 1944.
- ix. Member shall in the matters in respect of which no specific provision has been made in this order to governed by the rules and regulations which are applicable to Government servant of equal status.
