Notification

D.Tpt/EST/2812/1930

In exercise of the powers conferred by sub-section (1) of section 200 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) (hereinafter referred to as the "said Act") and in supersession of the Government Notification No. 5/28/88-TPT (Part I) dated 20-09-1995, published in the Official Gazette, Series I No. 29 dated 19-10-1995, the Government Notification No. D.Tpt/EST/1482/2016/2164 dated 12-06-2019, published in the Official Gazette, Series I No. 11 dated 13-06-2019, the Government Notification No. D.Tpt/EST/1482/2016/2636 dated 18-07-2019, published in the Official Gazette, Series I No. 17, dated 25-07-2019, and the Government Notification No. D.Tpt/EST/1482/2019/1071 published in the Official Gazette, Series I No. 3, dated 15-04-2021, the Government of Goa hereby specifies the following officers for the purpose of compounding of offences under the said Act as specified hereunder, namely:—

(i) all the officers in the rank of the Assistant Director of Transport or above, of the Directorate of Transport, for compounding offences as mentioned in columns (2) and (3) of Schedule 'A' herein, for the amounts mentioned in the corresponding entry in column (4) or column (5), as the case may be, of the said Schedule;

(ii) all the officers in the rank of the Assistant Motor Vehicles Inspector or above, of the Directorate of Transport, for compounding offences as mentioned in columns (2) and (3) of Schedule 'B' herein, for the amounts mentioned in the corresponding entry in column (4) or column (5), as the case may be, of the said Schedule; and

(iii) the Police Inspectors, Police Sub-Inspectors and Assistant Sub-Inspectors of Police, of the Police Department, within their respective jurisdiction, for compounding offences as mentioned in columns (2) and (3) of Schedule 'C' herein, for the amounts mentioned in the corresponding entry in column (4) or column (5), as the case may be, of the said Schedule.
