The Narcotic Drugs and Psychotropic Substances (Amendment) Ordinance, 2021

No. 8 of 2021

Promulgated by the President in the Seventy-second Year of the Republic of India.

An Ordinance further to amend the Narcotic Drugs and Psychotropic Substances Act, 1985.

Whereas the Narcotic Drugs and Psychotropic Substances Act, 1985 was amended by the Narcotic Drugs and Psychotropic Substances (Amendment) Act, 2014 which, inter alia, introduces a new clause (viiiia) in section 2 and renumbered existing clause (viiiia) relating to definition of “illicit traffic” as clause (viiiib) thereof, but to oversight the reference of the said clause could not be corrected in section 27A of the said Act, which provides for punishment for financing “illicit traffic” and harbouring offenders;

And Whereas the amendment does not create any new offence but contains a legislative declaration that reference of clause (viiiia) always meant the corresponding renumbered provision in clause (viiiib) and the amendment seeks to rectify this anomaly by making changes in section 27 of the said Act in order to carry out the legislative intent of the statute, which has always been to read clause (viiiib) in section 27, and already stood therein;

And Whereas the Narcotic Drugs and Psychotropic Substances (Amendment) Act, 2014 came into force on the 1st day of May, 2014;

And Whereas Parliament is not in session and President is satisfied that circumstances exist which render it necessary for him to take immediate action;

Now, Therefore, in exercise of the powers confirmed by clause (1) of article 123 of the Constitution, the President is pleased to promulgate the following Ordinance:-

1. *Short title and commencement.*— (1) This Ordinance may be called the Narcotic Drugs and Psychotropic Substances (Amendment) Ordinance, 2021.

(2) It shall be deemed to have come into force on the 1st day of May, 2014.

2. *Amendment of section 27A of Act 61 of 1985.*— In section 27A of the Narcotic Drugs and Psychotropic Substances Act, 1985, for the words, brackets, letters and figure “clause (viiiia) of section 2”, the words, brackets, letters and figure “clause (viiiib) of section 2” shall be substitute.

SCHEDULE

Syllabus for Competitive examination for direct recruitment to the Goa Civil Service

Part A: General Intelligence, Reasoning and Numerical Aptitude.

Part B: Basics of Constitution of India, Governance and Administration.

This component is aimed at testing the candidate's knowledge and aptitude on issues and themes relating to Constitution of India, Governance and Administration. On the Constitution, the student must be familiar with the key provisions of the Constitution of India having a direct linkage to the functioning of the Indian Democracy and also the debates surrounding Constitutional Reform/Amendment. With reference to Governance and administration, he must be familiar with the role of bureaucracy, Central, State and local level governance mechanisms (with reference to India and the State of Goa), fundamentals of good governance and emerging issues in society-bureaucracy interface. The select themes shall include:

- Constitution of India:- Preamble, Fundamental Rights, Fundamental Duties, Directive Principles of State Policy.
- Constitution of India and the Central and State Legislatures, Executives and Judiciary.
- Center State Relations, Union, State and Concurrent Lists, Budgetary Allocations, Role of Finance and National Institute for Transforming India (NITI Aayog).
- Elections and Electoral Process, Central and State Election Commissions, Representation of the People Act, 1950 (43 of 1950) and Representation of the People Act, 1951 (43 of 1951).

- Role of Bureaucracy in nation building, Civil Services Training, Central Civil Service Rules, Integrity in Administration, Public Private Partnership.

- Good Governance: Efficiency, Transparency, Accountability in Governance, Right to Information Act, 2005 (22 of 2005), Role of Lokayukta and Lokpal.

Part C: General Knowledge and Current Affairs.

This component is intended to test the candidate's awareness and knowledge on general issues of both historical and contemporary nature relating to India and the State of Goa. The questions aim at testing both the factual as well as the analytical grasp of the candidate on such issues without actually testing deeper knowledge on the subject. It may contain questions on history, geography, culture, scientific developments and current affairs. The select themes shall include:

- Current Events of State, National and International Importance.
- India's Freedom struggle, Goa's Freedom struggle.
- Physical, Economic and Social Geography of India and Goa.
- Religion, Customs and Festivals: India and Goa.
- Information and Communication Technology, Biodiversity, Environment and Climate Change.
- Social Movements: Corruption, Environment, Women's issues.

Part D: English Comprehension.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and in supersession of the existing recruitment rules for the post of Police Constable published in the Official Gazette, Series I No. 8 dated 25-05-2017 vide Government Notification No. 1/9/2013-PER dated 12-05-2017, the Governor of Goa hereby makes the following rules to regulate the recruitment to the Group 'C', Non-Gazetted, Non-Ministerial post, in the Office of the Director General of Police, Government of Goa, namely:—

1. *Short title, application and commencement.*— (1) These rules may be called the Government of Goa, Office of the Director General of Police, Group 'C', Non-Ministerial, Non-Gazetted post, Recruitment Rules, 2021.

(2) They shall apply to the post specified in column (1) of the Schedule to these rules (hereinafter called as the "said Schedule").

(3) They shall come into force from the date of their publication in the Official Gazette.

2. *Number, classification and level in the pay matrix.*— The number of posts, classification of the said post and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the said Schedule:

Provided that the Government may vary the number of posts as specified in column (2) of the said Schedule from time to time subject to exigencies of work.

3. *Method of recruitment, age limit and other qualifications.*— The method of

recruitment to the said post, age limit, qualifications and other matters connected therewith shall be as specified in columns (5) to (13) of the said Schedule.

4. *Disqualification.*— No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service:

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. *Power to relax.*— Where, the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. *Saving.*— Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes, Other Backward Classes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Government from time to time in that regard.

Whereas, the draft Rules, namely, the Goa Land Revenue (Amendment) Rules, 2021 which the Government of Goa proposed to make in exercise of the powers conferred by sub-section (2) of section 199 of the Goa Land Revenue Code, 1968 (Goa Act No. 9 of 1969) (hereinafter referred to as the "said Code") so as to further amend the Rules specified in the Schedule hereto framed under the said Code, were pre-published as required by sub-section (3) of section 199 of the said Act vide the Notification No. 16/1/4/2021-Rev/8280 dated 24-06-2021 of the Department of Revenue, Government of Goa, in the Official Gazette, Series I No. 14 dated 01-07-2021, inviting objections and suggestions from all persons likely to be affected thereby within a period of fifteen days from the date of publication of the said notification in the Official Gazette.

And whereas, the said Official Gazette was made available to the public on 01-07-2021;

And whereas, no objections or suggestions have been received from the public on the said draft Rules by the Government within the stipulated period.

Now, therefore, in exercise of the powers conferred by sub-sections (1) and (2) of section 199 of the Goa Land Revenue Code, 1968 (Goa Act No. 9 of 1969) and all other powers enabling it in this behalf, the Government of Goa hereby makes the following rules so as to further amend the rules specified in the Schedule hereto framed under the said Code, namely:

1. *Short title and commencement.*— (1) These rules may be called the Goa Land Revenue (Amendment) Rules, 2021.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. *Amendment of certain rules framed under the Goa Land Revenue Code, 1968 (Goa Act No. 9 of 1969).*— In the rules specified in the Schedule hereto, in the Short title, the expression "Daman and Diu" shall be omitted.
