Subject: Dividing the Village Panchayat area into wards for ensuing General Elections to three Village Panchayats of Pernem Taluka i.e. Village Panchayat Casarvarnem, Alorna, Chandel Hassapur.

Whereas, the Government of Goa vide the Goa Panchayat Raj (Amendment) Act, 2021 (Goa Act 32 of 2021) amended Section 7 of the Goa Panchayat Raj Act, 1994 (Goa Act 14 of 1994), entrusted the task of dividing the each Panchayat area into wards and reservation of seats in every Panchayat to the State Election Commission in consultation with the Government.

And whereas, in exercise of the powers conferred under sub-section (3) of Section 7 of the Goa Panchayat Raj Act, 1994 (Goa Act 14 of 1994), Goa State Election Commission Goa State Election Commission initiated the task of dividing the Village Panchayat area into wards for ensuing General

Elections to three Village Panchayats of Pernem Taluka i.e. Village Panchayat Casarvarnem, Alorna and Chandel Hassapur. The Mamlatdar of Pernem Taluka was appointed as the Electoral Registration Officer (ERO) and Awal Karkun in the office of Mamlatdar as Asst. Electoral Registration Officer (AERO) to carry out said task vide order No. 3/40/DELIMITATION/2022-23/SEC/3809 dated 04-08-2022.

And whereas, ERO/AERO was directed to divide the Village Panchayat area into wards in compliance with the following:

1. The wards may be constituted in consonance to Section 7 of the Goa Panchayat Raj Act, 1994 (Goa Act 14 of 1994) and Rules.

2. For dividing a Panchayat area into wards the population or the number of voters of each ward shall, as far as may be practicable be equal and be in the same proportion as the number of members fixed under Section 7 of the Act bears to the total population or the number of voters of the Panchayat.

3. The EROs/AEROs shall utilize the Electoral Roll of the Goa Legislative Assembly prepared under the provisions of the Representation of Peoples Act, 1950 (Central Act 43 of 1951) for the time being in force as on 1st January, 2022 published on 5-1-2022 along with the supplement published on 28th January,

2022, to form Village Panchayat wards, considering the Part and Sections of the said Electoral Roll.

4. In dividing a Panchayat area into wards under Section 7 of the Goa Panchayat Raj Act, 1994 (Goa Act 14 of 1994), the EROs shall ensure that a particular area is kept together and also to ensure that the members of a single household is in the same ward.

5. Due consideration to geographical contiguity and natural boundaries shall be given while constituting Village Panchayat wards.

6. Distance to polling booth shall be within 2 kms. while clubbing/dividing sections/parts to form Village Panchayat ward.

7. Each ward shall be assigned a separate serial number.

And whereas, the draft delimitation proposal prepared by ERO was kept open in the Office of the ERO and respective talathi office from 28th September, 2022 to 7th October, 2022 for general public so as to submit their suggestions/corrections/modifications pertaining to said delimitation of Village Panchayats wards by issuing Public Notice 3/40/DELIMITATION/2022-23/SEC/4012 dated 27-09-2022.

And whereas, EROs prepared the final draft delimitation proposals for Village Panchayats wards after considering the observation/suggestions/modifications/corrections received from the general public and submitted to the State Election Commission.

And whereas, the Commission submitted the final draft delimitation proposals for General Election to Village Panchayat Casarvarnem, Alorna and Chandel Hassapur in Pernem Taluka 2022 for the State Government consultation as per the amendment to Section 7 of the Goa Panchayat Raj Act, 1994 and

Rules (Goa Act 14 of 1994 & Rules). The State Government returned back the delimitation proposals of these Village Panchayats to the Commission after completing the consultation process.

And whereas, the Commission shall reserve the seats in Village Panchayats for Scheduled Castes (SC), Scheduled Tribes (ST) and Other Backward Classes (OBC) considering the provisions of the Goa Panchayat Raj Act, 1994 and Rules and directions issued by Hon'ble Supreme Court from time to time. The notification in this regard shall be issued separately.

Now therefore, the Goa State Election Commission in exercise of the powers conferred upon it do hereby notify the delimitation of Village Panchayat wards for ensuing General Election to Village Panchayat Casarvarnem, Alorna and Chandel Hassapur in Pernem Taluka 2022 vide following Notifications:
