Whereas, in order to conduct the election to the Board of Directors of the Co-operative Societies within stipulated time period, the Goa Co-operative Societies Rules were favourably amended and the Societies were classified under "A" "B" & "C" categories.

And whereas, from the election details submitted by the zonal offices it is observed that the term of the Board of Directors of many Societies have expired in the year 2023 but election could not be conducted within the stipulated time period as prescribed under the Rule 52 of the Goa Co-operative Societies Rules, 2003. The delay in holding the election is attributed to the insufficient time available to the Societies and as much as to the concerned zonal offices as the new arrangement has come into force vide notification No. 42/2/2001//TS/RCS/(Suppl.) dated 21-06-2023 published in the Official Gazette, Extraordinary, Series I No. 12 dated 22nd June, 2023.

Now, therefore, in exercise of the power conferred under Section 126A of the Goa Co-operative Societies Act, 2001 (Goa Act 36 of 2001), the Government of Goa hereby exempt all the Co-operative Societies, registered under the Goa Co-operative Societies Act, 2001, which are pending for holding election to the Board of Directors on or before 31st December, 2023 from applicability of Rule 52 of the Goa Co-operative Societies Rules, 2003 and allow to hold the election of such Societies upto 30th September, 2024.
