Whereas, Government I.T.I. Employees Co-op. Credit Society Ltd., Farmagudi, Ponda-Goa is registered under code symbol No. Reg. No. ARCS/ /CZ/3-(b)-24/Goa dated 06-04-1987 and classified as Salary Earners Society under sub-classification No. 3(b) in terms of Rule 9 of the Co-op. Societies Rules, 1962 for the Union territory of Goa, Daman & Diu and now deemed to be registered under the Goa Co-op. Societies Act, 2001 and Rules, 2003.

And whereas, the objectives of the society have been specified in the Bye-laws No. III(4(i-iii) to encourage sense of self help and thrift amongst the members, to assist its members to tide over their financial difficulties by making loan available to them on reasonable terms and conditions etc...

And whereas, the management has failed to adopt new Bye-laws in accordance with the Goa Co-op. Societies Act, 2001 and Rules, 2003 till this date even though instructions to this effect has already been issued by this office from time to time.

And whereas, it is observed from the available records of the said society in this office that society has not convened its Annual General Body Meetings as required in terms of provision of Section 72 of the Goa Co-op. Societies Act, 2001 which shows that the Board of Directors of the said Society are not interested in managing the affairs of the society. Moreover, it is mandatory on the part of the management to convene Annual General Body Meeting of the society within 6 months from the date of close of the every co-op. year. However, the management has failed to convene the said meetings which attracts deeming disqualification for period of 5 years being chosen as director and shall be ineligible to continue as directors of the society in terms of Section 61 of the Goa Co-op. Societies Act, 2001.

And whereas, it was the duty of Managing Committee to get audited every year statements of accounts from the Statutory Auditor and place the same before the Annual General Body Meeting for its approval. However, from the available records of the society in this office it is found that the audit of the society is pending from 2001-2002 onwards and no efforts have been made to complete the same.

And whereas, it is also observed that the society has failed to file annual return and to deposit filing fees as required in terms of Sections 81 read with Rule 113 of the Goa Co-op. Societies Act, 2001 and Rules, 2003 since implementation of the said law i.e. from 2008.

In view of the facts highlighted hereinabove, as regards to failure to convene Annual General Body Meeting, Statutory Audit from 2001-2002 onwards and also filing of return and fees etc. The Society is stagnant as there is no any functioning carried out as required in no existence of the Managing Committee and if the same condition is allowed to continue then there is every possibility that its existence may wiped off and the objectives as laid down in bye laws of the society may be defected.

Further, that no useful purpose will be served to allow to continue the affairs of the society as there is no scope of improving its affairs. In view of above, I inclined to pass following order.

ORDER

In excise of the power delegated to me vide notification dated 30-09-2020 U/S 92(2) of the Goa Co-op. Societies Act, I, Sangita S. Naik, Co-operative Officer, Ponda Zone, Ponda-Goa hereby confirm the order at serial No. 3 above appointing Kum. Ankita L. Halarnkar, Jr. Auditor, Co-op.
