34. Petitioners have filed this petition for divorce by mutual consent under Section 13B of the Hindu Marriage Act, 1955.

Brief facts of the petition are as under:

2. The marriage between Petitioner No. 1 and 2 was solemnized on 21-11-2017 at Novotel, Goa, as per Hindu Rites and rituals. They have no issue born out of said wedlock. They lived together for same period and due to their differences of opinion and incompatibility, they have been residing separately since 15-03-2019 and since then, there has been no cohabitation between them. They claim that inspite of all efforts made by them and their families, no reconciliation between them is possible. They have, therefore, decided to dissolve their marriage by mutual consent.

3. After appearance of parties they were referred to Marriage Counsellor for exploring possibility of reconciliation. They were given six months period to reconsider their decision. After six months, both parties appeared and prayed for divorce. Vide his, report Exh. 09 dated 08-06-2021, the Counsellor informed that there is no possibility of reconciliation between the parties and both parties are agreed for divorce by mutual consent.

4. Having regards to the contentions of Petitioners, the following points arise for my determination and I have recorded my findings thereon for the reasons as under:

Points	Findings
1. Whether the petitioners are entitled to a decree of divorce by mutual consent? Yes
2. What order? As per final order
Reasons	

As to point No. 1:

5. Petitioners No. 1 and 2 have filed their claim affidavit at Exhs. 10 and 11 respectively. Both of them have stated that they lived together as husband and wife for some period and they are residing separately since 15-03-2019 for more than one year and it is not been possible for them to reconcile their differences and to live together inspite of all efforts made by them and their relatives and therefore, their marriage may be dissolved.

6. After going through the Affidavits of the Petitioners, I find that there is no cohabitation between them since last one year prior to the presentation of the petition and there is no possibility of their reunion and they have decided to have a decree of divorce by mutual consent. The marriage, thus, appears to have been broken down

irretrievably. After going through the entire facts and circumstances of the case and the Affidavits of both Petitioners, I am satisfied that there was and is no undue influence, force, pressure or misrepresentation upon the parties for taking divorce by mutual consent and their consent appears to be voluntary and free. It is clear from their petition and their Affidavits that both Petitioners have waived their right of permanent alimony/maintenance against each other for past, present and future. Now, they do not have any claim in respect of maintenance, stridhan articles or properties of whatsoever nature against each other. Both the Petitioner agrees to abide all the terms signed/settled between them.

7. It is seen that till today, the Petitioners have not withdrawn their consent for divorce. Similarly, there appears no impediment in their way for having a decree of divorce as prayed by them. Therefore, I am of the opinion that Petitioners are entitled for a decree of divorce by mutual consent under Section 13-B of the Hindu Marriage Act, 1955. Accordingly, points No. 1 is answered and I proceed to pass the following order:
