Demand No. 2. Pay Scales and Grades:- Union demands that with effect from 01-10-2022, following pay scales should be implemented wherein the workers will be placed as per their capability, qualification, years of service and ability,—

## Grade Pay Scale

- I 13,000-800-17,000-1,050-22,250-1,300-28,750-1,550-36,500-1,800-45,500.
- II 12,000-750-15,750-1,000-20,750-1,250-27,000-1,500-34,500-1,750-43,250.

1 2 III 11,000-700-14,750-950-19,500-1,200--25,500-1,450-32,750-1,700-41,250.

In the event, an employee crosses the threshold of the respective pay scale, he shall be eligible to the last drawn increment every year.

Demand No. 3. Seniority Increments:- Union demands that with effect from 01-10-2022, all the workmen shall be given the Seniority Increments as mentioned below,—

(i) Service after completing : 1 increment. 3 years

(ii) Service after completing : 2 increments.6 years

(iii) Service after completing : 3 increments. 9 years

Fitment: The above amount should be added to the existing basic salary and thereafter fitted in the revised pay scale in the higher stage.

Demand No. 4. Variable Dearness Allowance: Union demands that with effect from 01-10-2022, each workmen shall be paid Variable Dearness Allowance at the revised rate of Rs. 25/- per point rise beyond 123 points of AICPI (2016) series. The Variable Dearness Allowance shall be revised every quarter.

Demand No. 5. Fixed Dearness Allowance:- Union demands that with effect from 01-10-2022, all the workmen shall be paid an amount of Rs. 2,000/- per month towards Fixed Dearness Allowance.

Demand No. 6. House Rent Allowance:- Union demands that with effect from 01-10-2022, all the workmen shall be paid an amount @ 35% of revised Basic+DA+FDA per month towards House Rent Allowance.

Demand No. 7. Conveyance Allowance: Union demands that with effect from 01-10-2022, each workman shall be paid an amount of Rs. 3,000/- per month towards Conveyance Allowance.

Demand No. 8. Education Allowance:- Union demands that with effect from 01-10-2022, each workmen shall be paid an amount of Rs. 2,000/- per month towards Education Allowance.

Demand No. 9. City Allowance:- Union demands that with effect from 01-10-2022, each workmen shall be paid an amount of Rs. 2,000/- per month towards City Allowance.

Demand No. 10. Food Allowance:- Union demands that with effect from 01-10-2022, each workmen shall be paid an amount of Rs. 2,000/- per month towards Food Allowance.

Demand No. 11. Shift Allowance, Snacks and Tea:(i) Union demands that with effect from 01-10-2022, each workman who work in the shifts shall be paid Shift Allowance as under:-

2nd Shift: Rs. 100/- per shift. 3rd Shift: Rs. 150/- per shift.

(ii) Those who work in 1st, 2nd and 3rd Shift and General should be provided with free snacks and tea. Besides, those working in 1st Shift should be provided with free lunch and those working in 2nd Shift should be provided with free dinner.

Demand No. 12. Medical Allowance:- Union demands that with effect from 01-10-2022, each workman shall be paid a Medical Allowance and provided with Insurance cover as under,—

- (i) That, all the workmen who are out of coverage of E.S.I. Act, 1948 shall be paid Medical Allowance @ 5% on the Gross Salary.
- (ii) In case a workman or his family member is required to undergo Special Hospital care, all the expenses shall be reimbursed and be paid for by the company. To work out the said objective, the Company may work out a Contributory Medi-claim Insurance Policy for each of the workman.
- (iii) In case a workman while on duty suffers an accident, the Company should bear all the expenses for his/her treatment. Besides the concerned workman shall be eligible to a special paid leave until he/she fully recovers and is fit to resume work.
- (iv) That, the workmen who are out of purview of E.S.I. Act, 1948 shall be covered under suitable Insurance Policy for an amount of not less than Rs. 5,00,000/- per year for hospitalization and reimbursement of medical expenses for self, spouse and up to 2 dependent children up to age of 21 years. The hospitalization claim shall be directly settled with insurance company and all the terms and conditions as prevalent with the Insurance Company will be applicable. As and when the existing employee is again covered under ESIC Scheme in future, whether prospectively or retrospectively, due to amendment in the ESI Act, the hospitalization benefit Scheme will cease to be in operation.
- (v) That, the Company should pay to each of the workman an amount equivalent to Rs. 2,000/- per month towards reimbursement of medical expenses.

Demand No. 13. Leave Travel Allowance:- Union demands that with effect from 01-10-2022, each workman shall be paid Leave Travel Allowance at

the revised rate of 1 month's Gross Salary with minimum 4 days leave. The amount should be paid one week before the commencement of the leave.

Demand No. 14. Loan Facilities:- Union demands that with effect from 01-10-2022, each workmen shall be entitled to interest free Loan of Rs. 2,00,000/- (Rupees two lakhs only) which can be availed for house repairs, construction of house, purchase of household articles, marriage of self or his/her family members, purchase of vehicle, higher education of children. This loan ought to be recovered in 50 equal installments. In case the loan remains unrecovered due to retirement, death, it should be recovered from the legal dues payable to the concerned workman.

Demand No. 15. Leave Facilities:- That with effect from 01-10-2022, all the workmen shall be given leave facilities and holidays as under:-

- (i) *Privilege Leave:* 30 days per year with facility to accumulate upto 150 days
- (ii) Casual Leave: 15 days per year with facility to encash balance leave.
- (iii) Sick Leave: 15 days per year with facility to accumulate upto 60 days and encash balance, if any. Those workers who are out of purview of E.S.I. Act, 1948, should be eligible for 20 days Sick Leave.
- (iv) *Holidays*:- 14 days per year to mutually decide between the Management and the Union in the month of January of every year.

Restricted Holidays: 4 restricted holidays per year.

- (v) The Union demands that whenever the Office bearer of the Union or any workman is required to attend any work before any authority under the Industrial Disputes Act, 1947 which said work has any connection with the Union, the concerned Office bearer/workman shall be considered on duty for the said period for which necessary prior intimation shall be given to the concerned superior for adjustment of shift etc.
- (vi) Leave facilities to probationer:- The probationer should be eligible for Casual, Sick Leave during the probationary period.
- (vii) Paid Trade Union Leave:- Besides to the above, the Union demands that 02 days Paid Trade Union Leave in total per month should be given to the Union representative to attend the Union meetings, training or any Union related activities.
- (viii) Compensatory Leave:- Union demands that each workman should be granted Compensatory Leave @ 12 days per year to be availed in case of any death of any of the family member.

(ix) Paternity Leave:- Union demands paternity leave for each workman to be granted @ 15 days per year which can be availed within 3 months after child birth. This demand is just and proper considering the present circumstances of small family and that no other persons are available to look after the spouse and child during initial days.

Demand No. 16. Festival Advance:- Union demands that with effect from 01-10-2022, each workman shall be granted Festival Advance of Rs. 15,000/per year to be given once in a year which is to be refundable in ten equal installments.

Demand No. 17. Bonus:- Union demands that with effect from 01-10-2022, each worker shall be paid bonus @ 20% on the Basic+VDA+FDA without any ceiling limit.

Demand No. 18. Gratuity:- Union demands that with effect from 01-10-2022, all the workmen who have worked for more than 5 years of continuous service shall be paid Gratuity @ 30 days of wages that is Basic+VDA+FDA per year of service at the time of termination or resignation from service.

Demand No. 19. Annual Picnic:- Union demands that with effect from 01-10-2022, all the workmen will be sanctioned one day for picnic in the month of January of every year. Food and beverage expenses besides vehicle expenses shall be borne by the Company.

Demand No. 20. Celebration of Annual Family Day:-Union demands that with effect from 01-10-2022, Management shall celebrate Annual Family day in the premises wherein the families of individual workman shall be permitted to participate for which food and beverage, lunch besides vehicle expenses shall be borne by the Company.

Demand No. 21. Rainwear and Foot wear:- Union demands that with effect from 01-10-2022, all the workmen shall be provided with raincoat (Pant and Shirt) every year in the month of May/June and a pair of gum boots and one pair of foot wear every year of Rs. 2,000/- per year.

Demand No. 22. Canteen Facility:- (i) That the Company shall provide a well-furnished, full-fledged free Canteen facility in the premises of the Company. It is further demanded that the food provided in the Canteen shall be vegetarian as well as non-vegetarian. The management should elect a committee consisting of at least 10 members that is 5 from Management and 5 from the Union and the elected Committee shall finalize the Menu of the Company and also oversee all the administration of the Canteen.

- (ii) The Management shall provide free food facility in all shift.
- (iii) The management shall provide free snacks and tea in all shift.

Demand No. 23. Retirement Age:- (i) Union demands that with effect from 01-10-2022, all the workmen shall be retired at the age of 60 years.

(ii) Whenever a workman retires from service, he should be presented with 20 gms. gold coin on behalf of the Company or in alternative 2 months Gross Salary as a retirement gift.

Demand No. 24. Leave Encashment:- Union demands that with effect from 01-10-2022, every workman shall be paid Leave Encashment on gross salary (that is Basic+DA+FDA+all other Allowances).

Demand No. 25. Overtime facility and its calculation:- Union demands that with effect from 01-10-2022, that whenever a workman is required to work overtime beyond 8 hours of normal work or is required 11 to work on weekly off or holiday(s), he/ /she should be paid overtime at the double rate of wages to be calculated on gross wages (that is Basic+DA+FDA+ all other Allowances) as per the provisions of the Factories Act, 1948 besides paid compensatory off which should be allowed to be availed within 10 days of such work. In case, the management is unable to give a paid off due to exigencies, the workman should be allowed to accumulate the paid off. It is further demanded that the weekly off for all should be on Sundays only.

Demand No. 26. Soap and Napkins:- Union demands that with effect from 01-10-2022, all the workmen shall be provided with soap and napkin for use in the factory premises for hand wash at all times as and when required.

Demand No. 27. Employment Next to Kin:- Union demands that with effect from 01-10-2022, the Kin of any of the workmen, who has died while in employment of the Company or who has retired or who has suffered permanent disablement while in employment of the company shall be given employment in the Company.

Demand No. 28. Free Transport and Fixation on Routes:- Union demands that with effect from 01-10-2022, existing facility of providing free transport in all the shifts shall be continued. Besides to the above, free transport shall be provided on following routes:-

- (i) Verna Plant:- Cortalim-Aggacaim-Pilar--Bambolim-Panaji-Porvorim-Mapusa.
- (ii) Verna Plant:- Margao KTC-Nuvem-Power House-Sanvordem Cuncolim-Canacona.
- (iii) Verna Plant:- Birla Cross-Birla-New Vaddem-Vasco KTC-Sada Vasco.
- (iv) Verna Plant:- Titan-Kesarval-Quelossim--Lotoulim-Ponda-Marcel Mollem.
- (v) General Shift:- Verna-Ponda-Margao--Vasco-Panaji.

Demand No. 29. Industrial Relations and Work Practices:- (i) Both the parties, the Union and the Management, shall co-operate with each other in maintaining cordial industrial relations and as well as healthy work practices to improve industrial relations and to improve productivity as well as quality and work practices.

(ii) The Company has framed Standing Operating Procedures in achieving the desired result, which the workers are expected to follow. However, it is found that sometimes superiors compel/force the worker(s) to deviate from the said procedure in Order to achieve the target faster and the concerned worker(s) are later on subjected to disciplinary action for deviating from the said procedure as and when the deviation is pointed out during the Audit. Considering the same, it is demanded that no worker(s) shall be compelled/ /forced to deviate from the Standing Operating Procedures by their respective superiors under any circumstances whatsoever and further no disciplinary action should be initiated against the concerned worker(s) in the event they are forced/ /compelled to deviate from the said procedure by their superior.

(iii) It is found that whenever superior file any complaint against workers in connection with work, the same is immediately taken note of and on that basis appropriate action is taken against the concerned worker however when a worker files any complaint against the superior in respect of his conduct in relation to the work assigned, no action of whatever nature is taken or initiated. In the circumstances, in order to achieve fairness and level playing filed, it is demanded that complaint filed by or against the worker(s) should be given equal importance and necessary action should be initiated in both situations.

Demand No. 30. Practices/Privileges and Existing Facilities:- Those practices, privileges and existing facilities which have not been expressly provided in the present Charter of Demands but are being followed at present shall not be withdrawn or discontinued.

Demand No. 31. Other Facilities:- (i) Casual/helper should be provided wherever required in production area.

- (ii) Housekeeping personal shall be provided in each area for housekeeping work.
  - (iii) Birthday coupon price to be given Rs. 1,500/-.
- (iv) Marriage Gift: On workmen's marriage one month's gross salary should be given as gift to him.
- (v) Punching Card: Provisions of punching card shall be near the security gate.
- (vi) If plant is running on festivals/national holidays then company should pay triple overtime and one C/OFF.
- (vii) In the night shift management shall give 15 minutes rest after every hour of working with a reliever operator during the said period.

Demand No. 32. Interim Relief:- The Union demands in the event discussions on the present Charter of Demands prolong beyond 3 months from the date of the receipt hereof, each of the workman shall be paid Interim Relief of Rs. 10,000/- per month from the expiry of 3 months period as aforesaid.

Demand No. 33. Period of Settlement:- The period of this Settlement shall be for 3 years from 01-10-2022 to 30-09-2025 and thereafter till date of termination thereof in accordance with law.

(3) If answer to issue No. (2) above is in negative then what relief the workmen are entitled to?

In exercise of the powers conferred by Clause (b) of sub-section (1) of Section 9 of the Indian Stamp Act, 1899 (Act No. 2 of 1899), as in force in the State of Goa, the Government of Goa hereby permits the Life Insurance Corporation of India, Goa Divisional Office, Panaji (hereinafter referred to as the "LIC Goa") to pay consolidated stamp duty of Rs. 35,00,000/- (Rupees thirty five lakhs only), chargeable on sums to be insured in the insurance policies issued by its offices in the State of Goa with effect from 1st January, 2024 upto 31st December, 2024 in lieu of affixing stamps upon individual insurance policies, which has been paid vide cheque No. 000502 dated 14-02-2024, drawn on HDFC Bank, Panaji, Goa, subject to the following conditions, namely:-

(a) In case the stamp duty chargeable on the insurance policies issued during the above mentioned period falls short of the stamp

- duty consolidated herein and paid to the Government, the excess consolidated stamp duty shall be adjusted for the calendar year 2025.
- (b) In case the stamp duty chargeable on the insurance policies issued during the above period exceeds the stamp duty consolidated herein and paid to the Government, the balance amount due towards the stamp duty shall be paid to the Government Treasury by LIC Goa latest by the first week of January, 2025.
- (c) A detailed report of the total stamp duty charged on the sums insured in the insurance policies issued by the offices of the LIC Goa in the State of Goa during the above period shall be submitted to the Secretary (Revenue), Revenue Department. Government of Goa on or before 31-12-2024.
