

And whereas, as requested by the Registrar General of Bombay High Court, the matter was placed before the Hon'ble Governor of Goa and the Hon'ble Governor of Goa has accepted the recommendations of the Disciplinary Committee of the High Court of Bombay.

Now, therefore, the major penalty of removal from service is hereby imposed upon Kum. Aruna P. Fernandes, Adhoc Civil Judge, Senior Division and Judicial Magistrate First Class, Margao, South Goa, as per Rule 11(viii) of the Central Civil Services (Classification, Control and Appeal) Rules, 1965, with immediate effect.
