ORDER $(22^{\text{nd}} \text{ April}, 2025)$

This is an application for review filed by the Respondents on 14/08/2024, under Section 20 of the Goa Human Rights Commission (Procedure) Regulations 2011.

- 2. The Respondents are seeking a review of the Inquiry Report dated 22/02/2024, passed in Proceeding No. 106/2022.
- 3. On perusing the application, the Commission by Order dated 30/10/2024, issued notice to the Complainant.
- 4. The Commission heard Adv. Shri K. L. Bhagat for the Respondents and Adv. Ms. Pooja Kamat for the Complainant.
- 5. The Learned Adv. for the Respondents submitted that the Commission had not taken into consideration the crucial points while passing the Inquiry Report, namely that there is a hillock just behind the target and also a special mud dump and there is a rare chance of any bullet travelling out of the firing range.
- 6. So also, he submitted that the house of the Complainant is situated at the distance of 3 kilometers from the firing range and the bullet could not have travelled to the same spot.
- 7. On the other hand, Learned Advocate, Adv. Ms. Pooja Kamat, contended that no grounds are made out for review of the Inquiry Report.
- 8. The Review Application has been filed under the Regulation 20 of the Goa Human Rights Commission Regulations 2011, which reads as under:-

"(Section 20)-If any application seeking modification or review of the order of proceedings passed by the Commission is received, the same shall be placed before the same Bench which made the order, along with the case file and a brief note on the points made out in such application and the same shall be disposed of by such order as may be deemed proper by such Bench."

9. Scope and extent of Review Jurisdiction of the Court.

The dictionary meaning of the word review is "the act of looking, offer something again with a view to correction or improvement".

10. As explained by the Apex Court in *S. Nagraj and others v. State of Karnataka and another, 1993 Supp (4) SCC 595*, review literally and even judicially means re-examination or re-consideration. The basic philosophy inherent in it is the universal acceptance of human fallibility. Yet in the realm of law, the courts and

even the statutes, lean strongly in favor of finality of decision legally and properly made. Exceptions both statutorily and judicially have been carved out to correct accidental mistakes or miscarriage of justice. The purpose of review is rectification of an order which stems from the fundamental principle that the justice is above all and it is exercised only to correct the error which has occurred.

- 11. The scope of review jurisdiction is narrow. As was rightly summed up by Justice Krishna Iyer in Northern India Caterers (India) Ltd. v. Lt. Governor of Delhi 1980 (2) SCC 167,
- "A plea for review, unless the first judicial view is manifestly distorted, is like asking for the moon. Therefore, unless and until there is patent error in the judgment delivered which is visible on the face of it, the review jurisdiction cannot be exercised."
- 12. On going through the above law on the subject, the Commission has considered the Review Application, the submissions of the learned Advocates for the parties and has gone through the Inquiry Report dated 22/02/2024.
- 13. In the Inquiry Report dated 22/02/2024, the Commission had held as under, in paragraphs 16, 17, 18, 19, 20 and 26,:-
- "16. The undisputed fact emerges that the Complainant had sustained a bullet injury on the heel of her right leg on 27/01/2021 and she was eventually hospitalized at the Goa Medical College, Bambolim, where she underwent a surgery and the bullet was removed on 03/02/2021. Though the Police Prosecutor contended that there was no negligence on the part of the Respondents and the Complainant may have come close to the firing range despite the warnings, the fact that the bullet was fired from the Firing Range is not denied by the Respondents. The complaint and the subsequent developments indicate that the Complainant had sustained an injury near her residence at Maulinguem, when she was washing clothes in her courtyard.
- 17. Again, though the learned Police Prosecutor submitted that the maximum range of the projectile fired from the gun is 1350 meters and the residence of the Complainant is beyond that distance, the very reply of the Respondent No. 1 admits that the inquiry conducted by the Police Department reveals that stray bullets had been flying over the hillock and landing in the village which is about two kilometers from the firing spot, as found in para 7 of the reply of the Respondent No.1 dated 27/07/2022.
- 18. The complaint had been filed before the Bicholim Police Station by the Complainant on 02/02/2021 regarding the bullet injury sustained by her on 27/01/2021 and the reply of the Respondent No.1 again indicates that the Bicholim Police Station had registered a case as Other Accident No. 01/2021 dated 03/02/2021.
- 19. There is also a letter dated 02/02/2021, which is written by the Sarpanch of Village Panchayat Ona, Maulinguem, Kudchirem to the Police Inspector of the Bicholim Police Station regarding this incident and suggesting to construct a safety wall around the Firing Range or to shift the same to some other convenient place to avoid any untoward incident in future.
- 20. The discharge card of the Complainant of the Goa Medical College, Bambolim, indicates that she was admitted on 03/02/2021 and discharged on 06/02/2021 and was found to have a bullet injury and she was operated on and the bullet was removed......
- 26. In the facts of the present case, and guided by the case laws cited above, the Commission agrees with the submissions of the Learned Advocate for the Complainant that the Complainant has made out violation of her human rights due to the actions of the Respondents in conducting their firing practices, resulting in a bullet travelling beyond the Firing Range and injuring the Complainant. The acts of the Respondents resulted in injury to the Complainant and loss of work to her for over three months as well as pain and suffering....."
- 14. Accordingly, the Commission recommended that the Respondent No. 1 pays compensation of Rs. 50,000/- (Rupees fifty thousand only) to the Complainant, within 30 days, from 22/02/2024, along with Simple Interest thereon at 6% p.a. from the date of the complaint i.e. 07/06/2022 till final payment.
- 15. Generally, the power of Review may be exercised on a discovery of new and important matters or on any error or mistake apparent from the face of the record.
- 16. The Commission does not agree with Learned Adv. Shri K. L. Bhagat for the Respondents, that the Commission had not taken into consideration the crucial points such as existence of the hillock and the distance of the house from the firing range.
- 17. The Commission had held in paragraph 12 of the Inquiry Report, that in the reply of Respondent No.1 filed in the same proceeding, they had stated that the Incharge of firing range had conducted a detailed inquiry,

which revealed that stray bullets had been flying over the hillock and were landing in the village which is about 2 kilometers away from the firing spot.

- 18. The Commission agrees with Adv. Ms. Pooja Kamat, for the Complainant, that the Respondents are raising matters for the first time of the existence of a natural hillock and a mud dump, which was not part of the record and of the reply of the Respondents in the Proceeding No. 106/2022.
- 19. Accordingly, the Commission finds that no grounds are made out for the Review of the Inquiry Report dated 22/02/2024 passed in Proceeding No. 106/2022, recommending that Respondent No. 1 should pay the compensation of Rs. 50,000/- to the Complainant within 30 days from 22/02/2024 along with simple interest thereon at 6% p.a. from the date of the complaint i.e. 07/06/2022 till final payment.
 - 20. The Review Application is accordingly rejected.
- 21. Copy of the Order be sent to the Respondent No. 1, calling for their comments, including the action taken or proposed to be taken within a period of 30 days, on or before 23/05/2025, in terms of Section 18 (e) of the Protection of Human Rights Act, 1993.

In compliance with the Order dated 22.04.2025, passed in Review Application No. 04/2024 in respect of Proceeding No. 106/2022, filed by the Respondent on 14.08.2024 under Section 20 of the Goa Human Rights Commission (Procedure) Regulations, 2011, it is respectfully submitted as follows:

The Commission, upon consideration, found no valid grounds for reviewing the Inquiry Report dated 22.02.2024 in Proceeding No. 106/2022. The said Inquiry Report had recommended that Respondent No.1 pay compensation of Rs. 50,000/- (Rupees Fifty Thousand only) to the Complainant within 30 days from the date of the order, along with simple interest at the rate of 6% per annum.

Accordingly, arrangements were made to disburse the compensation amount of Rs. 50,000/- along with the applicable interest calculated from the date of the complaint, i.e., 07.06.2022, until the date of final payment. To facilitate this, LPSI Nilam Gawas and UDC Nafisa Saied were deputed to visit the residence of the Complainant, Smt. Urmila Umesh Gaonkar, at Bicholim, on 21.05.2025 to obtain her signature on the prereceipt.

During the visit, Smt. Urmila Umesh Gaonkar requested additional time to consider the matter before signing the pre-receipt. Subsequently, she remained unresponsive to multiple phone calls on her mobile number 9623759233. She finally responded on 23.05.2025 at 12:42 hrs. and stated that she is unwilling to sign

the pre-receipt, expressing dissatisfaction with the compensation amount of Rs. 60,000/- (Rupees Sixty Thousand only), which she deemed insufficient in light of the injuries sustained in the firing incident.

This report is submitted with the approval of DGP, Goa, for the kind perusal of the Hon'ble Commission.

Read: (1) Order No. 01/ALLOCATION-DUTIES/ADM/2012-Mines/2473 dtd. 20/12/2012 published in the Official Gazette, Series I No. 39 dtd. 27/12/2012.

In exercise of power vested under sub-section (1) Section 24 of the Mines and Mineral (Development and Regulation) Act, 1957 (hereinafter referred to as the "said Act") and in supersession of the Government Order read in the preamble at serial number (1) above, the Government of Goa hereby authorizes the Director of Mines & Geology, the Additional Directors, Deputy Directors, Senior Geologists, Geologists, Assistant Mining Engineer, Surveying Officers, Junior Geologist, Junior Mining Engineers, Head Surveyors and any

other Officers specifically directed/empowered in this behalf by the Director of Mines & Geology to exercise following powers, namely:-

- a) Enter and inspect any mine;
- b) Survey and take measurements in any such mine;
- c) Weigh, measure or take measurement of the stocks of minerals lying at any mine;
- d) Examine any document, book, register, or record in the possession or power of any person having the control of, or connected with, any mine and place marks of identification thereon, and take extracts from or make copies of such document, book, register or record;
- e) Order the production of any such document, book, register, records, as referred to in Clause (d); and
- f) Examine any person having the control of, or connected with, any mine.

The above powers are vested for the purpose of ascertaining the position of the working, actual or prospective, of any mine or abandoned mine or for any other purpose connected with the said Act or the rules made thereunder.

All the officers mentioned hereinabove or person directed or empowered by Director of Mines & Geology shall be deemed to be public servant within the meaning of Section 2(28) of Bharatiya Nyaya Sanhita, 2023 and every person to whom an order of summons is issued by virtue of the powers conferred by Clause (e) or Clause (f) above shall be legally bound to comply with such order or summons, as the case may be.

Each working mining and composite lease shall be inspected at least twice in a year. The non-working, abandoned or mine under prospective working or under reconnaissance permit shall be inspected at least once in a year.
