In exercise of the powers conferred under Section 119 of the Goa Panchayat Raj Act, 1994 (Goa Act 14 of 1994), I, Daulat Hawaldar, IAS (Retd.), Commissioner, Goa State Election Commission, Panaji-Goa hereby initiate the process of dividing the area within the jurisdiction of North Goa Zilla Panchayat and South Goa Zilla Panchayat into 25 and 25 single member constituencies respectively for the purpose of ensuing General Election to North Goa Zilla Panchayat and South Goa Zilla Panchayat. To assist me in the above process the Officers mentioned below are appointed as the Electoral Registration Officers (ERO) and Asst. Electoral Registration Officers (AERO):-

The respective ERO/AERO shall divide area within the jurisdiction of North Goa Zilla Panchayat and South Goa Zilla Panchayat into 25 and 25 single member constituencies respectively considering following points:

- 1. The Zilla Panchayat Constituencies may be constituted in consonance to Section 119 of the Goa Panchayat Raj Act, 1994 (Goa Act 14 of 1994 & Rules) and Rule 3 of the Goa Panchayat and Zilla Panchayat (Election Procedure) Rules, 1996.
- 2. The ERO/AERO shall utilize the Electoral Roll of the Goa Legislative Assembly prepared under the provisions of Representation of People Act, 1950 (Central Act 43 of 1951) for the time being in force as on 1st January, 2025 (as the qualifying date) and published on 6th January, 2025 (Basic Roll of Special Summary Revision 2025 published on 29-10-2024 integrated with Additions, Deletions and Modifications carried out during Special Summary Revision 2025) and List of Addition, Deletion and Correction carried out during continuous updation with respect to 1st July, 2025 to divide the area of Zilla Panchayat into territorial constituencies.
- 3. To ensure that the geographical contiguity of all the areas in a Zilla Panchayat Constituency is maintained.
- 4. Each Zilla Panchayat Constituency shall be assigned a separate serial number.
- 5. The ERO/AERO shall prepare the Zilla Panchayat Constituency wise maps and submit the same along with the draft delimitation proposal to the Goa State Election Commission latest by 11<sup>th</sup> September, 2025.
