15(147)/2025/DITEC GTIP-2020/Impl.ROW Rules 24/561 Date : 24-Jun-2025 Read: 1. The Telecommunications (Right of Way) Rules, 2024 dated 17-09-2024.

2. F. No. 15(149)/2025/DITE&C/Impl. Of ROW Rules 2024/4397 dated 13-03-2025.

Whereas, the Government of Goa has adopted the Telecommunications (Right of Way) Rules, 2024, effective from 1st January, 2025, to ensure the rapid expansion of telecommunication infrastructure and improve connectivity;

And whereas, in order to streamline and expedite the issuance of Right of Way (RoW) permissions and facilitate the development of telecommunication networks, the Government of Goa has designated the Department of Information Technology, Electronics and Communications (DITE&C) for issuing RoW permissions and No Objection Certificates (NOCs) for Government Land on ROW eServices Portal developed by Department of Telecommunication, Government of India within the time period mentioned in the RoW Rules, 2024;

Now, therefore, the Government of Goa, in exercise of the powers conferred under the relevant provisions of the Telecommunications (Right of Way) Rules, 2024, issues the following directions:

# 1. State Designated Department:

The Department of Information Technology, Electronics & Communications (DITE&C) shall serve as the State Designated Department for the implementation of the Telecommunications (Right of Way) Rules, 2024. The Department shall oversee the smooth processing and issuance of all RoW applications related to Government Land within the State of Goa on ROW eServices Portal developed by Department of Telecommunication, Government of India within the time period mentioned in the RoW Rules, 2024.

#### 2. Appointment of Nodal Officer & collection of land usage charges:

- i The State Designated Department shall appoint a Nodal Officer who will be responsible for the efficient implementation and processing of all RoW applications through the ROW eServices Portal developed by the Department of Telecom, Government of India. This portal shall serve as the single window for RoW applications.
- ii All other line departments must also needs to appoint their respective Nodal Officers to co-ordinate with the State Designated Department for the effective implementation of the rules.
- iii The line departments, whose land is proposed to be utilized for telecom infrastructure, must conduct proper surveys, prepared report, and forward the recommendations to the Department of Information

Technology, Electronics, and Communications for the issuance of permission/NOC on ROW eServices Portal developed by the Department of Telecom, Government of India within the time period mentioned in the RoW Rules, 2024.

- iv Application fees, land usage charges for Government land, and street furniture usage charges shall be collected by DITE&C and deposited in the treasury account.
- v For Autonomous Bodies, Corporations, Local Governments, and Municipality Land, DITE&C will collect the land usage charges and transfer the same to the respective land-owning authority as and when applicable.

## 3. Compensation for Public Property:

As per the Telecommunications (Right of Way) Rules, 2024, Section 9(2)(b), compensation shall be paid for the value of public property used for telecommunication network establishment, based on rates decided by the relevant public entity.

"Where the establishment of the telecommunication network renders the public property unlikely to be used for any other purpose, compensation for the value of the public property, either once or annually, assessed on such rates as that public entity may, by general order."

#### **AWARD**

# (Delivered on this the 28th day of the month of July of the year 2025)

By Order dated 18-03-2024, bearing No. 28/10/2024-LAB/188 the Government of Goa in exercise of the powers conferred by Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (Central Act 14 of 1947) (hereinafter referred to as the "said Act"), referred the existing dispute between the Management of M/s. Marksans Pharma Limited, Plot No. L-82, L-83, Verna Industrial Estate, Verna, Salcete, Goa and its workman, Shri Gurudas S. Charadkar, represented by the Goa Trade and Commercial Workers' Union, for adjudication to the Industrial Tribunal of Goa at Panaji-Goa, constituted under Section 7-A of the said Act. The Schedule of reference is as under:

#### **SCHEDULE**

- (1) Whether the action of the management of M/s. Marksans Pharma Limited, Plot No. L-82, L-83, Verna Industrial Estate, Verna, Salcete, Goa in transferring Shri Gurunath S. Charadkar, workman from Goa to Company's Research and Development Centre, at Navi Mumbai, Maharashtra, with effect from 13/02/2023, is legal and justified?
- (2) If not, what relief the workman is entitled to?"
- 2. Upon receipt of the reference, it was registered as IT/11/2024 and registered A/D notices were issued to both the Parties. Pursuant to service of notice, both the Parties put in their appearance. Party I filed their Claim Statement at Exhibit 7. Exhibit 8 is the Written Statement filed by Party II to which Party I filed their Rejoinder at Exhibit 9.
- 3. Considering the pleadings of both the Parties this Tribunal framed issues on 18/11/2024 at Exhibit 11. The issues reads as under:

### **ISSUES**

- 1. Whether the Party I/Workman proves that the action of Party II/Company in transferring the services of Shri Gurunath S. Charadkar to Marksans Research and Development Centre located at Navi Mumbai, Maharashtra w.e.f. 13/02/2023 is malafide, illegal and bad in law and whether it amounts to an act of unfair labour practice, harassment and victimization?
- 2. Whether the Party II/Company proves that the Party I/Workman is not workman as defined u/s 2(s) of the I. D. Act, 1947?
- 3. Whether the Party II/Company proves that the Party I/Workman has abandoned his services voluntarily?
- 4. Whether the Party II/Company proves that this Hon'ble Court lacks jurisdiction to adjudicate upon the present industrial dispute?
- 5. What Order? What Relief?
- 4. The Party I in support of their case, examined their witness Shri Gurunath S. Charadkar. Along with the Affidavit-in-Evidence at Exhibit 14, Shri Charadkar produced documents from Exhibit 15 Colly to Exhibit 42. The matter was adjourned for cross-examination of the Party I witness at which time the Advocate for Party II filed an application for withdrawal along with the Memorandum of Settlement at Exhibit 43 Colly.
- 5. The above application for withdrawal at Exh. 43 Colly along with the Terms of Settlement have been signed by the Workman and the representative of the Party II/Employer and have agreed upon the terms mentioned below:

The terms of Settlement are as follows:

1. The Management states that they have already paid all the dues to Shri Gurunath S. Charadkar vide bank transfer on 04/07/2025, total amount of Rs. 10,974/- (Rupees Ten Thousand Nine Hundred and

Seventy Four only) as full and final settlement of all his legal dues as per the terms of his Appointment Letter which he has duly received and acknowledged.

- 2. The Management further agreed to assist him withdrawal/transfer of his PF dues with the necessary compliance with the Provident Fund Corporation.
- 3. In view of the above Shri Gurunath S. Charadkar agreed that his all dues are cleared and his dispute with the Management is conclusively settled and he is having no claim of whatsoever nature against the Management.
- 4. Shri Gurunath S. Charadkar further agreed that he will not file any further claim against the Management company before any Court of law as he is no longer interested in working for the Management company as he is presently interested in taking alternate employment.
- 5. That Shri Gurunath S. Charadkar further stated that he does not wish to pursue his matter i.e. case Ref. No. 11/2024 pending before Industrial Tribunal/Labour Court, Application bearing No. 22/2023 before the Labour Court II and Charter of Demands matter bearing No. IT/15/2023. He shall submit this Memorandum of Settlement for the records of the said Court requesting the Hon'ble Judge/Presiding Officer of the said Tribunal/Court to treat the said reference as duly settled and that this agreement is voluntarily executed by him out of his own free will and without any coercion.
- 6. That Shri Gurunath S. Charadkar agrees to file application before the appropriate courts on their respective dates of hearing. It is also agreed that if needed both Parties shall file joint application to treat the said application/reference case in Ref. No. 11/2024, Appln. No. 22/2023 and Ref. No. IT/15/2023 as duly settled or for passing no dispute award and also to withdraw the applications filed by Mr. Charadkar.
- 7. In view of the above, it is agreed that the issue/dispute between both the Parties is conclusively settled. Shri Gurunath S. Charadkar hereby agrees and undertakes not to act or cause to act against the interest of the Company directly or indirectly in the future.
- 8. In view of the above terms, Shri Gurunath S. Charadkar agrees to withdraw all the application/cases/complaints etc. filed by him or on his behalf against the management company with Labour Court/Labour Commissioner or any other court, Government, Non-Government or statutory authority/authorities as all the disputes between both the Parties are treated as conclusively settled.
- 9. The Management also agreed to issue experience certificate to Shri Gurunath S. Charadkar as per his request which will assist him in taking up new employment.
- 10. In view of the above, it is further agreed that all the issues/disputes between both the parties is conclusively settled and both the parties do not have any claim of whatsoever nature against each other.
- 6. I have gone through the withdrawal application dated 04/07/2025 along with the Memorandum of Settlement at Exh. 43 Colly filed on record duly signed by both the Parties. The terms of settlement are acceptable to both the Parties which in my view, are just and fair to bring about harmony and industrial peace. As such the Settlement is accepted.

In view of above, I pass the following Order:

#### **ORDER**

- (i) The reference at the instance of both the Parties stands disposed off in view of the Settlement arrived by both the Parties at Exhibit 43 Colly.
- (ii) No order as to costs.
- (iii) Inform the Government accordingly.
