Whereas, Hon'ble High Court of Bombay at Goa vide Judgment in Writ Petition No. 347 of 1996 dated 20-12-1996, declared that bull fights or Dhirios were in contravention of the Prevention of Cruelty to Animals, Act 1968, therefore illegal and cannot be permitted.

And whereas, said Judgment and Order dated 20-12-1996 further directed the Respondents therein to take immediate steps to ban all types of animal fights including Bull fights or Dhirio.

And whereas, a Contempt Petition No. 10/2021 in Writ Petition No. 347 of 1996 was filed by People for Animals, Goa vs. Govt. of Goa in the matter regarding banning the organization of bull fights in the State of Goa.

And whereas, an action plan was formulated for curbing Dhirios pursuant to the judgment passed by the Hon'ble High Court of Bombay at Goa in Contempt Petition No. 10 of 2021 in Writ Petition No. 347 of 1996 filed by People for Animals Goa v/s Shri Parimal Rai & Ors.

And whereas, an uniform direction was received from the District Collector North and South Goa, for microchipping of the bulls, to tackle the persistent issue of bullfights in their meetings held on 09-07-2025 and 08-07-2025 respectively.

Now therefore, (a) all the bull owners in the State of Goa are hereby directed to get their bulls (including buffalo bulls) microchipped and registered with the Area Veterinary Officers by taking prior appointment but not later than 1 month from date of publication of this notification in Official Gazette.

The Police Inspector in whose jurisdiction the said bull is housed, should ensure that the owner of the bull gets his animal registered, without any delay.

Those bull owners who fail to get their bulls (including buffalo bulls) microchipped and registered with the Area Veterinary Officers after the time frame fixed by this Notification, shall be presumed to have willfully abstained from microchipping and registration with Area Veterinary Officer with the intent of Indulgence in illegal Bull fights or Dhirios.

Any bulls found without registration and microchipping/ear tagging, shall be confiscated and shifted to the designated Gaushala, by the concerned Police Inspector under supervision of jurisdictional Veterinary Officer.

Any person contravening this Notification shall be levied by the concerned Police Inspector, a fine of Rs. 50,000/- (Rupees Fifty Thousand only) being amount equivalent to maintenance cost of bull for initial 3 months at Goshala.

The following draft Rules which the Government of Goa proposes to make in exercise of the powers conferred by Section 9 of the Goa (Verification of Tenants) Act, 2024 (Goa Act 26 of 2024) are hereby pre-published as required by Section 9 of the said Act for information of all the persons likely to be affected thereby and notice is hereby given that the said draft rules will be taken into consideration by the Government after expiry of a period of thirty days from the date of publication of this Notification in the Official Gazette.

All objections and/or suggestions to the said draft rules may be forwarded to the Chief Secretary/Secretary (Home), Secretariat, Porvorim, Goa, 403521, before the expiry of said period of thirty days so that they may be taken into consideration at the time of finalization of the said draft rules.

DRAFT RULES

In exercise of the powers conferred by Section 9 of the Goa (Verification of Tenants) Act, 2024 (Goa Act 26 of 2024), and all other powers enabling it in this behalf, the Government of Goa hereby makes the following rules, namely:—

1. *Short title and commencement.*— (1) These rules may be called the Goa (Verification of Tenants) Rules, 2025.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. *Definitions.*— In these rules, unless the context otherwise requires—

(a) “Act” means the Goa (Verification of Tenants) Act, 2024 (Goa Act 26 of 2024);

(b) “CCTNS” means Crime and Criminal Tracking Networking System;

(c) “Form” means a form appended to these rules;

(d) “Government” means the Government of Goa;

(e) “ICJS” means Inter Operable Criminal Justice System;

(f) “section” means a section of the Act;

(g) “Sub-Divisional Magistrate” shall have the same meaning as specified under sub-section (4) of Section 14 of the Bharatiy Nagarik Suraksha Sanhita, 2023 (Central Act No. 46 of 2023);

(h) “Sub-Divisional Police Officer” means a police officer of the rank of the Deputy Superintendent of Police heading a Police sub-division in the State of Goa.

3. *Manner of verification.*— (1) The owner shall verify the identity of the tenant by obtaining and inspecting any one of the original document specified in sub-section (1) of Section 3 of the Act.

(2) The owner shall also take a photocopy of the documents so inspected and enclose it along with Form-I for submission to the designated Police Station having jurisdiction over the area in which the premises are located within 48 hours either in person or digital mode as directed by the Authority collecting and verifying such information. In case, the owner opts for digital mode, the same will be done on payment of fees as notified by the Government. The owner shall be provided an acknowledgment of such application by the concerned Police Station.

4. *Form for maintenance of record.*— The owner shall maintain a record of every tenant occupying his premises in a register/book as per Form-II

5. *Inspection and Report by the Police Officer.*— (1) The Police Officer not below the rank of Head Constable having jurisdiction or such other Officer as may be specified by the Government by notification in the Official Gazette shall be entitled to inspect the records maintained under Section 3 of the Act.

(2) A report under sub-rule (1) shall be prepared by such police officer or other officer, as the case may be.

(3) In the event of:

(a) Non-maintenance and non-submission of information by owner; or

(b) Tenant not willing to disclose such Information as required;

(c) Tenant disclosing false information;

(d) receiving criminal case information of the tenant from other Police Station or

(e) receiving criminal case information of tenant through ICJS or CCTNS portal. Such reports shall be submitted to the jurisdictional Sub-Divisional Police Officer within a period of 7 days for necessary action as per law.

(4) In respect of cases stated in sub-rule 3 (a) and 3 (b) above, the Sub-Divisional Police Officer shall forward his report to the Sub-Divisional Magistrate within a period of 3 days.

6. *Procedure for recovery of fine from owner.*— On receipt of a report from Sub-Divisional Police Officer, Sub-Divisional Magistrate shall issue a notice to the owner of the premises to appear before it along with the information of the tenant in Form I and II and if offence under Section 5 is committed levy fine as stated in that section.

7. *Interpretation.*— If any question arises as to the interpretation of these rules or any other matter not expressly provided for in these rules, the same shall be referred to the Government, and the decision of the Government thereon shall be final and binding.

The Empowering Schedule Tribe (ST)/Schedule Caste (SC) Communities using Information and Communication Tools (ICT) scheme as adopted by the Government is hereby notified for information of the public.

This is issued with the approval of the Council of Ministers in the LXXIXth Cabinet Meeting held on 06-08-2025.

1. *Short Title and Commencement.*— a. This scheme is called “Empowering Schedule Tribe (ST)/Schedule Caste (SC) Communities using Information and Communication Technology (ICT) Tools”.

b. The scheme shall come into force from the date of the notification of its publication in the Official Gazette and shall remain valid for a period of 3 years.

2. *Introduction.*— The Department of Information Technology, Electronics & Communications under its vision to create a suitable IT eco-system has formulated this scheme, namely “Empowering Schedule Tribe (ST)/Schedule Caste (SC) Communities, using Information and Communication Technology (ICT) Tools” under Tribal Sub Plan (TSP) & Schedule Caste Sub Plan (SCSP) to provide IT related trainings to the ST/SC communities free of cost. This scheme shall be implemented through the various IT Knowledge Centers (ITKC) setup across the State.

3. *Objective of the Scheme.*— a. The following are the objectives of the scheme:

- i. To provide basic computer skills to the local youth, housewives and other citizens belonging to the ST/SC Community.
- ii. To provide various Job oriented IT Training courses.
- iii. To provide structural training programmes depending on the needs.
- iv. To make at least one person in each family in the State IT literate.

4. *Scope of the Scheme.*— The Department through M/s. ITG empanels training centers to conduct IT courses under the banner of IT Knowledge Centers (ITKCs). This scheme is applicable in all the empanelled ITKCs. Eligible students from the Scheduled Tribe (ST) and Scheduled Caste (SC) communities may enroll in a maximum of two courses per year under this scheme, through the ITKCs. However, they are not permitted to repeat any courses they have successfully completed in previous years. These courses will be available free of cost to the ST/SC communities.

5. *Eligibility under the scheme.*— a. The citizen/student must be of Goan Origin.

b. The citizen/student must belong to ST or SC Community.

c. The scheme is applicable for all the courses offered under ITKC and available at the IT training centers empanelled by M/s. ITG.

d. An applicant will not be allowed to avail the benefit for the same course in multiple ITKCs.

e. An applicant shall be eligible to enroll a maximum of two courses per year under the scheme, with no provision to repeat any courses they have successfully completed in previous years.

6. *Procedure for applying.*— a. The application forms are to be submitted at the empanelled ITKCs through which the applicant would like to avail the courses.

b. The applicant is required to submit the following documents while applying;

- i. One copy of the application form (enclosed herewith).
- ii. One copy of passport size photograph with signature of the applicant thereon.
- iii. An attested copy of Caste Certificate/Social Status certificate issued by the Deputy Collector, in case the applicant is belonging to ST/SC community.
- iv. An attested copy of Education Qualification.
- v. Undertaking from applicant stating that he/she shall/has not availed more than two courses per year and is not repeating the said course under this scheme.
- vi. Birth Certificate
- vii. Aadhaar Card

7. *Quantum of Financial Assistance under the Scheme.*— a. M/s. Info Tech Corporation of Goa Ltd. (M/s. ITG) is nominated as the implementing agency for the proposed scheme.

b. The Department of Information Technology, Electronics & Communication shall provide as per the a Grant-in-Aid under the Tribal Sub Plan (TSP) and the Schedule Caste Sub Plan (SCSP) to M/s. ITG on a yearly basis for providing free IT related trainings to the ST/SC beneficiaries as per the guidelines outlined in Office Memorandum File No. 7/15/2023-FIN (EXP)/182, issued by the Finance Department.

8. *Pattern of Assistance.*— a. The grants shall be utilized exclusively for providing free IT related trainings to the ST/SC beneficiaries.

b. The entire amount of the grants should be utilized within a period of one financial year and only for the purpose for which it is sanctioned. Any portion of the grant, which is not ultimately required, will be refunded to the Government. After utilizing/refunding the sanctioned amount, Utilization Certificate should be furnished to the sanctioning authority as required under form G.F.R. – 12-C.

c. No grant shall be paid to any other institutions/voluntary organizations out of this grant sanctioned by the Government.

d. The Grantee Institution must exercise reasonable economy, observe all financial rules as issued by the Government from time to time while incurring the expenditure.

e. The amount remaining unspent out of this grant shall be refunded back to the Government Treasury by Challan within 3 (three) months from the close of financial year.

f. The amount shall be drawn from the Directorate of Accounts on presentation of the bill in form GAR-32 duly countersigned by the Drawing and Disbursing Officer, Department of Information Technology, Electronics & Communications.

9. *Relaxation and Interpretation of the provision of the Scheme.*— The Government through Department of Information Technology, Electronics & Communications shall be empowered to relax/interpret any of the clauses/conditions of this scheme and the decision of the Director (ITE&C) shall be final and binding on all concerned.

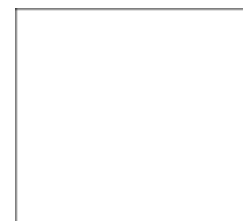

Since this is the last revision of the scheme, the final authority to grant the benefit either fully or in exceptional cases as an ex-gratia benefit in either single case or group of cases shall lie with Hon’ble Chief Minister whose decision shall be final, in case “Screening Committee” either defers the decision on proposal or decides on such proposal in negative.

This issues with the approval of the Council of Ministers as Table Item No. 12 of its LXXVTH Cabinet Meeting held on 21-07-2025 as conveyed by the General Administration Department vide letter No. 1/16/2025-GAD-II dated 22-07-2025.

In pursuance to amendment made to proviso to sub-section (3) of Section 88 of the Goa Municipalities (Amendment) Act, 2022; published in Official Gazette Series I No. 24 dated 15th September, 2022 the Government makes the following terms and conditions in respect of immovable property of a Council where the period of lease has already expired and such lease is not renewed:

1. The Council may renew the lease of property of the Council if,

(i) lessee clears all outstanding dues of the Council;

(ii) application for renewal of lease is made before expiry of a period of two months from the date of publication of this Notification in the Official Gazette.

2. The lease shall be renewed within a period of fifteen days from the date of receipt of application by the Council from the lessee, complete in all respects.

3. If any lease is not renewed on expiry of period of lease of any premises of the Council, as mentioned herein above, then such lease shall be treated as unauthorized and shall stand terminated. The Chief Officer shall take possession of such premises after giving fifteen days notice to the lessee.

4. If the lessee desires to hear him pursuant to the notice issued, then he shall deposit the rental amount as per demand of arrears of rent including interest as applicable, raised by the Council for the defaulting period till the date of issue of notice failing which the licence issued to the lessee shall be revoked and Chief Officer shall proceed with Section 265A of the Goa Municipalities Act, 1968.
