The City Logistics Committee (CLC) shall serve as the core institutional framework responsible for steering the preparation and implementation of the Vasco City Logistics Action Plan (CLAP). The following roles and responsibilities are assigned to the Committee:-

1. The Committee shall act as a strong institutional mechanism ensuring co-ordinated, inclusive, and participatory decision making involving all key stakeholders from Government, industry, and civil society.
2. The Committee shall convene meetings to jointly review and understand the existing logistics landscape of Vasco, identify major challenges, and outline key focus areas for targeted policy and infrastructure interventions.
3. The Committee shall oversee the preparation of a baseline assessment capturing.
  - \* Freight corridors and flow patterns.
  - \* Key freight-generating hubs.
  - \* Vehicle types and movement frequencies.
  - \* Congestion hotspots and logistics demand zones.
4. The Committee shall define a clear vision for urban freight movement and formulate measurable objectives addressing sustainability operational efficiency, road safety, emission reduction.
5. The Committee shall oversee and facilitate the development of the Vasco City Logistics Action Plan (CLAP), ensuring alignment with the methodology and timelines outlined by DPIIT. It shall guide the overall approach for preparing the plan and ensure that the CLAP includes a phased implementation roadmap (short-, medium-, and long-term), clearly tying actions to responsible agencies and budgetary allocations.
6. The Committee shall provide advisory support to the appointed term or consultants, ensuring adherence to guidelines and directives issued by DPIIT, Government of India.
7. The Committee shall monitor progress of CLAP and implementation, conduct regular review meetings, and facilitate course of correction where required to ensure timely delivery of outcomes.

#### **Operational Guidelines for the City Logistics Committee (CLC)-Vasco City.**

1. The quorum for any meeting of the Committee shall be one-third of the total members or a minimum of five members, whichever is higher.
2. Presence of the Chairman and the Member Secretary shall be mandatory for the meeting to be deemed valid.
3. The Committee shall convene at least once every month or as often as required to meet the timelines and deliverables of the City Logistics Action Plan.
4. The Directorate of Industries, Trade & Commerce shall act as nodal department and provide secretariat and co-ordination support to the Committee.
5. The Directorate of Industries, Trade & Commerce shall be responsible for issuing meeting notices, recording minutes, co-ordinating with line departments, and ensuring timely follow-up on Committee decisions.
6. The Committee may invite subject matter experts, external consultants, or representatives from academia or technical institutions as special invitees for specific agenda discussions.
