Read:- Notification No. 6/26/2015-FIN(DMU)/7553 dated 03-05-2024.

Para No. 3 along with 3(a) of the Notification mentioned above shall be read as follows:—

3. Objective of the scheme.— The fund shall be utilized for meeting the payment obligations arising out of the guarantees issued by the Government in respect of bonds issued and other borrowings by the State Level Public Sector Undertakings or Other Bodies and invoked by the 'beneficiaries'. Further, the funds in excess of prescribed limit of 5% of accumulated fund/outstanding guarantees shall be utilized for Debt Management Purpose by the State Government.

Explanation

(a) The accumulations in the Fund shall be utilized towards the payment of the guarantees issued by the Government and invoked by the beneficiary and not paid by the institution on whose behalf guarantee was issued and shall also be utilized for Debt Management purpose.

Also, Para No. 5(a) of the Notification mentioned above shall be read as follows:-

5. Contribution to the fund.— (a) The Government should make conscious efforts towards building up the GRF corpus to five per cent of the outstanding guarantees within a span of five years from the date of constitution of the fund. The amount over and above 5% of the accumulated fund in the Guarantee Redemption Fund can be withdrawn and utilized for debt management purpose by the State Government.

The remaining content of the Notification remains unchanged.

Goa Media Representatives Accreditation Rules, 2025

In exercise of the powers conferred by The Goa Media Representatives Accreditation Rules, 2025 and all other powers enabling it, the Government of Goa hereby makes the following amendments to "The Goa Media Representatives Accreditation Rules, 2025" with the following changes to the original notification No. DI/INF/Revisit-PAC/2024-25/153 dated April 4, 2025, published in the Official Gazette, Series I No. 2 dated April 10, 2025.

Amendment: Clause 5(xiii)(a) the sentence "Only news portals run by entities duly registered as media house with the Government and under Companies Act and with the Labour Commissioner and Provident Fund as per existing rules in force in addition to registration under Trade and Establishment Act Shops and Establishment Act" shall be deleted and substituted with "Only news portals run by entities duly registered as media house under Companies Act or under Shops and Establishment Act with valid trade license and with the Labour Commissioner and Provident Fund as per existing rules in force".

Clause 7.2— The sentence "The Accreditation Committee formed by the State Government shall on the recommendation of Editors Guild and GUJ have 02 Representatives of the Editors Guild, 09 Representatives of Goa Union of Journalists-4 from Print-01 shall be news photographer and 01 shall be Sports Reporter; 02 from Local TV Channels (one cameraman and one reporter) and 02 from Digital Portals and one member shall be from Magazines mandatorily. The aforesaid associations shall be registered and submit a copy of the valid registration to the Department" shall be deleted and substituted with "The Accreditation Committee formed by the State Government shall on the recommendation of Editors Guild and GUJ have 02 Representatives of the Editors Guild, 02 Representatives of Goa Union of Journalists; 01 each from PJAG and Sports Reporter; 02 from Local TV Channels (one cameraman and one reporter) to be recommended by EMJA; 02 from Digital Portals and one member shall be from Magazines mandatorily. The aforesaid associations shall be registered and submit a copy of the valid registration to the Department. In case there is no association or no names are submitted by the concerned association, then DIP will recommend the name from the concerned field".

Clause 7.11 The sentence "Educational Qualifications for Print/Electronic Media local news channel/Digital Platform journalists shall be atleast HSSC shall be read as "Educational Qualifications for Print/Electronic Media local news channel/Digital Platform journalists shall be atleast HSSC or 10 + 2 equivalent.

Clause 7.18 the words '25 years' shall be deleted and substituted with '15 years'.

powers enabling him in this behalf and in consultation with the Goa Public Service Commission, conveyed vide their letter No. COM/I/25/88/442 dated 26-06-2025, the Governor of Goa hereby makes the following rules so as to amend the Goa Police Service Rules, 2022, namely:—

- 1. Short title and commencement.— (1) These rules may be called the Goa Police Service (First Amendment) Rules, 2025.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Amendment of rule 2.— In rule 2 of the Goa Police Service Rules, 2022 (hereinafter referred to as the "Principal Rules"), for clause (o), the following clause shall be substituted, namely:—
 - "(o) "Year" means the period commencing on the first day of January and ending on the thirty-first day of December of the same year".
- 3. Amendment of rule 7.— In rule 7 of the Principal Rules, for clause (b), the following clause shall be substituted, namely:—
 - "(b) The remaining 60% of the vacancies of the Junior Scale shall be filled by promotion from amongst the officers who hold any of the post of Police Inspector i.e. Police Inspector, Police Inspector (Armourer), Police Inspector (Wireless), Police Inspector (Radio Mechanic) and Police Inspector (Motor Transport) including Police Inspector of Indian Reserve Battalions of Goa Police i.e. Police Inspector (Armed Police) on regular basis for a minimum period of five years under the Government".
- 4. Amendment of rule 8.— In rule 8 of the Principal Rules, in item (ii), for clause (b), the following clause shall be substituted, namely:—
 - "(b) He shall not be more than 40 years of age on the last date of the receipt of application:

Provided that the upper age limit may be relaxed by the Government in respect of the Government servants and other categories of persons as may be notified by special order issued in this behalf by the Government for maximum upto 45 years".

- 5. Amendment of rule 9.— In rule 9 of the Principal Rules, in sub-rule (1), for the existing proviso, the following proviso shall be substituted, namely:—
 - "Provided that whenever the Goa Public Service Commission is of opinion that conducting screening test is required for short listing of candidates, such test including Computer Based Recruitment Test should be conducted by the Commission in such a manner as may be decided by the Commission, from time to time".
- 6. Amendment of rule 13.— In rule 13 of the Principal Rules, in item (xii), for the expression "Indian Penal Code,1860 (Central Act 45 of 1860)", the expression "Bharatiya Nyaya Sanhita, 2023 (Central Act 45 of 2023)" shall be substituted
- 7. Substitution of rule 16.— For rule 16 of the Principal Rules, the following rule shall be substituted, namely:-
 - "16. Promotion to Junior Scale of Goa Police Service.— (1) In the month of January of every year, the Government shall prepare a combined eligibility list of officers in the rank of Police Inspector i.e. Police Inspector, Police Inspector (Armourer), Police Inspector (Wireless), Police Inspector (Radio Mechanic) and Police Inspector (Motor Transport) including Police Inspector of Indian Reserve Battalions of Goa Police i.e. Police Inspector (Armed Police) for the purpose of promotion to the Junior Scale of the Service, such list shall be circulated to all the officers holding such posts.
 - (2) For the purpose of sub-rule (1), an officer shall be considered as eligible for promotion to the Junior Scale of the Service, if he or she has held the posts on regular basis for a period of five years and possesses essential qualifications including educational qualifications as specified in item (iii) of rule 8.

- (3) The combined eligibility list so prepared shall be based upon the seniority list vis-a-vis date of appointment shown in the respective seniority list of the posts in the rank of Police Inspector i.e. Police Inspector, Police Inspector (Armourer), Police Inspector (Wireless), Police Inspector (Radio Mechanic) and Police Inspector (Motor Transport) including Police Inspector of Indian Reserve Battalions of Goa Police i.e. Police Inspector (Armed Police).".
- 8. Substitution of rule 18.— For rule 18 of the Principal Rules, the following rule shall be substituted, namely:—
 - "18. Conditions of eligibility and procedure for selection.— (1) The D.P.C. shall consider in the month of January every year the cases of officers eligible under clause (b) of rule 7, who have served in any of the post of Police Inspector i.e. Police Inspector, Police Inspector (Armourer), Police Inspector (Wireless), Police Inspector (Radio Mechanic) and Police Inspector (Motor Transport) including Police Inspector of Indian Reserve Battalions of Goa Police i.e. Police Inspector (Armed Police) for not less than five years in regular service and prepare a select list of officers recommended, taking into account the actual vacancies at the time of selection. The selection for inclusion in the list shall be based on eligibility and seniority for appointment to the Service".
- 9. Amendment of rule 22.— In rule 22 of the Principal Rules, for sub-rules (1), (2), (3) and (4), the following sub-rules shall be respectively substituted, namely:—
 - "(1) Every probationer shall, during the course of probation, appear at departmental training and pass a departmental examination to be conducted by the Government either through the Goa Institute of Public Administration and Rural Development (GIPARD) or any institution entrusted by the Government for the said purpose, in the manner as notified by the Government in this regard, from time to time.
 - (2) The training module, period of training and syllabus for the departmental examination shall be as specified by the Government in consultation with the Commission.
 - (3) The Goa Institute of Public Administration and Rural Development or any institution entrusted by the Government, in the calendar year, normally in the month of January, shall hold the departmental training for minimum three weeks followed by departmental examination for the probationers of the Junior Scale post of Goa Police Service. The Goa Institute of Public Administration and Rural Development or any institution entrusted by the Government, while drawing the training schedule of each year, shall reserve slots for training of probationers of the Junior Scale of Goa Police Service irrespective of candidates available for training or otherwise.
 - (4) A probationer who has attained the age of 50 years and who is appointed under clause (b) of rule 7 shall be exempted from the Departmental Examination. However, he shall compulsorily undergo the training programme during the probation period."
- 10. Amendment of rule 23.— In rule 23 of the Principal Rules, for the words "three months", the words "six months" shall be substituted.
- 11. Amendment of rule 30.— In rule 30 of the Principal Rules, in sub-rule (2), for the words "six years", the words "five years" shall be substituted.
- 12. Amendment of rule 31.— In rule 31 of the Principal Rules, for sub-rule (2), the following sub-rule shall be substituted, namely:—
 - "(2) A Senior Scale Officer after completion of ten years of regular service in the service or four years of regular service in the grade of Senior Scale, shall be entitled for promotion to the Junior Administrative Grade from the date of completion of the said period."
- 13. Amendment of rule 32.— In rule 32 of the Principal Rules, for sub-rule (2), the following sub-rule shall be substituted, namely:—
 - "(2) A Junior Administrative Grade Officer after completion of fourteen years of regular service in the service or four years of regular service in the Junior Administrative Grade, shall be entitled for promotion to the Selection Grade from the date of completion of the said period."

- 14. Amendment of rule 33.— In rule 33 of the Principal Rules, for sub-rule (2), the following sub-rule shall be substituted, namely:—
 - "(2) A Selection Grade Officer after completion of nineteen years of regular service in the service or four years of regular service in the Selection Grade, shall be entitled for promotion to the Senior Administrative Grade from the date of completion of the said period."
- 15. Substitution of rule 37.— For rule 37 of the Principal Rules, the following rule shall be substituted, namely:—
 - "37. The crucial date for eligibility of officers for promotion.— The crucial date for determining the eligibility of the officers for promotion to Junior and Senior Scale of Goa Police Service shall be the first day of January of the year in which the D.P.C. meets."
- 16. Substitution of Schedule-I.— For Schedule-I to the Principal Rules, the following Schedule shall be substituted, namely:—

supersession of the existing recruitment rules for the post of Superintendent of Survey and Land Records, published vide Government Notification No. 1/10/74-PER (Part) dated 28-04-2004, in the Official Gazette, Series I No. 7 dated 13-05-2004, the Governor of Goa hereby makes the following rules to regulate the recruitment to the Group 'B', Gazetted, Non-Ministerial post, in the Directorate of Settlement and Land Records, Government of Goa, namely:—

- 1. Short title, application and commencement.— (1) These rules may be called the Government of Goa, Directorate of Settlement and Land Records, Group 'B', Gazetted, Non-Ministerial post, Recruitment Rules, 2025.
- (2) They shall apply to the post specified in column (1) of the Schedule to these rules (hereinafter called as the "said Schedule").
 - (3) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number, classification and the level in the pay matrix.— The number of posts, classification of the said post and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the said Schedule:

Provided that the Government may vary the number of posts as specified in column (2) of the said Schedule from time to time subject to exigencies of work.

- 3. Method of recruitment, age limit and other qualifications.— The method of recruitment to the said post, age limit, qualifications and other matters connected therewith shall be as specified in columns (5) to (13) of the said Schedule.
- 4. Disqualification.— No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service:

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.— Where, the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Goa Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.— Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes, Other Backward Classes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Government from time to time in that regards.

These rules are issued in consultation with the Goa Public Service Commission conveyed vide its letter No. COM/II/13/29(1)/03/939 dated 23-09-2025.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and in supersession of the existing recruitment Rules for the post of Field Assistant, notified vide Government Notification No. 1/13/2005-PER dated 05-10-2005, published in the Official Gazette, Series I No. 27 dated 06-10-2005, the Governor of Goa hereby makes the following Rules to regulate the recruitment to the Group 'C', Non-Gazetted, Non-Ministerial post, in the Directorate of Agriculture, Government of Goa, namely:—

- 1. Short title, application and commencement.— (1) These Rules may be called the Government of Goa, Directorate of Agriculture, Group 'C', Non-Gazetted, Non-Ministerial post, Recruitment Rules, 2025.
- (2) They shall apply to the post specified in column (1) of the Schedule to these rules (hereinafter called as the "said Schedule").
 - (3) They shall come into force on the date of their publication in the Official Gazette.
- 2. *Number, classification and level in the pay matrix.* The number of posts, classification of the said post and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the said Schedule:

Provided that the Government may vary the number of posts specified in column (2) of the said Schedule from time to time subject to exigencies of work.

- 3. Method of recruitment, age limit and other qualifications.— The method of recruitment to the said post, age limit, qualifications and other matters connected therewith shall be as specified in columns (5) to (13) of the said Schedule.
- 4. *Disqualification.* No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service:

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.— Where the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.— Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes, Other Backward Classes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Government from time to time in that regard.

On the basis of the approval given by the Governing Council in its seventh and eighth Meeting held on 17-03-2025 and 13-08-2025 respectively, the Goa State Research Foundation (GSRF) is pleased to notify herewith Amendments to the Notification, published in the Official Gazette, Government of Goa (Series I, No. 24, dated 14th September, 2023) with reference to the following:

GSRF/Schemes/PDF/11/2023 GSRF Post-Doctoral Fellowship Scheme

The following sentence shall be added as the first sentence under clause V. *Pattern of Assistance*: "V. *Pattern of Assistance*.— In a given financial year, the number of new proposals sanctioned under the scheme shall not exceed 05."

The sub-clause (f) with all its sub-sub-clauses under clause VI. *Eligibility* stands deleted and shall be substituted with the following:

(f) The host institute can be any recognised and reputed Higher Educational Institute (HEI) or a National Research Institution in India.

The sub-clause (g) under clause VI. *Eligibility* stands deleted and shall be substituted with the following:

(g) The host institution shall not be the University from which PhD degree was obtained or its affiliated institutions or its recognised research centres or the institute where in the PhD work was actually carried out.

The first para under the clause IX (Procedure to release the fellowship/grants), stands deleted; and shall be substituted with the following:

IX. Procedure for release of fellowship/grants.— The Fellowship component will be disbursed on a six monthly basis, with the first instalment for six months, along with the Research Grant of Rs.1,00,000/- for one year, being released after receiving the joining letter from the Post-doctoral fellow to the host institution.

The second instalment of the fellowship for six months will be released on receiving a satisfactory progress report, utilisation certificate, and pre-receipt for Rs. 3.6 lakhs. The third six-month Fellowship along with the Research Grant for one year will be released at the beginning of the second year upon the receipt of the following documents: (i) Annual Progress Report; (ii) Annual Statement of Expenditure and Utilisation Certificate. The fourth six months fellowship will be released subject to receipt of the necessary submissions at the end of 18 months of the fellowship as was in the case after the completion of six months.
