JUDGEMENT

This judgment and order shall dispose of the proceedings initiated u/s 58A(2) of the Act against the Board of Directors of Sumit Province II Co-op. Housing Society Ltd., Dhavali, Ponda-Goa and the brief facts of this case are as under:-

That, 7 members of Sumit Province II Co-op. Housing Society Ltd., Dhavali, Ponda-Goa has moved a requisition dtd. 27-05-2025, addressed to the Chairman of the Sumit Province II Co-op. Housing Society Ltd., Dhavali, Ponda-Goa, to convene special general body meeting as provided in terms of Sec. 58A(1)(ii) of the Goa Co-operative Societies Act, 2001, vide letter dtd. 27.05.2025 specifying the agenda "inclusion of extra Rs. 3000/- in the quarterly bill since July 2024 and reasons behind the penalty charged on it in the subsequent quarterly maintenance bills".

That, taking the cognizance of the above requisition dtd. 27-05-2025, this office has issued direction to the society to call special general meeting as per the provision of the Act, Rules and bye-laws of the society vide letter dtd. 16-06-2025.

That in terms of Sec. 58A(1)(ii) "A special general body meeting may be called within one month from the date of submission of a requisition in writing to that effect by at least one-tenth of the total number of members of the society or by at least one-tenth of the total number of elected representatives or by such number as specified in the bye-laws for the purpose".

That, subsequently vide letter dtd. 31-07-2025, the two members of the society informed this office that the Board of Directors has failed to conduct the requisitioned special general body meeting and requested this office to take action against the members of the committee, as per the provision of the law.

That, in terms of Sec. 58A(2) "where, any officer or a member of the committee, whose duty is to call such meeting fails, without reasonable excuse, to call such meeting, the Registrar may, by order, declare such member as disqualified for being a member of the committee for such period not exceeding five years, as he may specify in such order or impose on such officer a penalty not exceeding one hundred rupees for each day of default. Before making an order under this sub-section, the Registrar shall give, or cause to be given, a reasonable opportunity to the person concerned for showing cause as to why the action proposed should not be taken against him."

That, taking the note of the letter dtd. 31-07-2025 for failure to convene the requisition general body meeting within one month, this office issued show cause notice for disqualification of entire Board of Directors in terms of Sec. 58A(2) and to submit their say in the matter.

That, the board of directors in their joint reply dtd. 6-08-2025 contended that the complainants have never personally or through post have served the letter for calling the requisitioned general body meeting though they are living in the same complex.

Further, as per the submission of the Board of Directors, they came to know the contents of the requisitioned general meeting dtd. 27-05-2025, only when the complainants have put up a photo of letter dtd. 16-06-2025 on society's whatsapp group and that too after the lapsation of the period of one month. From the above it is crystal clear that the intension of the complainants was to only get the Board of Directors to be disqualified and that is why they put up the letter on whatsapp group after lapsation of 30 days. If the complainants were really serious about convening the requisitioned general meeting, they would have served the said letter by personally or hand delivery, however they remained silent and only after lapsation of 30 days, put up this office letter dtd. 16-06-2025 on whatsapp group.

That, when this office had convened the requisitioned general body meeting by authorizing its own officer, the said requisitioned general meeting called on 14-08-2025 could not take place for want of quorum and therefore dissolved it in terms of bye-laws No. 96 of the society. The lack of presence by all the 7 members despite of their own request for requisitioned general meeting clearly shows that they are more particular in disqualifying the Board of Directors rather than attending the meeting.

That, this office vide letter dtd. 3-09-2025 has directed the complainants to produce the acknowledgement copy within the stipulated time period of 5 days, having delivered the copy of the requisitioned general meeting to the Chairman/Secretary. However, no copy of the acknowledgement has been produced before this authority. This fact goes on record to prove that the complainant have not served the notice of the requisitioned general meeting to the Chairman/Secretary personally nor by registered post. On the contrary, the complainants under his letter dtd. 06-09-2025 made an attempt to justify his stand stating that the Chairman/Secretary acknowledged the receipt of their letter dtd. 25-07-2025 inviting members for a special general body meeting which is not at all convincing and acceptable.

I have carefully examined the records relating to the disqualification issue having not convened the requisitioned general body meeting within one month from the date of submission of a requisition as specified in sub-section (2) of Section 58A of the Act, filed by the complainant and reply submitted by the Board of Directors to that effect and come to the conclusion that there is no concrete evidence produced by the complainant in the form of acknowledgment to hold Board of Directors responsible for non convening requisitioned general body meeting within the specified time limit. As such, Board of Directors have not committed any default on their part in convening the requisitioned general body meeting and therefore not liable for disqualification in terms of sub-section (2) of Section 58A of the Act. In these circumstances, I pass following order.

(iv) vide Notification No. 36/18/39A/Notification(14)/TCP/2024/67 dated 31-12-2024 published in the Official Gazette, Series III No. 40 dated 02-01-2025 (as regards proposal at Sr. No. 4 & 5); and suggestions were invited from the public within a period of thirty days from the date of publication to the said Notifications in the Official Gazette.

And whereas, suggestions received from public were placed before the Goa Town and Country Planning Board in terms of sub-rules (3) of Rule 4 for its recommendation/approval and the Goa Town and Country Planning Board after due consideration of the suggestions received from the public recommended the proposals for change of zone as regards to Sr. No. 1 in its 215th meeting held on 04-06-2025, Sr. No. 2 in its 211th meeting held on 15-01-2025, Sr. No. 3 in its 219th meeting held on 30-09-2025, Sr. No. 4 & 5 in its 216th meeting held on 13-06-2025, and directed to take further action as per sub-rule (4) of Rule 4 of the said Rules:

And whereas, as required by sub-rule (4) of Rule 4 of the said Rules, the recommendation/approval/decision of the Goa Town and Country Planning Board along with the said proposals were placed before the Government for its decision and the Government has approved the same;

Now, therefore, in view of the recommendation of the Goa Town and Country Planning Board being approved by the Government and in exercise of the powers conferred by Section 39A of the Goa Town and Country Planning Act, 1974 (Act 21 of 1975) read with sub-rule (5) of Rule 4 of the Goa Town and Country Planning (Change of zone of land in the Regional Plan or the Outline Development Plan) Rules, 2024, the Regional Plan and the Outline Development Plan is hereby altered and modified as specified in column No. (8) of above Table and as directed by the Government for carrying out change of zone of land in respect of the plots of land as specified in detail in column Nos. (2) to (7) of above Table.

The alteration and modification of the Regional Plan and the Outline Development Plan as notified in this Notification shall be subject to the outcome of the PIL Writ Petition Nos. 53 of 2024 and 54 of 2024 which are pending final disposal before the Hon'ble High Court of Bombay at Goa.
