Sub: Directives for implementation of "Swasth Nari, Sashakt Parivar Abhiyaan" – A Nationwide Health Mission for Women and Adolescent Girls.

The Hon'ble Prime Minister of India, in his address to the nation on 17th September, 2025, launched a historic health campaign titled "Swasth Nari, Sashakt Parivar Abhiyaan" (Healthy Women, Empowered Family Campaign). This landmark initiative is an integral part of the national mission Viksit Bharat 2047, with the objective of building a healthy, empowered and prosperous India.

The Hon'ble Prime Minister underlined that a healthy mother is the foundation of a healthy family and a healthy family builds a strong nation. Women, being the strength of families and the torchbearers of society, must receive timely healthcare and preventive support. This Abhiyaan ensures that no woman or adolescent girl is left behind due to lack of awareness, diagnosis or access to medical facilities.

The Abhiyaan is being implemented on a nationwide scale focusing on both preventive care and curative health services. The salient features are as follows:

- i. Universal Free Health Services: Free check-ups, consultations, medicines and follow-ups at government health centers and hospitals.
- ii. Preventive Care & Early Diagnosis: Targeting common but serious health issues such as anemia, diabetes, hypertension, cancer and arthritis.
- iii. Holistic Wellness: Incorporating mental health, adolescent health, nutrition, gender equity and lifestyle awareness.
- iv. Specialist Medical Services: Expert doctors in gynecology, pediatrics, psychiatry, ophthalmology, etc., mobilized through medical colleges, district hospitals and partner institutions.

- v. Community-Led Movement: Driven by ASHAs, ANMs, Anganwadi workers, SHGs, Cooperative Societies and volunteers to reach the grassroots level.
- vi. National Jan Andolan (People's Movement): Strong support from public representatives, institutions and civil society organizations making it a mass movement for women's empowerment.

Accordingly, all Cooperative Societies, Self-Help Groups (SHGs), Federations and affiliated institutions under the Department are hereby directed to widely publicize the objectives of the campaign among members and the local community, mobilize women and adolescent girls to participate in the free health check-ups at their nearest government health facilities, collaborate actively with Panchayats, Health Officers, ASHA//ANM workers and Anganwadi centers for field-level outreach, conduct awareness sessions, health talks and local campaigns within their area of operation thereby encouraging family support so that women and adolescent girls are motivated and facilitated to attend and submit to this Department a report of awareness and mobilization activities within 30 days for monitoring and record.

This Abhiyaan is not just a programme but a collective mission of empowerment, health and national progress. Co-operative societies and Self Help Groups being close to its members are expected to play a pivotal role in its success by ensuring maximum participation of women and adolescent girls.

All the Co-operative Societies are requested to extend wholehearted support and cooperation so that together we can transform this campaign into a true movement of "Swasth Nari, Sashakt Parivar and Viksit Bharat".


