The following draft Rules which the Government of Goa propose to make in exercise of the powers conferred by Section 15 and sub-section (2) of Section 125 read with sub-section (1) of the Section 240 of the Goa Panchayat Raj Act, 1994 (Goa Act 14 of 1994), so as to further amend the Goa Panchayat and Zilla Panchayat (Election Procedure) Rules, 1996, are hereby pre-published as required by sub-section (1) of Section 240 of the said Act for the information of the persons likely to be affected thereby and notice is hereby given that the said draft Rules will be taken into consideration by the Government after the expiry of period of seven days from the date of publication of this Notification in the Official Gazette.

All objections and/or suggestions to the said draft Rules may be forwarded to the Director of Panchayats and Ex-Officio Joint Secretary to the Government of Goa, 5th floor, Myles High, Corporate Hub, Patto, Panaji, Goa before the expiry of said period of seven days so that they may be taken into consideration at the time of finalization of the said draft Rules.

DRAFT RULES

In exercise of the powers conferred by section 15 and sub-section (2) of Section 125 read with sub-section (1) of Section 240 of the Goa Panchayat Raj Act, 1994 (Goa Act 14 of 1994) and all other powers enabling it in this behalf, the Government of Goa hereby makes the following rules so as to further amend the Goa Panchayat and Zilla Panchayat (Election Procedure) Rules, 1996, namely:—

- 1. Short title and commencement.— (1) These rules may be called the Goa Panchayat and Zilla Panchayat (Election Procedure) (Eight Amendment) Rules, 2024.
 - (2) They shall come into force on the date of their final publication in the Official Gazette.

2. Amendment of rule 20.— In rule 20 of the Goa Panchayat and Zilla Panchayat (Election Procedure) Rules, 1996, in sub-rule (1), for the expression "(4) Ball (5) Camera (6) Car (7) Desk (8) Door (9) Envelope (10) Fire Engine (11) Flute (12) Frying Pan (13) Gas Cylinder (14) Gas Stove (15) Hanger (16) Hat (17) Ink Pot and Pen (18) Jeep (19) Kite (20) Lock and Key (21) Pressure Cooker (22) Railway Engine (23) Road Roller (24) Sewing Machine (25) Stool (26) Table Lamp (27) Television (28) Violin (29) Walking Stick (30) Whistle", the expression "(4) Camera (5) Car (6) Desk (7) Door (8) Envelope (9) Fire Engine (10) Flute (11) Frying Pan (12) Gas cylinder (13) Gas stove (14) Hanger (15) Hat (16) Ink Pot and Pen (17) Jeep (18) Kite (19) Lock and Key (20) Pressure Cooker (21) Railway Engine (22) Road Roller (23) Sewing Machine (24) Stool (25) Table Lamp (26) Television (27) Violin (28) Walking Stick (29) Whistle" shall be substituted.
