INQUIRY REPORT

 $(02^{nd} \text{ May}, 2025)$

The complaint dated 23-07-2024 was received from the Complainants who are some of the parents of children of Vidya Prabodhini School, Porvorim, in respect of shifting of the classes of the primary section to a new building near the Penha-de-Franca Garbage Plant, in a polluted atmosphere and to initiate action for violation of human rights.

- 2. On perusing the complaint, the Commission by Order dated 27-4-2024 issued notices to the Respondents No. 1 and No. 2 calling for their replies.
 - 3. The Respondent No. 2, filed their reply on 19-08-2024.
- 4. Subsequently, Respondent No. 1, filed their reply on 27-09-2024, on which date, the Complainant filed the Rejoinder.
- 5. On the same date, the Respondents No. 3 and No. 4 were added as parties and notices were issued to them calling for their replies.
- 6. The Respondent No. 3 filed their reply on 14-01-2025, and Respondent No. 4 filed a Memo, producing two Inspection Reports.
 - 7. Thereafter, the Complainants filed their further Rejoinder on 11-04-2025.
- 8. The Commission heard learned Adv. Ms. S. Bandodkar, for the Complainants, learned Adv. Shri Sachin Dessai for Respondent No. 1 and learned Adv. Shri Goculdas Naik for Respondent No. 3.
- 9. Learned Adv. Ms. S. Bandodkar, argued that the human rights of the children of the primary school are affected by the foul smell from the MRF shed near the School.
- 10. Learned Adv. Shri Sachin Dessai, for the Respondent No. 2, contended that the school authorities have taken steps to resolve the grievances of the parents.
- 11. Learned Adv. Shri Goculdas Naik for the Village Panchayat submitted that they are segregating the dry garbage at the MRF plant.
- 12. The Commission has gone through the Complaint, replies of the Respondents and has considered the documents on record and the arguments advanced.
- 13. The grievance of the Complainants is that their children were shifted from June 2024 to the new building of the Respondent No. 2 at Porvorim, next to the Garbage treatment plant, and in a polluted atmosphere.
- 14. The Respondent No. 2, stated that they were allotted the plot by Housing Board of Goa, in the year 2004 and presently the school building has been completed in all respects at the cost of Rs. 2,00,00,000/- (Rupees two crores only) and the Town and Country Planning Department has issued the Completion Order, dated 26-04-2024. So also, the NOC was issued by the Directorate of Health Services, after which the Occupancy Certificate was issued by the Penha-de-Franca Panchayat.
- 15. The Respondent No. 2, stated that the Material Recovery Facility (MRF) has been erected by the Village Panchayat, after the High Court of Bombay had directed all the Village Panchayats to create facilities for segregation of waste.

- 16. The Respondent No.1, had stated that they had granted the permission to Respondent No. 2 by the letter dated 16-07-2024, to shift the primary school section to the new premises.
- 17. The Respondent No. 3 stated that to set up a garbage plant they entered into an Agreement, dated 31-07-2013, with the Goa Housing Board, who allotted the area of 1000 sq.mtr. under Survey No. 120/1 at Porvorim for garbage segregation.
- 18. They have stated that the garbage is segregated at the Material Recovery Facility and the wet waste is sent to the Saligao plant.
- 19. The Respondent No. 4 had produced 2 Inspection Reports dated 30-09-2024 and 10-12-2024, along with the photographs showing the garbage littered all over the place.
- 20. The Commission has gone through the Inspection Reports dated 30-09-2024 and 10-12-2024, after the inspections were carried out by the Goa State Pollution Control Board.
 - 21. The first inspection was held on 30-09-2024 and they have observed as under:-
 - "1) The Penha de Franca Village Panchayat has constructed an MRF shed of Approx. area 150 sq. mt. located at Sy. No. 120/1, Penha de Franca, Bardez-Goa.
 - 2) The Said MRF shed is located exactly opposite of newly constructed Vidya Prabodhini School premises and separated by a common road of 6m. wide.
 - 3) The MRF shed constructed is not covered from all the sides and also no separate compartments are provided.
 - 4) All the dry waste stored was littering and even scattered all over and also outside the MRF shed.
 - 5) A very strong foul smell was emanating at the MRF shed. However, no foul smell was emanating at the entrance of Vidya Prabodhini School premises.
 - 6) The wet waste in the form of vegetable waste, kitchen waste, restaurant waste and fish waste was also seen scattered on the ground all over the plot which indicates that the wet waste is also handled within the plot by the Contractor.
 - 7) Traces of leachate flowing was also seen during inspection..."
 - 22. In the same report, the Conclusion drawn is as under:-
 - "1) No proper handling storage and segregation of dry waste is done. All the dry waste stored was littering and even scattered all over and outside the MRF shed.
 - 2) The wet waste in the form of vegetable waste, kitchen waste, restaurant waste and fish waste was also seen scattered on ground all over the plot which indicates that the wet waste is also handled within the plot by the Contractor.
 - 3) Traces of leachate flowing was also seen during inspection.
 - 4) A very strong foul smell was emanating at the MRF shed. However, no foul smell was emanating at the entrance of Vidya Prabodhini School premises."
- 23. The said MRF shed was inspected on 19/07/2024 and based on the finding of the inspection report, the Board had issued Directions to the Village Panchayat Penha de Franca vide order dated 26/07/2024 for violating the conditions No. 2, 3, 4, 5 and 6 of the approval for operation of MRF granted by the Board vide order dated 04/08/2021 and also directed the Panchayat to pay a fine of Rs. 10,000/- towards the Environmental Compensation as per condition No.20 mentioned in the said approval.
- 24. The Village Panchayat Penha de Franca had replied to the Directions issued by the Board vide letter dated 01/08/2024 and requested the Board to grant a time period of 6 months for carrying out the due procedure like removing tenders, inviting quotations, sending letters/correspondence to the Directorate of Panchayats/BDO, Goa, for taking necessary approvals of the said MRF shed. However, the Panchayat has not yet paid the fine of Rs. 10,000/- imposed by the Board.

- 25. The second inspection was held on 10-12-2024 and the observations were as under:-
- "1) The Penha de Franca Village Panchayat has constructed an MRF shed of Approx. area 150 sq. mt located at Sy. No. 120/1, Penha de Franca, Bardez, Goa.
- 2) The said MRF shed is located exactly opposite of newly constructed Vidya Prabodhini School premises and separated by a common road of 6m. width.
- 3) The MRF shed constructed is not covered from all the sides and also no separate compartments are provided.
- 4) All the dry waste stored was littering and even scattered all over and outside the MRF shed.
- 5) Scattered traces of waste such as vegetable waste, kitchen waste, restaurant waste seen at the MRF shed which the contractor informed that small amount of wet waste comes along with dry waste.
- 6) C&D waste was also seen disposed at the site."
- 26. In the same report, the Conclusions drawn by the Engineer were as under:-
- "1) No proper handling storage and segregation of dry waste is done. All the dry waste stored was littering and scattered all over.
- 2) Traces of wet waste were seen at the site indicating that segregation at source is not properly done.
- 3) The MRF shed constructed is not covered from all the sides and also no separate compartments are provided.
- 4) The wet waste collected is directly disposed through the GWMC."
- 27. The directions they issued were as under:-
- "1) Stop handling mixed waste (biodegradable/non-biodegradable waste) at the authorized MRF site.
- 2) Find an alternate access to the MRF shed.
- 3) Transport all the collected waste to the said waste management facility at Saligao until an alternate location is identified."
- 28. The Commission agrees with the learned Advocates for the Complainant and the Respondent No. 2, that the above 2 Inspection Reports of the Goa State Board Pollution Control Board, bring out that the Village Panchayat of Penha de Franca, has not been properly handling the segregation of the waste, resulting in environmental pollution in the vicinity, for which the G.S.P.C.B. also directed the Panchayat to pay the compensation of Rs. 10,000/- (Rupees Ten thousand only).
- 29. In the facts of the present case, the Commission agrees with the learned Advocates for the Complainant and Respondent No. 2 that it is necessary to recommend that the Respondent No. 3 stop handling mixed waste (biodegradable/non-biodegradable waste) at the authorized MRF site and to transport all the mixed waste to the Waste Management Facility at Saligao. Only the dry waste be brought to the MRF site for further processing. The Respondent No. 3 to instruct the Contractor of the garbage collectors not to collect the dry waste if found to be mixed with the wet waste. The directions of the Goa State Pollution Control Board Reports, dated 30-09-2024 and 10-12-2024 be strictly complied with. The Goa State Pollution Control Board to monitor the MRF site and to inspect the same every 15 days and issue directions, as necessary to the Respondent No. 3.
- 30. Under Section 18(e) of the Protection of Human Rights Act, 1993, the Commission shall send a copy of the Inquiry Report together with its recommendations to the concerned Government or authority and they shall, within a period of one month or such further time as the Commission may allow, forward its comments on the report, including the action taken or proposed to be taken, to the Commission.

31. Copy of the Inquiry Report be sent to the Respondent No. 3, the Village Panchayat of Penha de Franca and to the Respondent No. 4, the Goa State Pollution Control Board, calling for their comments, including the action taken or proposed to be taken within a period of 30 days or on or before 02-06-2025, in terms of Section 18(e) of the Protection of Human Rights Act, 1993.

And whereas, I am also to inform your kind authority that MRF shade area is fenced with Tata Sheets on compound wall, further Dry Waste is bailed and sent to the Cement Factory and Wet waste is directly sent to the solid Waste Management Plant, Saligao Plant, for safe disposal. (18th July, 2025)

The complaint dated 21-05-2025, was received from the Complainant.

- 2. On perusing the complaint, the Commission by Order dated 22-05-2025, issued notice to the Respondents calling for their replies.
- 3. The Respondents No. 1 and No. 2, filed their reply dated 02-06-2025 and no reply was filed by the Respondent No. 3.
 - 4. Subsequently, the Complainant filed his further reply on 26-06-2025.
- 5. The Commission has heard the Complainant in person and heard Shri O. Pais, Assistant Engineer, present on behalf of the Respondents No. 1 and No. 2.
- 6. The Commission has gone through the complaint, reply of the Respondents, the documents on record and has considered the submissions of both parties.
- 7. The case of the Complainant is that the PWD had laid the new pipeline and were to shift the existing water connection to the new pipeline but there were objections in digging the public road by the nearby residents and no help was provided by the Police.
- 8. The Respondent No. 2 had stated that there is one water connection for H. No. 686, at Badem-Chapora, in the name of Rohidas Jagadish Naik, and they were to shift the said water connection to the new line but there were objections of the local residents. They stated that they are ready to restore the water supply of Shri Rohidas Naik, by laying service connection provided the applicant makes hindrance free land available.
- 9. In his further reply, the Complainant stated that the property from where the pipeline was proposed to the house of the Complainant is neither private nor disputed and the property is a public road starting from the main tar road to the house of the Complainant. The Complainant produced a copy of the Plan filed in the Mundkar case No. MND/SR-16(1)Assagao/09/2023, showing the public access, on the North of Survey No. 59/3 and Survey No. 59/1 (Part).

- 10. The Commission agrees with the Complainant that in the absence of the proper water supply to the house of the Complainant, there will be the violation of his Human Rights.
- 11. In the facts of the present case, the Commission recommends that the Respondent No. 1 and No. 2 lay the new pipeline from the house of the Complainant upto the new line provided by the PWD, and shift the existing service connection in the name of Rohidas Jagadish Naik to the new line within 30 days from today. The costs to be paid by the Complainant in accordance with the law.
- 12. The Police Inspector, Anjuna Police Station, Respondent No. 3 shall provide the Police protection to the Complainant and Respondent No. 1 and 2, while laying the new pipeline along the side of the existing Public road on the North of Survey No. 59/3 and 59/1(Part), leading to the H. No. 686, of the Complainant, provided that there is no Court Order in respect of the digging of the said public road. The Complainant to deposit the costs for providing police protection, with Respondent No. 3.
- 13. Under Section 18(e) of the Protection of Human Rights Act, 1993, the Commission shall send a copy of the Inquiry Report together with its recommendations to the concerned Government or authority and they shall, within a period of one month or such further time as the Commission may allow, forward its comments on the report, including the action taken or proposed to be taken, to the Commission.
- 13. Copy of the Inquiry Report be sent to the Respondents No. 1, 2 and 3, calling for their comments, including the action taken or proposed to be taken within a period of 30 days or on or before 20-08-2025, in terms of Section 18(e) of the Protection of Human Rights Act, 1993.

And whereas suggestions received from public were placed before the Goa Town and Country Planning Board in terms of sub-rules (3) of Rule 4 for its recommendation/approval and the Goa Town and Country Planning Board after due consideration of the suggestions received from the public recommended the proposals for change of zone as regards to Sr. No. 1 & 2 in its 215th meeting held on 04-06-2025, Sr. No. 3 in its 212th meeting held on 03-02-2025, Sr. No. 4 in 219th Meeting held on 30-09-2025 and Sr. No. 5 in 217th meeting held on 29-07-2025 and directed to take further action as per sub-rule (4) of Rule 4 of the said Rules:

And whereas, as required by sub-rule (4) of Rule 4 of the said Rules, the recommendation/approval/decision of the Goa Town and Country Planning Board along with the said proposals were placed before the Government for its decision and the Government has approved the same;

Now, therefore, in view of the recommendation of the Goa Town and Country Planning Board being approved by the Government and in exercise of the powers conferred by Section 39A of the Goa Town and Country Planning Act, 1974 (Act 21 of 1975) read with sub-rule (5) of Rule 4 of the Goa Town and Country Planning (Change of zone of land in the Regional Plan or the Outline Development Plan) Rules, 2024, the Regional Plan and the Outline Development Plan is hereby altered and modified as specified in column No. (8) of above Table and as directed by the Government for carrying out change of zone of land in respect of the plots of land as specified in detail in column Nos. (2) to (7) of above Table.

The alteration and modification of the Regional Plan and the Outline Development Plan as notified in this Notification shall be subject to the outcome of the PIL Writ Petition Nos. 53 of 2024 and 54 of 2024 which are pending final disposal before the Hon'ble High Court of Bombay at Goa.
