Subject: Release of an additional Installment of Dearness Relief (DR) to Central Government pensioners/family pensioners revised rate with effective from 01-07-2025–reg.

The undersigned is directed to refer to this Department's OM No. 42/02/2024-P&PW(D) dated 11-04-2025 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government Pensioners/Family Pensioners shall be enhanced from

the existing rate of 55% to 58% of the basic pension/family pension (including additional pension/family pension) w.e.f. 01st July, 2025.

- 2. These rates of DR will be applicable to the following categories:—
- (i) Civilian Central Government Pensioners/Family Pensioners including Central Government absorbee pensioners in PSU/Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D)Vol. II dated 23-06-2017 for restoration of full pension after expiry of commutation period of 15 years.
- (ii) The Armed Forces Pensioners/Family Pensioners and Civilian Pensioners/Family Pensioners paid out of the Defence Service Estimates.
 - (iii) All India Service Pensioners/Family Pensioners.
 - (iv) Railway Pensioners/Family Pensioners.
 - (v) Pensioners who are in receipt of provisional pension.
- (vi) The Burma Civilian Pensioners/Family Pensioners and Pensioners/Families of displaced Government pensioners from Burma/Pakistan, in respect of whom orders have been issued vide this Department's O. M. No. 23/3/2008-P&PW(B) dated 11-09-2017.
- 3. The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 4. Other provisions governing grant of DR in respect of employed family pensioners and re-employed Central Government Pensioners will be regulated in accordance with the provisions contained in Rule 52 of CCS (Pension) Rules, 2021 and this Department's O. M. No. 45/73/97-P&PW(G) dated 2-7-1999 as amended from time to time. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.
- 5. In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.
- 6. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.
- 7. The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of Dearness relief to Pensioners/Family Pensioners on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528-TA,II/34-80-II dated 23-04-1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL)/81 dated the 21st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.
- 8. In so far as the persons serving in Indian Audit and Accounts Department are concerned, these orders are issued in consultation with the Comptroller and Auditor General of India, as mandated under Article 148 (5) of the Constitution of India.
- 9. This issues in accordance with the Ministry of Finance, Department of Expenditure's O.M. No. 1/4(i)/2025-E.II(B) dated 06-10-2025.

Subject: Policy for Usage of Government Land for Installation of Mobile Towers and Allied Telecom Infrastructure in the State of Goa

In view of the growing need for robust telecommunications infrastructure and in alignment with the *Right of Way (RoW) Rules, 2024*, the Government of Goa hereby notifies the following policy and fee structure for the installation of Ground-Based Towers (GBT), Rooftop Towers (RTT), Ground-Based Masts (GBM), and Telecom Poles on government land across urban and rural areas of Goa.

This notification shall apply to all telecom service providers, infrastructure providers, and entities duly licensed by the Department of Telecommunications (DoT) seeking to establish mobile towers and related infrastructure on government-owned land and buildings in Goa.

In accordance with Section 9(2)(b) of the Telecommunications (Right of Way) Rules, 2024, compensation shall be paid for the use of public property for the establishment of telecom networks, based on rates determined by the concerned public authority.

- **Penalty for Unauthorized Installations**: 25% penalty for regularization within 30 days; 50% penalty thereafter.
- **Renewal**: After five years, charges increase by 50% upon renewal.

5. Sharing and Co-location Policy

- Multiple operators may share a tower with no additional land rent, but must register their tenancy.
- Rent shall be split proportionally among co-tenants, with one operator designated as the nodal licensee.

6. Permissions and Timeline for procession RoW applications

Step 1: Application Submission

• Facility Provider (FP) submits the application on the Central ROW eService Portal.

Step 2: Application Examination by State Designated Department (SDD)

- SDD reviews the application for correctness and completeness.
- Within 5 days application will be transfer to concerned land owning department.

Step 3: Concerned land owning department:

- Within 20 Days on receipt of application from SDD may review the details of application & documents submitted by FP and if application is Okay they process the application and recommend the SDD to issue the permission within 50 days.
- And If Application is Not Okay, request SDD to seek clarification from Facility Provider (FP).

Step 4: State Designated Department (SDD):

• If any request from land owning department to seek more clarification then SDD will request FP to submitted required information within 15 days from date of request only once.

Step 6: Facility Provider (FP):

• FP must submit the BG with details as clarification or requested information.

Step7: State Designated Department (SDD):

- Information Submitted by FP if found Okay then process the application and issue permission on recommendation of land owning department.
- If application is NOT Okay, initiate intent to reject by informing FP of the reason within 45 days.
- After 60 days, if the application is still not resolved, SDD must take a decision on rejection within 7 days with reasons through Central RoW eService portal.
- If no reply is received from FP within 15 days, the application moves toward rejection.
- If application is Okay and land owning department recommend to issue permission then SDD will issue permission on completion of process through Central RoW eService Portal.
- If the SDD does not take any action within 67 days, the application is treated as having automatic deemed permission.
- SDD has to generate a letter with terms and conditions within the next 7 days to grant permission.
- After the work is completed and restoration is verified, the Bank Guarantee (BG) will be returned to FP within 30 days.

7. Infrastructure Compliance

All installations must comply with:

- EMF exposure norms by DoT/TRAI
- Local building and fire safety codes
- Environment protection guidelines (where applicable)

8. Restoration and Exit

- In case of decommissioning, the site shall be restored to its original state.
- Restoration cost, if any, shall be adjusted from the security deposit.

9. Exemptions and Incentives

- Installations in rural or uncovered areas may receive up to 50% rebate on rental charges for the first 3 years.
- BSNL/PSUs deploying towers under central government connectivity schemes shall be exempt from rental charges.

10. Effective Date

This policy shall come into effect from date of notification and shall remain valid until amended or superseded.

THE MANIPUR GOODS AND SERVICES TAX (SECOND AMENDMENT) ORDINANCE, 2025 No. 2 of 2025

Promulgated by the President in the Seventy-sixth year of the Republic of India.

An Ordinance further to amend the Manipur Goods and Services Tax Act, 2017.

Whereas the provisions of the Central Goods and Services Tax Act, 2017 were amended through sections 121 to 134 of the Finance Act, 2025;

And whereas similar amendments were required to be made in the Manipur Goods and Services Tax Act, 2017 to avoid repugnancy with the Central Act;

And whereas the respective amendments were to be carried out in the Manipur Goods and Services Tax Act, 2017 so as to bring them into effect at the earliest, as per the decision of the 56th GST Council;

And whereas by a proclamation issued on the 13th February, 2025 by the President under Article 356 of the Constitution, the powers of the Legislature of the State of Manipur have been declared to be exercisable by or under the authority of Parliament;

And whereas Parliament has approved the resolution for continuance in force of the said proclamation for a further period of six months with effect from the 13th August, 2025;

And whereas Parliament is not in session and the President is satisfied that circumstances exist which render it necessary for her to take immediate action;

Now, therefore, in exercise of the powers conferred by clause (1) of article 123 of the Constitution, the President is pleased to promulgate the following Ordinance:—

1. (1) This Ordinance may be called the Manipur Goods and Services Tax (Second Amendment) Ordinance, 2025

Short title and commencement.

- (2) Save as otherwise provided in this Ordinance, Sections 2 to 5, 7 to 13 and 15 shall come into force on such date as the State Government may, by notification in the Official Gazette, appoint.
- Manipur Act 3 of 2017.
- 2. In the Manipur Goods and Services Tax Act, 2017 (hereinafter referred to as the principal Act), in Section 2,—

Amendment of Section 2.

13 of 2017.

- (a) in clause (61), after the word and figure "Section 9", the words, brackets and figures "of this Act or under sub-section (3) or sub-section (4) of Section 5 of the Integrated Goods and Services Tax Act, 2017" shall be inserted and shall be deemed to have been inserted with effect from the 1st day of April, 2025:
 - (b) in clause (69),—
 - (i) in sub-clause (c), for the words "management of a municipal or local fund;", the words "management of a local fund or municipal fund." shall be substituted;
 - (*ii*) after sub-clause (*c*), the following *Explanation* shall be inserted, namely:—
 - *'Explanation.*—For the purposes of this sub-clause,—
 - (a) "local fund" means any fund under the control or management of an authority of a local self-government established for discharging civic functions in relation to a Panchayat area and vested by law with the powers to levy, collect and appropriate any tax, duty, toll, cess or fee, by whatever name called;
 - (b) "municipal fund" means any fund under the control or management of an authority of a local self-government established for discharging civic functions in relation to a Metropolitan area or Municipal area and vested by law with the powers to levy, collect and appropriate any tax, duty, toll, cess or fee, by whatever name called;";

- 7. In Section 34 of the principal Act, in sub-section (2), for the proviso, the following proviso shall be substituted, namely:—

Amendment of section 34.

- "Provided that no reduction in output tax liability of the supplier shall be permitted, if the
 - (i) input tax credit as is attributable to such a credit note, if availed, has not been reversed by the recipient, where such recipient is a registered person; or

- (ii) incidence of tax on such supply has been passed on to any other person, in other cases.".
- 8. In Section 38 of the principal Act,—

Amendment of Section 38.

- (a) in sub-section (1), for the words "an auto-generated statement", the words "a statement" shall be substituted;
 - (b) in sub-section (2),—
 - (i) for the words "auto-generated statement under", the words "statement referred in" shall be substituted;
 - (ii) in clause (a), the word "and" shall be omitted;
 - (iii) in clause (b), after the words "by the recipient,", the word "including" shall be inserted;
 - (iv) after clause (b), the following clause shall be inserted, namely:—
 - "(c) such other details, as may be prescribed.".
- 9. In Section 39 of the principal Act, in sub-section (1), for the words "and within such time", the words "within such time, and subject to such conditions and restrictions" shall be substituted.

Amendment of Section 39.

10. In Section 107 of the principal Act, in sub-section (6), for the Amendment of proviso, the following proviso shall be substituted, namely:—

Section 107.

"Provided that in case of any order demanding penalty without involving demand of any tax, no appeal shall be filed against such order unless a sum equal to ten per cent. of the said penalty has been paid by the appellant.".

11. In section 112 of the principal Act, in sub-section (8), the following proviso shall be inserted, namely:—

Amendment of Section 112.

"Provided that in case of any order demanding penalty without involving demand of any tax, no appeal shall be filed against such order unless a sum equal to ten per cent. of the said penalty, in addition to the amount payable under the proviso to sub-section (6) of Section 107 has been paid by the appellant.".

12. After Section 122A of the principal Act, the following section shall be inserted, namely:—

Insertion of new Section 122B.

"122B. Notwithstanding anything contained in this Act, where any person referred to in clause (b) of sub-section (1) of Section 148A acts in contravention of the provisions of the said section, he shall, in addition to any penalty under Chapter XV or the provisions of this Chapter, be liable to pay a penalty equal to an amount of one lakh rupees or ten per cent. of the tax payable on such goods, whichever is higher.".

Penalty for failure to comply with track and trace mechanism.

13. After section 148 of the principal Act, the following section shall be inserted, namely:—

Insertion of new Section 148 A.

"148A. (1) The Government may, on the recommendations of the Council, by notification, specifyTrack and trace mechanism for certain goods.

- (a) the goods;
- (b) persons or class of persons who are in possession or deal with such goods,

to which the provisions of this section shall apply.

- (2) The Government may, in respect of the goods referred to in clause (a) of sub-section (1),—
 - (a) provide a system for enabling affixation of unique identification marking and for electronic storage and access of information contained therein, through such persons, as may be prescribed; and
 - (b) prescribe the unique identification marking for such goods, including the information to be recorded therein.
 - (3) The persons referred to in sub-section (1) shall—
 - (a) affix on the said goods or packages thereof, a unique identification marking, containing such information and in such manner:
 - (b) furnish such information and details within such time and maintain such records or documents, in such form and manner:
 - (c) furnish details of the machinery installed in the place of business of manufacture of such goods, including the identification, capacity, duration of operation and such other details or information, within such time and in such form and manner;
 - (d) pay such amount in relation to the system referred to in sub-section (2),

as may be prescribed.".

14. In Schedule III to the principal Act, with effect from the Amendment of 1st day of July, 2017,—

Schedule III.

- (i) in paragraph 8, after clause (a), the following clause shall be inserted and shall be deemed to have been inserted, namely:—
 - "(aa) supply of goods warehoused in a Special Economic Zone or in a Free Trade Warehousing Zone to any person before clearance for exports or to the Domestic Tariff Area;";
- (ii) in Explanation 2, after the words "For the purposes of", the words, brackets and letter "clause (a) of" shall be inserted and shall be deemed to have been inserted;
- (iii) after Explanation 2, the following Explanation shall be inserted and shall be deemed to have been inserted, namely:-

28 of 2005

'Explanation 3.— For the purposes of clause (*aa*), the expressions "Special Economic Zone", "Free Trade Warehousing Zone" and "Domestic Tariff Area" shall have the same meanings as respectively assigned to them in section 2 of the Special Economic Zones Act, 2005.'.

15. No refund shall be made of all such tax which has been No refund of tax collected, but which would not have been so collected, had section collected 14 been in force at all material times.

The Goa State Legal Services Authority and the Members of the Staff on the Establishment

(Recruitment and Conditions of Services Rules, 2024)

In exercise of the powers conferred by Section 28(1) and (2) of The Legal Services Authorities Act, 1987, the State Government in consultation with the Chief Justice of the High Court hereby makes the following rules to regulate the method of recruitment and other conditions of service of the Officers and members of The Goa State Legal Services Authority and High Court Legal Services Committee the staff serving on the Establishment of the Goa State Legal Services Authority and all other matters incidental thereto.

1. Short title, application and commencement.— (1) These rules may be called the Goa State Legal Services Authority, Porvorim, Goa of Group B Gazetted officer and Group C (Non Gazetted) Members of the Staff on the establishment of Goa State Legal Services Authority (Recruitment and Conditions of Service) Rules, 2024.

- (2) These Rules shall apply to the post specified in Column (2) of the Schedule to these Rules (hereafter called as the "Said Schedule").
 - (3) These Rules shall come into force from the date of their publication in the Official Gazette.
 - 2. Definitions.— In these rules unless the context otherwise requires—
 - (a) "The Chief Justice" and Patron in Chief: means The Chief Justice of the High Court of Bombay.
 - (b) "Degree in Law": means a Degree qualifying the holder for enrollment as an Advocate under the Advocates Act, 1961 (Central Act 25 of 1961);
 - (c) "Duty": a person is said to be 'on duty' as a member of the service; (i) When he is performing the duties of a post borne on the cadre of the service, or is undergoing the probation; or (ii) When he is on joining time; or (iii) When he is absent from duty during vacation, or on authorized holidays, or on casual leave taken in accordance with the rules or instructions regulating such leave, having been on duty immediately before and immediately after such absence.
 - (d) "Direct Recruit" or "Nominee" means a candidate who at the time of his first appointment to the establishment of The Goa State Legal Service Authority, is not already appointed to the service of Goa State Legal Service Authority.
 - (e) "Deputation" means temporary transfer or borrowing the services of an officer or other employees from the District Judiciary in the State of Goa to the establishment of Goa State Legal Services Authority.
 - (f) "Establishment" means and includes all Offices, Departments, Sections, Branches of the Goa State Legal Services Authority.
 - (g) "Government" means the Government of Goa.
 - (h) "GSLSA" means The Goa State Legal Services Authority.
 - (i) "High Court Legal Services Committee" means a High Court Legal Services Committee as defined under Section 8A of The Legal Services Authorities Act, 1987.
 - (j) "State Legal Services Authority" means The Goa State Legal Services Authority.
 - (*k*) "Other Backward Classes" means such backward classes of citizens other than Scheduled Castes and Scheduled Tribes as may be prescribed by the Goa State Government from time to time.
 - (*l*) "Scheduled Caste" and "Scheduled Tribe" shall have the same meaning are assigned to them by clauses (24) and (25), respectively of Article 366 of the Constitution of India.
 - (m) "Scheduled" means schedule appended to these rules.
- 3. Appointing Authority.— The Appointing and disciplinary Authority for all categories of Gazetted Group-B, Non-Gazetted and Group C Posts shall be the Member Secretary. However the Member Secretary shall exercise the powers to issue the appointment orders subject to the approval and overall control of the Executive Chairman and The Chief Justice and Patron-in-Chief of Goa State Legal Service Authority.
- 4. The Sanctioned Strength of the Goa State Legal Services Authority as per Notification No. 11/4/2018-LD(Estt.)/260 dated 05th February, 2019 consist of the following classes and categories designated as under:—

- 5. The Goa State Legal Services Authority headed by the Executive Chairman of Goa State Legal Services Authority and Member Secretary shall exercise the power and perform the functions conferred on or assigned by the Executive Chairman of Goa State Legal Services Authority.
 - 1) Member Secretary of the Goa State Legal Services Authority shall be the Drawing and Disbursing Officer (DDO) of Goa State Legal Services Authority headed by the Executive Chairman.
 - 2) The Member Secretary of the Goa State Legal Services Authority shall route their submissions to the Hon'ble the Chief Justice and Patron in Chief through Registrar/Principal Secretary to the Hon'ble The Chief Justice, High Court of Bombay.
- 6. Procedure for Direct Recruitment or Nomination.— (1) Where appointment is to be made, by direct recruitment or nomination, the Member Secretary shall issue a notice inviting applications from eligible candidates for being included in the Select list of respective posts, on the official website of the Goa State Legal Services Authority. Such notice shall also be published in one widely circulated English and one widely circulated and also in one Marathi newspaper and in one widely circulated Konkani newspaper, if any.

The notice shall indicate the number of existing vacancies sought to be filled up. It may also indicate the number of vacancies that are expected to arise in next two years. In case, the expected vacancies are indicated, the selection process shall be conducted for filling up both existing and expected vacancies for one year.

- (2) Such notice, in addition to being published in the newspapers as aforesaid and as may be directed, by the Hon'ble the Chief Justice, shall also be published on the Notice Boards of the Offices of the Goa State Legal Services Authority inter-alia indicating the qualifications prescribed for the post and calling upon the applications alongwith copies of the required attested documents to be submitted on or before the prescribed date.
- (3) The Candidate in his/her/their application shall declare as to whether he has been arrested anytime or whether there is any criminal prosecution pending against him or whether he is convicted by a Criminal Court or whether he has been held guilty or is facing disciplinary enquiry or terminated/compulsorily returned from any service in past.
- 7. Select List.— (1) A Select List of candidates shall be prepared for appointment to each post in accordance with these rules and notified on the Notice Board and the official website of the Goa State Legal Services Authority.
- (2) The Select List shall consist of names of candidates equal to the number of vacancies notified as per sub-rule (1) of rule 6, arranged in order of merit. If considered necessary, a wait list of candidates, arranged

in order of merit, may be prepared not exceeding twenty five percent of the total number of vacancies notified.

(3) The aforesaid list(s) so prepared shall ordinarily be valid for a period of one year from the date of its notification as above:

Provided that the Hon'ble The Chief Justice and Patron in Chief of Goa State Legal Service Authority may, in his discretion, direct the appointment from the above wait list(s) even after the expiry of the period of two years until a new list is prepared in accordance with the rules.

- 8. *Probation.* (1) A person appointed to the service by direct recruitment or nomination shall be on probation for a period of two years or until an order declaring such person to have satisfactorily completed the period of probation is made by the Appointing Authority, whichever is later.
- (2) The Services of a probationer are liable to be terminated without notice and without assigning any reason.
- 9. Nomination of Judge for supervision.— The Hon'ble The Chief Justice and the Hon'ble Executive Chairman of the Goa State Legal Services Authority may nominate the Member Secretary of the Goa State Legal Service Authority for supervising the process of selection of the candidates for being included in the select list of any of the above mentioned posts and may direct the Member Secretary for taking assistance of any of the Judicial Officers from the District Judiciary of Goa for completing the process of recruitment.
- 10. Recruitment Norms.— Appointment of the Officers and members of the staff on the Establishment of the Goa State Legal Services Authority may be made:
 - i) By direct recruitment
 - ii) By selection,
 - iii) By Transfer
 - iv) By promotion,
 - v) By deputation, as the case may be

"Provided further that the maximum age limit for direct recruitment as specified in the Schedule shall be relaxable for the Scheduled Castes, Scheduled Tribes and Other Backward Classes in accordance with the orders issued by the Government of Goa from time to time in that regard".

(ii) The number of posts, mode of appointment, qualifications, classification of the post and level in the pay matrices attached thereto and other matters shall be as specified in the Schedule.

Written Examination shall be held for recruitment of all group "C" Posts. The examination may be conducted departmentally, wherever the department possesses the requisite expertise and capacity to conduct the examination.

- (iii) Syllabus and Scheme of examination shall be designed by considering the nature of duties assigned to the posts and published in the notice inviting applications on the website of the Authority. The syllabus may encompass questions based on essential qualification, general knowledge, reasoning ability, quantitative aptitude, etc. commensurate with the degree/level of understanding required for the post.
- (iv) The total marks of written examination shall be 100 marks and duration of examination shall be decided by the Authority Department according to the nature of examination i.e subjective or combination of both.
- (ν) Physical endurance test shall be conducted for the posts which require physical standards in terms of recruitment rules and only the successful candidates shall be shortlisted for written examination. Such test shall be conducted prior to written examination.

- (vi) Physical endurance test or skill/aptitude test being qualifying in nature shall not be considered for drawing merit list.
- (vii) Skill test/aptitude test, wherever necessary, may be considered for screening eligible candidates to be called for written examination and only qualified candidates shall be called for written examination.
- (viii) Selection of the Candidates shall be determined in accordance with the marks obtained by each candidate in the written examination as per merit. The Head of Department/Appointing Authority shall publish the entire result on the notice board of the Department, as well as on the Website of the Goa State Legal Services Authority.
- (ix) If two or more candidates secure equal marks in the written examination then order of merit shall be as per their date of birth and if in case the date of birth is also same, then the candidate possessing higher educational qualifications will be placed higher in the merit list.
- (x) There shall be no allocation of marks for educational qualifications and the selection of the candidates shall be done strictly as per the marks scored in written/online examination and as per procedure laid down in this Office Memorandum.
- (xi) The Head of the Department/Appointing Authority shall based on the results declared on the website of this Authority, proceed to verify the documents of equal number of candidates as number of post advertised plus 10% wait list candidates. The verification process shall be conducted on the same date/s when the Department selection committee shall meet for finalizing the select list.
 - 11. Role of Departmental Selection Committee (DSC).—
 - i. The Member Secretary shall ensure that, the Departmental Selection Committee is constituted in terms of standing instructions/guidelines issued from time to time. The Member Secretary shall furnish a copy of Notification in this regard, at the request of the members.
 - ii. In the event, the expert members form OBC/ST/SC/Ex-serviceman does not attend the selection committee meeting after being duly served at least three clear days in advance, the Chairman of the Departmental Selection Committee/Head of Department, if the Chairman is other than Head of Department, shall intimate the fact to the controlling Officer/Department or Institution for further action against such Officer, unless the officer justifies the non-attendance.

Further, absence of expert shall not invalidate the selection proceedings and the Departmental Selection Committee shall proceed with the selection process. The role of the expert members shall be limited to ensuring that the roster/reservation is verified by the Competent Authority and that the candidate possesses valid caste/discharge certificate issued by the competent Authority.

- iii. The Departmental Selection Committee shall check the copy of the advertisement published in local dailies and ascertain the number of posts advertised alongwith details of reservation of vacancies so advertised.
- iv. The Departmental Selection Committee shall first proceed to shortlist candidates belonging to person with disability category and ex-servicemen based on merit. The candidates so shortlisted shall be adjusted against the category to which they belong i.e. unreserved, scheduled tribes, scheduled castes, and other backward classes. The vacancies in these categories shall be reduced to that extent. In case, persons under these categories are not available, the number of such advertised vacancies shall be deducted from the unreserved category. For instance, the posts advertised are say 10 viz. 05 UR, 02 ST, 01 SC and 02 OBC, out of which 01 post to be filled from person with disability category and 01 post under ex-servicemen category and if the candidate under person with disability category is unavailable,

it shall be deducted form unreserved category i.e. 5-1= 4. i.e. the Departmental Selection Committee shall proceed to select only 04 candidates belonging to unreserved category.

- v. The Departmental Selection Committee shall then proceed to select candidates of unreserved category as per the descending order of marks scored in written/online examination.
- vi. In case of candidates belonging to reserved category, who by virtue of their merit in written examination are eligible for selection against unreserved category, they shall be adjusted against unreserved category, only if they have not availed age relaxation or any other concession/relaxation other than payment of fees.
- vii. Once the Departmental Selection Committee finalizes the list of unreserved category candidates, it shall proceed to prepare selection list of reserved category candidates.
- viii. The Department shall, once finalize selection list is prepared, arrange to verify the essential qualification of the candidates and ensure that the candidate is eligible vis-à-vis essential qualification/criteria for the post as per the recruitment rules.
- ix. The Departmental Selection Committee shall, in addition to select list also prepare a separate wait list upto 10% of the vacancies based on merit of the candidates in their respective category.
- 12. Provided further that the candidate from the wait list may be considered, only if the candidate from the select list does not accept the offer of appointment.
 - (i) The process of selection comes to an end once the vacancies advertised are filled up. The wait list shall be used as a reservoir to fill the advertised existing/anticipated vacancies.
 - (ii) The wait list shall lapse on the declaration of the date of subsequent examination for the same category or after a period of one year from the date of preparation of such wait list, whichever is earlier.

(iii) The quorum:—

Non-attendance/non availability of any member of the Departmental Selection Committee other than Chairman shall not invalidate the proceeding of such committee provided minimum 2 members were present.

- (*iv*) Final Selection List:— Once the Departmental Selection Committee prepares the final selection list and wait list, which shall be subject to verification of documents, the Head of Department/Appointing Authority shall publish the on notice board and on the website of the Goa State Legal Services Authority preferably on the same day, but not later than three days from the date of meeting of selection committee. In case the selection committee meeting was held on more than one day, then the period of three days shall be counted from the last day of such meeting.
- (v) The Ministry of Personnel, Public Grievances and Pensions (Department of Personnel and Training) vide letter no. 39020/09/2015/Estt.(B) dated 23rd October, 2015, has dispensed with the interview for all Group 'C' and 'D' (which are now reclassified as Group 'C' posts. Interview should be also discontinued for non-gazetted posts of Group 'B' category.
- (vi) Specific and isolated Group 'B' non-gazetted posts for which any particular department considers interview absolutely essential, clearance of The Hon'ble Chief Justice would need to be obtained. It is clarified that since the skill test and physical test are different from interview such tests may continue.
- 11. *Method of recruitment, age limit and other qualifications.* The method of recruitment to the said posts, age limit, qualifications and other matters connected therewith shall be as specified in the Schedule.

Provided that the Government may, in consultation with the Chief Justice and Patron in Chief, vary the number of posts specified in column (3) of the Schedule from time to time subject to exigencies of work.

- 12. Special Deputation.— The Hon'ble The Chief Justice may at his discretion appoint any person on the Establishment, on deputation from the District Judiciary in the State of Goa, any Government Department, Public Sector undertaking or Autonomous Body. Provided that the appointment from Government Department/Public Sector undertaking skill made only with the consent of the Government.
- (2) In the case of employees who have retired upon superannuation on or after 1st day of January, 2014, till the commencement of these rules, their extension of age for all purposes including pay and allowances shall be protected for the purpose of pension and pensionary benefits.
- 14. Overriding power of the Hon'ble The Chief Justice and Patron in Chief of Goa State Legal Service Authority.— Notwithstanding anything contained than in accordance with these rules, the Hon'ble The Chief Justice and Patron in Chief shall have power to:
 - a) appoint any person at any time otherwise than in accordance with these rules in a temporary vacancy and the appointment so made shall be as effective and valid as any other appointment made in accordance with these rules:
- 15. Residuary matters.— With regards to matters not specifically covered by or under these Rules, including the service conditions shall be governed by Law, Rules and Regulations or norms as applicable to the State Government employees, in general, in so far as these are not inconsistent with or repugnant to these Rules.
- 16. Powers to relax.— Where the Authority is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and with the approval of the Government, relax any of the provisions of these Rules with respect to any class or category of persons.
- 17. Savings.— Nothing in these Rules shall affect reservation, relaxation of age limit and other concessions required to be provided for Schedule Castes, Schedule Tribes, Other Backward Classes, Ex-Serviceman and other special categories of persons in accordance with the orders issued by the Government from time to time in that regard.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Goa hereby makes the following rules to regulate the recruitment to the Group 'C', Non-Gazetted, Ministerial and Non-Ministerial posts, in the Directorate of Art and Culture, Government of Goa, namely:—

- 4. *Disqualification.* No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service:

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. *Power to relax.* Where, the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.— Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes, Other Backward Classes, Exservicemen and other special categories of persons in accordance with the orders issued by the Government from time to time in that regard.
