In exercise of the powers conferred by Section 14 of the Goa Non-Biodegradable Garbage (Control) Act, 1996 (Act 5 of 1997) (hereinafter referred to as the "said Act"), the Government of Goa hereby directs those officers of the Department of Legal Metrology not below the rank of the Inspector of Legal Metrology shall exercise powers under clause 14 of the Government Notification No. LS-MISC/1915/96/Part-V/692 dated 12th August, 2024, published in the Official Gazette, Series I No. 20 dated 16th August, 2024 (hereinafter referred to as the "said Notification") and for efficient implementation of the said Notification such officers shall exercise the following powers, namely:—

- (i) the power of inspection, verification and enforcement of the provisions contained in clauses 5, 8, 9 and 10 of the said Notification.
- (ii) the power to enter and search, at all reasonable times, any premises, place, vehicle, or facility wherein any activity connected with the Deposit Refund System is carried on or reasonably suspected to be carried on;
- (iii) the power to inspect any DRS Product and examine all books, registers, records, accounts, digital systems, or documents maintained in relation thereto, whether in physical or electronic form;
- (*iv*) the power to seize any DRS Product, package, register, record, document, or digital database which appears to be in contravention of the provisions of the said Notification, or which may be required as evidence in any proceedings under the Act or this scheme.
- (v) the power to return the DRS Product seized for non-affixation of USI on all DRS products, if the concerned entity, ensures affixation of a valid USI within a period of fifteen days from the date of such seizure.
- (vi) the power to record particulars, obtain necessary signatures and retain the seized DRS product for prosecution or dispose it off as he may deem fit.

This Order shall come into force on the date of its publication in the Official Gazette.

In exercise of the powers conferred by Section 5 of the Goa Non-Biodegradable Garbage (Control) Act, 1996 (Act 5 of 1997) read with Section 21 of the General Clauses Act, 1897 (Act No. 10 of 1897), the Government of Goa hereby amends the Government Notification No. LS MISC/1915/96/Part-V/692 dated 12th August, 2024, published in the Official Gazette, Series I No. 20 dated 16th August, 2024 (hereinafter referred to as the "principal Notification"), as follows, namely:—

In the principal Notification,—

- (*i*) in clause 1,—
 - (a) for sub-clause (i), the following sub-clause shall be substituted, namely:—

- "(1) "DRS Product" means a product made of non-biodegradable material specified in the Schedule of the Act and used for the purpose of packing the commodity suitable for sale in the State of Goa but does not include,—
 - (a) a package of cooked food product sold by a hotel, restaurant or cafe or any other eatery as a takeaway;
 - (b) a packaged commodity of price not exceeding the amount as notified by the Scheme Administrator from time to time;
 - (c) a packaged commodity of volume not exceeding the volume as notified by the Scheme Administrator from time to time;
 - (d) flexible plastic packaging used for sale of milk;
 - (e) a product of the manufacturer registered as Micro Enterprises under the Micro, Small and Medium Enterprises Development Act, 2006 (27 of 2006).
 - (b) after sub-clause (k), the following sub-clause shall be inserted, namely:—
- "(ka) "liquor" means a liquor as defined in clause (1) of Section 2 of the Goa Excise Duty Act, 1964 (Act No. 5 of 1964);"
- (c) in sub-clause (w), for the words "System Administrator", the words "Scheme Administrator" shall be substituted;
 - (ii) in clause 4,—
- (a) in sub-clause (v) for the words, "all DRS Escrow accounts" the words "all DRS escrow accounts and current accounts" shall be substituted;
- (b) in sub-clause (viii), for the words "The deposit shall be fully refunded," the words "shall refund full deposit" shall be substituted;
 - (c) after sub-clause (xi), the following sub-clause shall be inserted, namely,:—
 - (xii) shall ascertain and determine the validity of the USI from time to time.";
- (iii) in clause 6, in sub-clause (iii), for the words "Scheme Operator, the words "System Operator" shall be substituted;
 - (iv) in clause 8,—
 - (a) for the words "Scheme Operator" and "System Administrator", wherever they occur, the words "System Operator" and "Scheme Administrator" shall be respectively substituted;
 - (b) for sub-clause (v), the following sub-clause shall be substituted, namely:—
 - "(v) Every Manufacturers shall transfer an amount equivalent to the deposit of each DRS product into such escrow account as designated by the Scheme Administrator from time to time."
 - (v) after clause 10, the following clauses shall be inserted, namely:—
 - "10A. Verification and inspection of DRS Products.— (1) Every Manufacturer (Producer, Importer, Brand Owner), dealer, retailer, distributor, or any obligated entity engaged in the manufacture, import, storage, distribution, or sale of DRS Products shall present such products bearing or displaying a valid and scannable USI, for inspection and verification. Such verification and Inspection may take place at,—
 - (i) the registered business premises, additional place of business, or warehouse of the obligated entity;
 - (ii) the premises of a retailer, distributor, or dealer where such DRS products are offered or exposed for sale;
 - (iii) any transport hub, storage facility, or other location where the products are in the course of trade or commerce; or

- (iv) any other place as may be notified or specified by the authorized officer for this purpose.
- (2) Every DRS Product presented for verification shall be complete in itself with a securely affixed USI conforming to the prescribed standards as defined by the Scheme Administrator.
- (3) The USI affixed to the DRS product shall remain legible and scannable throughout the lifecycle of such product.
- 10B. Disposal of Seized DRS Products and Recording thereof.— (1) The DRS product seized for non-compliance under mandated USI on all DRS products may be returned if the concerned entity ensures affixation of a valid USI, within period of fifteen days from the date of such seizure.
- (2) When DRS products are seized, the authorised officer shall record particulars, obtain necessary signatures, and they may retain such DRS product for prosecution or dispose it off as may deem fit.
 - (vi) After clause 13, the following clause shall be inserted, namely:—
- "14. Penalties.— (1) Whoever contravenes the provisions contained in clause 5, clause 8, clause 9, or clause 10 of this notification shall be punishable with fine which may extend to twenty-five thousand rupees. In addition, to the deposit that has not been deposited in the escrow account such batch of commodity packed in DRS Product shall be liable for confiscation;
- (2) Whoever tampers with, forges, alters, removes, or in any manner manipulates, a Unique Serialized Identifier (USI) affixed on a Deposit Refund Scheme (DRS) product prior to the sale of such product, he shall be punishable with fine which may extend to twenty-five thousand rupees and such batch of commodity packed in DRS Product shall be liable for confiscation or any other criminal liability under the applicable laws;
- (3) Whoever manufactures or sells DRS Product without affixation of a valid USI, shall be punishable with fine which may extend to twenty thousand rupees and such batch of commodity packed in DRS Product shall be liable for confiscation.
- (4) The penalties specified in this clause shall be in addition to any other action taken, penalty imposed, or proceeding that may be initiated, against the person violating provisions of this notification.".

This Notification shall come into force on the date of its publication in the Official Gazette.
