Sub.: Amendment to State Sector Scheme 'Kera Suraksha Insurance' Scheme.

AMENDMENT

Para No. 8 Kera Suraksha Insurance scheme will be replaced and shall be read as below:

Kera Suraksha Insurance scheme.— The 'Kera Suraksha Insurance' scheme is implemented by the Coconut Development Board in association with The New India Assurance Company Ltd; Tripunithura specified by Coconut Development Board for providing accidental insurance coverage to a maximum of

Rs. 7.00 lakhs to workers/labourers engaged in coconut farms, including those performing high-risk activities such as coconut tree climbing, neera tapping, coconut harvesting, hybridization and other essential farm operations. It also includes workers/labourers involved in coconut peeling and de-shelling, whether on-farm or in small-scale coconut based industries. 'Kera Suraksha Insurance' scheme is a comprehensive group personal accident insurance scheme implemented for the benefit of coconut pluckers with a premium of Rs. 956/ or as fixed by Coconut Development Board which is shared between the Coconut Development Board and the beneficiary i.e coconut plucker in the ratio of 85:15%. At present, the beneficiary has to bear Rs. 143/ as the beneficiary share and the balance Rs. 813/ is borne by the Coconut Development Board. In-spite of promoting the scheme through various forums, the traditional coconut pluckers are hesitant to take up the insurance scheme.

It is therefore, decided to insure all the workers/labourers engaged in coconut farms, including those performing high-risk activities such as coconut tree climbing, neera tapping, coconut harvesting, hybridization and other essential farm operations. It also includes workers/labourers involved in coconut peeling and de-shelling, whether on-farm or in small-scale coconut based industries under the 'Kera Suraksha Insurance' Scheme from 2025-26 onwards. The insurance premium payable by the beneficiary as per the pattern decided by Coconut Development Board from time to time will be borne by the State Government to cover all workers/labourers engaged in coconut farms, including those performing high-risk activities such as coconut tree climbing, neera tapping, coconut harvesting, hybridization and other essential farm operations. It also includes workers/labourers involved in coconut peeling and de-shelling, whether on-farm or in small-scale coconut based industries operating in the State of Goa by providing insurance coverage of Rs. 7.00 lakhs or as decided by the Coconut Development Board from time to time. It is proposed to cover 1000 coconut pluckers every year with a financial outlay of Rs. 1.43 lakhs annually.

Para No. 1 of Redressal of Grievances and disputes will be replaced and shall be read as below:

Redressal of Grievances and disputes.— The Minister of Agriculture shall have the powers to grant any relaxation in general or on cases to case basis regarding procedure and guidelines of the scheme in the interest of insuring all the workers/labourers engaged in coconut farms, including those performing high-risk activities such as coconut tree climbing, neera tapping, coconut harvesting, hybridization and other essential farm operations. It also includes workers/labourers involved in coconut peeling and de-shelling, whether on-farm or in small-scale coconut based industries operating in the State of Goa.

Para No. 1 of Guidelines and Procedure adopted for Sanction will be replaced and shall be read as below:

Guidelines and Procedure adopted for sanction.— Applications are invited from the workers/labourers engaged in coconut farms, including those performing high-risk activities such as coconut tree climbing, neera tapping, coconut harvesting, hybridization and other essential farm operations. It also includes workers/labourers involved in coconut peeling and de-shelling, whether on-farm or in small-scale coconut based industries willing to insure themselves under 'Kera Suraksha Insurance' scheme of Coconut Development Board for taking the benefits under the scheme along with the prescribed documents.

Other contents of the Notification remain the same. This Amendment shall come into force during the financial year 2025-26.

This issues with the approval of the Government and concurrence of Finance (Exp.) Department vide their U.O. No. 1400091529 dtd. 07-11-2025.
