In view of the recent tragic fire incident at Arpora and with a view to ensure strict adherence to fire safety norms and statutory compliance in tourism-related establishments across the State of Goa, the Government hereby constitutes a Joint Enforcement and Monitoring Committee as follows:

1.	Senior Scale Officer, Goa Civil Service	 Chairperson.
2.	Police Inspector (PI)	 Member.
3.	Station Fire Officer, Directorate of Fire & Emergency Services	 Member.
4.	Executive Engineer, Public Works Department (PWD)	 Member.
5.	Executive Engineer, Electricity Department	 Member.

The taluka wise teams and their area of jurisdiction is enclosed as Annexure -I.

The Chairperson of the Committee is appointed as Executive Magistrate under Section 14(1) of BNSS, 2023 for the purpose of enforcement and monitoring in their respective jurisdictions

The Committee shall conduct joint inspections of tourism establishments including but not limited to Nightclubs, Bars & Restaurants, Hotels, Guesthouses & Resorts, Beach shacks and temporary structures and event venues and entertainment establishments.

The Committee shall randomly verify compliance with fire safety norms, including Valid Fire Safety Certificate, functioning of fire-fighting equipment, emergency exits and evacuation routes, electrical installation safety, structural and occupancy compliance, adherence to sound and lighting norms and crowd-control safety measures.

The Committee shall submit monthly report to the Government through the District Magistrates, highlighting establishments inspected, compliance status, violations detected and action taken/recommended.

The Chairperson of the committee shall report to District Magistrate concerned.

This Order shall come into force with immediate effect and shall remain operational until further orders.

- 3. Committee shall identify violations or deficiencies and recommend SoPs for corrective measures for safe functioning of these establishment.
- 4. Committee shall have powers to co-opt expert members if required.
