And whereas, in terms of sub-rule (1) of Rule 4 of the Goa Town and Country Planning (Change of zone of land in the Regional Plan or the Outline Development Plan) Rules, 2024 (hereinafter referred to as the “said Rules”), the Town and Country Planning Department after scrutinizing the said proposals placed such proposals alongwith its scrutiny reports before the Goa Town and Country Planning Board for its recommendations/approval/decision;

And whereas, the Goa Town and Country Planning Board approved the said proposals as specified in column No. 8 of the above Table;

And whereas, notices as required by sub-rule (2) of Rule 4 of the said Rules were published,—

- (i) vide Notification No. 36/18/39A/Notification(30)/TCP/2025/442 dated 13-08-2025, published in the Official Gazette, Series III No. 24 dated 11-09-2025 (as regards proposal at Sr. No. 1);
- (ii) vide Notification No. 36/18/39A/Notification(10)/TCP/2024/52 dated 19-11-2024, published in the Official Gazette, Series III No. 34 dated 21-11-2024 (as regards proposals at Sr. No. 2 & 3);
- (iii) vide Notification No. 36/18/39A/Notification(29)/TCP/2025/377 dated 13-08-2025, published in the Official Gazette, Series III No. 21 dated 21-08-2025 (as regards proposal at Sr. No. 4); and suggestions were invited from the public within a period of thirty days from the date of publication to the said Notifications in the Official Gazette.

And whereas, suggestions received from public were placed before the Goa Town and Country Planning Board in terms of sub-rules (3) of Rule 4 for its recommendation/approval and the Goa Town and Country Planning Board after due consideration of the suggestions received from the public recommended the proposals for change of zone as regards to Sr. No. 1 in its 221st Meeting held on 16-10-2025, Sr. No. 2 in its 212th meeting held on 03-02-2025, Sr. No. 3 in its 217th Meeting held on 29-07-2025 and Sr. No. 4 in its 221st Meeting held on 16-10-2025 and directed to take further action as per sub-rule (4) of rule 4 of the said Rules;

And whereas, as required by sub-rule (4) of Rule 4 of the said Rules, the recommendation/approval/decision of the Goa Town and Country Planning Board along with the said proposals were placed before the Government for its decision and the Government has approved the same;

Now, therefore, in view of the recommendation of the Goa Town and Country Planning Board being approved by the Government and in exercise of the powers conferred by Section 39A of the Goa Town and Country Planning Act, 1974 (Act 21 of 1975) read with sub-rule (5) of Rule 4 of the Goa Town and Country Planning (Change of zone of land in the Regional Plan or the Outline Development Plan) Rules, 2024, the Regional Plan and the Outline Development Plan is hereby altered and modified as specified in column No. (8) of above Table and as directed by the Government for carrying out change of zone of land in respect of the plots of land as specified in detail in column Nos. (2) to (7) of above Table.

The alteration and modification of the Regional Plan and the Outline Development Plan as notified in this Notification shall be subject to the outcome of the PIL Writ Petition Nos. 53 of 2024 and 54 of 2024 which are pending final disposal before the Hon’ble High Court of Bombay at Goa.

Read: Notification No.D.Tpt/EST/2115/P.F.I/2019/4036 dated 27-11-2019 published in Official Gazette, Series II No. 35 dated 28-11-2019.

In exercise of the powers conferred by sub-section (2) of Section 11 of the Goa Motor Vehicles Tax Act, 1974 (Act 8 of 1974) (hereinafter referred to as the “said Act”), the Government of Goa hereby exempts the motor vehicles engaged in mining activities registered on the portal of Department of Mines (DoM), from the payment of the tax leviable under the said Act, for the period from 01-10-2020 to 31-03-2025, subject to the condition that such motor vehicles continues to be in possession and ownership of their respective owners, and remained out of mining business, failing which, they shall be liable to pay the tax due on pro-rata basis. This exemption shall not be applicable to the motor vehicles which have already paid the tax for the period from 01-10-2020 to 31-03-2025, before the publication of this notification in the Official Gazette.

This Notification shall come into force on the date of its publication in the Official Gazette.
