Whereas, the Goa Investment Promotion and Facilitation Board (hereinafter referred to as “the Board”) received an application dated 29-07-2024 from M/s. BramhaCorp Theme Park LLP to establish a theme park/garden in the areas as specified in the Schedule hereto (hereinafter referred to as the “said area”) which is it’s privately owned land (hereinafter referred to as the “said Project”);

The existing Basic Pay of each worker be increased by Rs. 11,000/- per month and then fitted in the above revised Basic Pay Scale.

Dearness Allowance of each worker be increased by an amount of Rs. 11,000/- per month.

**Demand No. 5: Improvement in V.D.A.**

Group Insurance should be done for all workers and they should be insured for an amount of Rs. 50 lakhs per head in case of accident, injury and/or death.

#### **Demand No. 19: Workers Welfare Fund**

Workers Welfare Fund be created wherein representatives of our trade union be represented. Management should contribute every year 5% of the gross profit into the said Fund. The Fund should be utilized for the welfare of workers.
