**Sub:** Encouraging Cooperative Societies to avail Financial Assistance for purchase of Computers.

The Department of Cooperation, Government of Goa is committed to promoting digital transformation and technological strengthening of cooperative institutions in the State. It has been observed that several Dairy Cooperative Societies and Cooperative Credit Societies continue to function and maintain their records manually which results in delay and inefficiency in maintaining accounts, audit preparation and online submission of statutory data.

To address this issues the Government has introduced Financial Assistance for Purchase of Computers and related peripherals (such as printers, UPS and accounting software) for registered Cooperative Societies. The main purpose of this scheme is to encourage all eligible Cooperative Societies to actively avail the financial assistance and to utilize the same for modernizing their functioning by purchasing computer systems. To facilitate transparent and user-friendly application, an Online Module for Financial Assistance has also been developed and is now operational. All Dairy and Cooperative Credit Societies are hereby directed to submit their proposals only through online mode within two (2) months from the date of issue of this circular.

The link for the online submission of application is available on this Departmental official website i.e. [www.coopgoa.gov.in](http://www.coopgoa.gov.in) under the tab “Financial Assistance Portal for Cooperative Societies.” While submitting applications for financial assistance, the eligible societies shall upload all the necessary documents as prescribed under the scheme.

Therefore, Cooperative Societies are staunchly advised to take this opportunity to avail financial assistance to give away with manual book keeping and onboard on digital platform this will ultimately help them to improve the efficiency and record-keeping of the society, ensure timely compliance with audit and returns,

facilitate participation in e-governance and departmental portals and prepare the societies for integration with future digital initiatives of the Department.

The proposal for financial assistance shall be compulsorily submitted through above mentioned departmental portal by their login credentials. All concerned should take note that no physical proposals will be entertained and failure to submit proposals within the stipulated time shall be summarily rejected.

All Zonal Assistant Registrar of Cooperative Societies are directed to disseminate this circular widely, organize awareness sessions and ensure that maximum societies from their jurisdiction submit proposals within the given timeframe. The zonal offices shall also verify and recommend the proposals online within 5 days after the closure of the submission period.

Whereas, it is reported by the Superintendent of Police, South Goa District, Margao, that criminals with an intention of committing crime in Goa, usually stay in Hotel/rented premises with fictitious names and bogus residential/official addresses and telephone numbers and after commission of crime, it becomes very difficult to locate the culprits, on the basis of available information recorded in the registers of Hotels/Guest House/Inns, as on verification it is found to be at times bogus/false.

And whereas, anti-social/criminal or undesirable elements can camouflage their identity for illegal/immoral operations, which need to be contained and regulated. Certain hotel owners/landlords/establishment have a tendency to rent out premises without verifying the antecedents of the person/tenants or informing the local Police;

Now therefore, on being satisfied of the need to take preventive action based on the report of the Superintendent of Police, South Goa District, Margao, I, Egna Cleetus, IAS, District Magistrate, South Goa District, Margao, in exercise of the powers vested in me under Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023, do hereby order that:-

- a) All owner of the houses, buildings, flats and other residential accommodations and the Owners/Management of all Hotels, Lodging & Boarding, Shacks, Private guest houses, Paying Guest facilities, religious bodies, offering temporary accommodations, temporarily residential accommodation, etc., in the whole of South Goa District must verify the bonafides of persons through their proof of identity such as Election card, Driving License, Aadhar card, Passport, Smart card, etc.
- b) No landlords, tenants, owners or person of any house/property falling under the territorial jurisdiction of South Goa District, Goa, shall let, sublet or rent out any accommodation to any person unless the particulars of the tenants have been furnished to the Officer-In-Charge of the concerned Police Station.

- c) All In-Charges of such accommodations shall provide such facilities for inspection and the maintenance of record in the Police Authorities or any other authority authorized by the undersigned.
- d) All Head/Incharges of Nationalized Banks of South Goa District must deploy security guards for security of their ATM's round the clock and install CCTV cameras or shall install ESS (Electronic Survey System) equipped with panic button hooter, two-way communication system & remote outstanding control.

The circumstances do not permit serving of the notice individual to the concerned persons. Therefore, this order is hereby passed ex-parte. It shall be published for public information through the Press, Social Media, etc. and also by affixing copies on the Notice Boards of all Sub-Divisional Magistrates, Mamlatdars and Police Stations.

This order shall come into force with effect from 05-01-2026 and shall remain in operation for a period of 60 days (both days inclusive) unless withdrawn earlier.

Violation of this order is punishable u/s 223 of the Bharatiya Nyaya Sanhita, 2023.

2. Report No. SP/TRF/PAN/1446/2025 Goa dated 24-12-2025 from the Superintendent of Police, North Traffic Altinho, Panaji-Goa.

In exercise of the powers conferred on me under Section 115, 116 & 117 of the Motor Vehicles Act, 1988 and as recommended by the Superintendent of Police, Traffic North, Altinho, Panaji I, Ankit Yadav, IAS, District Magistrate, North Goa District, Panaji, hereby order for closure of road (Phase-I) (A) from P16 near ODP road to P20 near Damin de Goa; (B) Closure of Road from P61 Kadamba Restaurant to P55 near O' Coqueiro Junction w.e.f. 02-01-2026 to 02-03-2026, subject to the following conditions:-

1. Heavy vehicles carrying essential commodities shall not be able to travel on ODP road from Mapusa side due to steep ascent. One lane on the existing carriageway shall be kept open for all vehicular traffic from proceeding from Mapusa to Panaji.
2. All the proposed diversion routes shall be in motorable conditions and sufficient illumination shall be made available all along the route. All the wild vegetation shall be removed and the height of the electrical wires shall be sufficiently maintained.
3. Transportation of Bridge Segments shall not be carried out during the day time.
4. A dedicated lane on either side shall be maintained for the movement of emergency vehicles viz. Ambulance, Fire Brigade etc. This dedicated lane can also be used to ease traffic snarl, if any.
5. Considering the paucity of manpower with Traffic Police, the contractor shall be directed to deploy at least 02 Traffic Marshals during the restriction hours at each Diversion Point to assist the Traffic Police.
6. The contractor shall provide cranes which shall be supervised by PI Traffic Cell Porvorim to remove breakdown vehicles or to ensure smooth flow of vehicles.
7. Traffic Marshals shall be stationed (in consultation with Traffic Police) at all strategic locations with Uniform, Reflective Jackets and Flashing Batons.
8. The contractor shall not close any roads or effect diversion without prior intimation to Traffic Cell Porvorim and Porvorim Police Station.
9. The contractor shall appoint a Supervisor and share his contact details with PI Traffic Cell Porvorim.
10. The PWD shall give wide publicity through Print/Electronic Media regarding the closure/diversion for the information of the motorist and also heavy vehicles including luxury passenger buses.
11. The contractor shall apply for permission for diversion/closure of roads in Phase 2 only upon completion of Phase 1.
