In exercise of the powers conferred on me under Section 112 of the Motor Vehicles Act, 1988 and Rule 264A of the Motor Vehicles Rules, 1991 as amended in 2005 and as recommended by the Dy. Supdt. of Police, Traffic (North), Altinho, Panaji and the Assistant Engineer, SD.I, Works Div.II(Roads), PWD, Panaji-Goa, I, Ankit Yadav, IAS, District Magistrate, North Goa District, hereby order the construction of "Speed Breakers" at the places mentioned in Column No. 2 of the schedule below in the jurisdiction of Corporation of the City of Panaji in Tiswadi Taluka.

SCHEDULE

1.	Four Speed Breakers at Ribandar, Panaji-Goa: One Speed Breaker to be constructed at a distance admeasuring 30 meters before the junction near Nossa Senhora de Remdios Chapel on the road leading towards Panaji. One Speed Breaker to be constructed at a distance admeasuring 10 meters before the junction near the Post Office on the road leading towards Panaji. One Speed Breaker to be constructed at a distance admeasuring 30 meters before the 'Y' junction near Tamba House, on the road leading from Ribandar to Panaji. One Speed Breaker to be constructed at a distance admeasuring 15 meters away from the Chapel, on the road leading from Ribandar to Panaji.	Speed Breaker

The above Speed Breakers shall be painted with white thermoplastic fluorescent paint and fixed with blinkers for better visibility.

Further, in exercise of the powers conferred on me under Section 116 of the above Act, I also authorize the erection of cautionary signboards "Speed Breakers" at about 40 mts. on either side of the speed breakers in advance of the speed breakers and traffic signboard showing the sign "Speed Breakers" at the placement in order to regulate the motor vehicular traffic.

The Commissioner, Corporation of the City of Panaji, Panaji-Goa is directed to publish this notification through the Director of Information and Publicity and in local newspapers and P.W.D. (Engineering Cell), to make necessary arrangements to erect the signboards at the places indicated above as per the specification laid down by the Ministry of Road Transport and Highways and as published in the Official Gazette by the Government of Goa and report compliance within thirty days time.
