O. 99(E).— In exercise of the powers conferred by Section 3 and Section 17A of the Census Act, 1948 (37 of 1948) read with rules 6A and 6D of the Census Rules, 1990 and in supersession of the notification of the Government of India in the Ministry of Home Affairs (Office of the Registrar General, India) number S. O. 119(E), dated the 7th January, 2020, published in the Gazette of India, Extraordinary, Part II, Section 3, sub-section (ii), dated the 9th January, 2020, except as respects things done or omitted to be done before such supersession, the Central Government hereby declares that the houselisting operations of the Census of India, 2027 shall take place between 1st April, 2026 and 30th September, 2026 in all States and Union Territories in India during the period of thirty days specified by each State and Union territory. S.O. 353(E).— In exercise of the powers conferred by sub-section (I) of Section 8 of the Census Act, 1948 (37 of 1948), and in supersession of the notification of the Government of India in the Ministry of Home Affairs (Office of the Registrar General, India) number S.O. 120(E), dated the 7th January, 2020 published in the Gazette of India, Extraordinary, Part II, Section 3, sub-section (ii), dated the 9th January,

12. Whether the head of the household belongs to Scheduled Caste/Scheduled Tribe/Other.
13. Ownership status of the census house.
14. Number of dwelling rooms exclusively in possession of the household.
15. Number of married couple(s) living in the household.
16. Main source of drinking water.
17. Availability of drinking water source.
18. Main source of lighting.
19. Access to latrine.
20. Type of latrine.
21. Waste water outlet.
22. Availability of bathing facility.
23. Availability of kitchen and LPG/PNG connection.
24. Main fuel used for cooking.
25. Radio/Transistor.
26. Television.
27. Access to internet.
28. Laptop/Computer.
29. Telephone/Mobile Phone/Smartphone.
30. Bicycle/Scooter/Motorcycle/Moped.
31. Car/Jeep/Van.
32. Main Cereal consumed in the household.
33. Mobile Number (for census related communications only).

The following draft rules, which the Government of Goa proposes to make in exercise of the powers conferred by sub-sections (1) and (2) of Section 199 of the Goa Land Revenue Code, 1968 (Act No. 9 of 1969), so as to further amend the Goa Land Revenue (Conversion of use of land and non-agricultural assessment) Rules, 1969, are hereby pre-published as required by sub-section (3) of Section 199 of the said Code for information of all the persons likely to be affected thereby and notice is hereby given that the said draft Rules shall be taken into consideration by the Government after expiry of a period of fifteen days from the date of publication of this Notification in the Official Gazette.

All objections and/or suggestions to the said draft rules may be forwarded to the Secretary (Revenue) to the Government of Goa, Revenue Department, Secretariat, Porvorim Goa, before the expiry of the said period of fifteen days so that they may be taken into consideration at the time of finalization of the said draft rules.

DRAFT RULES

In exercise of the powers conferred by sub-sections (1) and (2) of Section 199 of the Goa Land Revenue Code, 1968 (Act No. 9 of 1969) and all other powers enabling it in this behalf, the Government of Goa hereby makes the following rules so as to further amend the Goa Land Revenue (Conversion of use of land and non- agricultural assessment) Rules, 1969, namely:—

1. *Short title and commencement.*— (1) These rules may be called the Goa Land Revenue (Conversion of use of land and non-agricultural assessment) (Amendment) Rules, 2025.

(2) They shall come into force on the date of their final publication in the Official Gazette.

2. *Substitution of Schedule II.*— For Schedule II appended to the Goa Land Revenue (Conversion of use of land and non-agricultural assessment) Rules, 1969, the following Schedule shall be substituted, namely:—

SCHEDULE II

(See rule 7)

Whereas an application has been made to the Collector of (hereinafter referred to as “the Collector” which expression shall include any officer whom the Collector shall appoint to exercise and perform his powers and duties under this grant) under Section 32 of the Goa Land Revenue Code, 1968 (hereinafter referred to as “the said Code”, which expression shall where the context so admits include the rules and orders thereunder) by inhabitant of being the occupant/tenant of Survey No. in the village of in the taluka (hereinafter referred to as “the applicant” which expression shall, where the context so admits, include his heirs, executors, administrators and assigns) for permission to use for the plot of land (hereinafter referred to as the “said plot”) described in Appendix I hereto and indicated by the letters on the site plan annexed hereto, forming part of survey number and measuring the same a little more or less.....

Now, this is to certify that the permission to use of the said plot is hereby granted, subject to the provisions of the said Code, and rules thereunder, and on the following conditions, namely:—

1. *Leveling and clearing of the land.*— The applicant shall be bound to level and clear the land sufficiently to render suitable for the particular non-agriculture purpose for which permission is granted and to prevent insanitary conditions.

2. *Assessment.*— The applicant in lieu of the assessment heretofore leviable in respect of the said plot shall pay to Government on the day of in each year an annual assessment of Rupees (Rs.....) during the fifteen years commencing on the day of 20..... and on the expiry of the said period of fifteen years, such revised assessment as may from time to time be fixed by the Collector under the said Code:

Provided that, where the applicant is a Co-operative Housing Society or the Goa Housing Board, it shall be entitled to such exemption from the payment of altered assessment as is permissible under sub-rule (3) or rule 20.

3. *Use.*— The applicant shall not use the said land and building erected or to be erected thereon for any purpose other than (here insert the specific purpose for which the permission is granted without the previous sanction of the Collector.

4. *Liability for rates.*— The applicant shall pay all taxes, rates and cesses leviable on the said land.

5. *Penalty clause.*— (a) If the applicant contravenes any of the foregoing conditions the Collector may, without prejudice to any other penalty to which the applicant may be liable under the provisions of the said Code continue the said plot in the occupation of the applicant on payment of such fine, and assessment as he may direct.

(b) Notwithstanding anything contained in sub-clause (a) it shall be lawful for the Collector to direct the removal or alteration of any building or structure erected or used contrary to the provisions of this grant within such time as is specified in that behalf by the Collector, and on such removal or alteration not being carried out within the specified time, he may cause the same to be carried out, and recover the cost of carrying out the same from the applicant as an arrears of land revenue.

6. *Code provisions applicable.*— Save as herein provided, the grant shall be subject to the provisions of the said Code and the rules thereunder.
