The Government of Goa is pleased to introduce a new Scheme “Mukhyamantri Hastakala Adhunikaran Yojana” and the same is published in the Official Gazette for information of general public.

Mukhyamantri Hastakala Adhunikaran Yojana

1. *Short title and commencement.*— 1. The scheme shall be called “Mukhyamantri Hastakala Adhunikaran Yojana.”

2. It shall come into force from the date of its publication in the Official Gazette.

2. *Objectives.*— The Primary Objective of the ‘Mukhyamantri Hastakala Adhunikaran Yojana’ is to significantly enhance the mechanization of Handicraft, Textile, and Coir production in Goa. This scheme aims to bolster these traditional industries by offering subsidies for the acquisition of advanced machinery and equipment. By doing so, it seeks to elevate productivity, improve product quality, and boost the competitiveness of artisans and producers in the region. Given the rich cultural heritage and economic significance of Handicrafts in Goa, this initiative not only preserves traditional crafts but also empowers local artisans to thrive in a modern market.

3. *Definitions.*— In this scheme, unless the context otherwise requires:

- “Government” means the Government of Goa.

- “Department” means the Department of Handicrafts, Textile and Coir.
- “Director” means Director of Department of Handicrafts, Textile and Coir.
- “Beneficiary” means any individual, NGO, Self Help group, registered society, or artisan cluster involved in the production of handicrafts, textiles or coir.
- “Authorized dealer” means a agency empanelled on GeM Portal or empanelled with the Department of Handicrafts, Textile and Coir.

4. *Trades Covered.*—

1. Tailoring and Embroidery
2. Handloom Weaving
3. Dyeing and Batik Printing
4. Wood Craft
5. Bamboo and Cane Craft
6. Pottery and Ceramic Craft
7. Paper Mache
8. Metal Crafts
9. Coir Craft
10. Coconut Crafts
11. Jute Crafts
12. Soft Toys
13. Imitation Jewellery
14. Candle/Wax Item Making
15. Any other trades related to Handicrafts with the approval of the Director.

5. *Eligibility Criteria.*— a. The Applicant must possess Artisan Certificate/ID card issued by the State Government or Government of India or Artisan Card issued under PM Vishwakarma Scheme or the artisan must have undergone training in Handicrafts/Textile/Coir trade from any Government/Government recognized organization.

- b. The Applicant shall be resident of Goa for last 15 years.
- c. The Applicant shall have minimum educational qualification of 5th standard pass.
- d. The Applicant shall be in the age group of 18 to 60 years.
- e. The Applicant must not have availed of a similar subsidy for the same trade in the past three years.
- f. The applicant must have the place for business activity.

6. *Pattern of Assistance.*— A. The Scheme will provide subsidy to the Artisans of trades as specified in clause 4 of the scheme for the purchase of machinery/equipments essential for production.

B. The pattern of assistance shall be as follows:

- a. Subsidy up to 75% of the cost of Machinery/equipment or maximum of Rs. 5,00,000/- whichever is less for individual beneficiary and subsidy up to 90% or maximum of Rs. 5,00,000/- whichever is less for the individual beneficiary belonging to Scheduled Caste/Scheduled Tribe category.

b. Subsidy up to 75% of the cost of Machinery/equipment or maximum of Rs. 7,00,000/- whichever is less for NGOs/Registered Societies/Artisan cluster/Self Help Group and subsidy up to 90% or maximum of Rs. 7,00,000/- whichever is less for the NGO/Artisan cluster or Self Help Group/registered society having 80% members of Scheduled Caste/Scheduled Tribe category.

7. *Documents required.*— a. Application form in Annexure ‘A’.

b. Self attested Artisan Certificate/ID card issued by the State Government or Government of India or Artisan Card issued under PM Vishwakarma Scheme or self attested copy of the trade certificate issued by any Government/Government recognized organization.

c. Self attested copy of 15 years Residence Certificate issued by the Mamlatdar of the respective Taluka.

d. Self attested copy of Aadhar Card .

e. Self attested copy of Caste Certificate issued by Competent Authority of Goa in case of SC/ST beneficiary.

f. Self attested copy of Educational Qualification Certificate.

g. Budgetary quotation including GST from the Authorized Dealer for the purchase of machinery/equipments.

h. Self attested copy of Lease agreement or House Tax Receipt, NOC of the owner of land/house if Land/House belongs to other person.

8. *Application procedure.*— a. The applicant shall submit the application in Annexure ‘A’ along with the documents mentioned at clause 7 of the scheme to the Department.

b. The application, after scrutiny shall be placed before the committee in accordance with clause 9 of the scheme.

9. *Committee for recommending the applicants.*— The Committee comprising the following members shall be constituted by the Director for the purpose of recommending the applicants.

1. Assistant Director — Chairman.

2. Accountant — Member.

3. Handicraft Inspector — Member Secretary.

4. One specialized person from the concerned trade from which the equipment/machinery is proposed to be purchased — Member

10. *Role of the Recommending Committee & procedure to release the subsidy.*— a. The Committee shall verify the application.

b. The Committee shall submit recommendation to the Director for the decision.

c. Director, on recommendation of the committee shall approve/reject the application and issue the Sanction Order to the Authorized Dealer/Vendor.

11. *Procedure for Release of subsidy.*— a. After receiving the application, the committee as mentioned in the clause 9 of the scheme shall verify the application and submit its report recommendation/rejection before the Director for the final decision.

b. Based on the recommendation of the Committee, the Director shall approve/reject the applications & issue the Sanction Order to the Authorized Dealer/Vendor.

c. Based on the Sanction Order, applicant shall purchase the machinery/equipment from the Authorized Dealer by paying his share and submit the GST bill along with the photograph to the Department of

Handicrafts, Textile and Coir within 15 days from the purchase of machinery/equipment to release the subsidy to the Authorized Dealer.

12. *Utilization and Monitoring.*— The Department of Handicrafts, Textile & Coir shall inspect and monitor the utilization of the Machinery/Equipment purchased under the Scheme.

13. *Recovery of Subsidy.*— In case of non-compliance with the terms and conditions of the Scheme, the Subsidy granted shall be recovered as per the Land Revenue Code.

14. *Power to Relax.*— The Government with reason recorded in writing shall be empowered to relax any or all clauses/conditions of the Scheme in genuine cases for the release of subsidy.

15. *Evaluation of the Scheme.*— The Scheme shall be evaluated after every three years.

16. *Redressal of grievances and disputes.*— Grievances if any, arising out of the implementation of this scheme, shall be heard and decided by the Director of Handicrafts, Textile and Coir and the decision of the Director of Handicrafts, Textile and Coir in this regard shall be final and binding on all concerned.

17. *Power of the Government.*— Government shall be empowered to modify any or all the clauses of the scheme as and when considered necessary for the betterment of the scheme.

18. *Validity of the Scheme.*— The scheme Mukhyamantri Hastakala Adhunikaran Yojana shall remain in force for a period of five years from the date of its publication unless extended or modified by the Government.
