The Committee will have the following terms of reference.

*I. Co-ordination*

- Facilitate regular interaction among MoSPI, its field offices and the State's statistical departments to plan and implement major national surveys (e.g., NSS, ASI, Economic Census, ASUSE, PLFS, HCES, etc.) and other statistical activities in the State.
- Facilitate the exchange of information on upcoming all-India surveys, sample frames, matching-samples etc. and State participation in these surveys.
- Review and monitor the adoption of MoSPI-issued standards such as National Metadata Structure (NMDS) 2.0, Statistical Quality Assessment Framework (SQAF) etc. within the State statistical system.

d. Serve as a forum for coordination between MoSPI and the State Government's statistical departments, including the State Directorate of Planning, Statistics & Evaluation (DPSE) and other departmental statistical units.

## II. *Quality, Timeliness and Comparability of Statistics*

a. Review State-level and Taluka level statistical outputs (e.g. State Domestic Product and District Domestic Product estimates, State and sub-State level industrial production indices, price indices etc.) for compliance with national standards, timeliness and policy relevance.

b. Identify and address gaps, overlaps or duplication in statistical work at State departmental level, and propose corrective action of rationalization.

c. Promote and monitor adoption of modern and IT-enabled statistical methods in the State statistical system.

## III. *Data dissemination, user engagement and policy relevance*

a. Encourage timely dissemination of State statistical outputs and facilitate alignment with MoSPI's national data dissemination standards (including advance release calendar and metadata standards).

b. Provide feedback to MoSPI on user-needs, State priorities and emerging areas requiring statistical attention.

c. Promote the use of statistics in evidence-based policy making, monitoring and evaluation of programmes at the State level, and encourage State departments to treat statistical offices as key decision-support units.

## IV. *Capacity building and institutional strengthening*

a. Advise on and monitor capacity-development initiatives for the State statistical cadre, departmental statistical units and district-level statistical offices, in collaboration with MoSPI's National Statistical Systems Training Academy (NSSTA).

b. Recommend institutional enhancements (e.g. setting up a statistical cadre, upgrading DPSE and departmental statistical units, improving resources for surveys and IT) for State statistical systems.

c. Facilitate exchange of good practices and innovations among State's Statistical Systems.

Sheet No. 83 of City Panaji, Taluka Tiswadi, District North Goa, State of Goa, from the payment of fees amounting to Rs. 13,12,800/- (Rupees Thirteen lakhs, twelve thousand and eight hundred only) payable under Clause (ii) of sub-section (6) of Section 32, and penalty amounting to Rs. 4,29,600/- (Rupees Four lakhs, twenty-

nine thousand and six hundred only) payable under Section 33, of the said Code subject to the condition that the said land shall be used exclusively for institutional purpose i.e. extension of Kindergarten School building.
