Consequent upon the creation of Kushavati District, vide the notification referred to at ref. No. 4 above, and in order to ensure smooth administration of the Goa Value Added Tax Act, 2005 and the Goa Goods and Services Tax Act, 2017, the Commissioner, in exercise of the powers conferred under Section 13 of the Goa Value Added Tax Act, 2005 (Goa Act No. 9 of 2005) and under Section 4 of the Goa Goods and Services Tax Act, 2017 (Goa Act No. 4 of 2017) and in continuation of the above referred orders, hereby direct that the Additional Commissioner of State Tax (Appeals-South) and the Additional

Commissioner of State Tax (Enforcement–South) shall perform and discharge their duties and exercise their powers in respect of the South Goa District, as well as in respect of the Kushavati District, in respect of all the subjects allotted to them vide above referred orders.

This order shall come into force with effect from 1st day of April, 2026.

In exercise of powers conferred by Section 28 A of the Representation of People Act, 1951, the Government of Goa hereby designates the Director General of Police and all Police Officers functioning in the Assembly Constituencies of South Goa District of Goa State, including the Returning Officers, Assistant Returning Officers, Presiding Officers, Polling Officers and any other officer appointed under this part and personnel of Central Police Forces deployed for Election in the State, as ‘Designated Officers’ for the purpose of Section 28 A of the Representation of People Act, 1951 till the completion of Bye Election process to 21—Ponda Assembly Constituency, 2026 and all such officers shall be subject to the control, superintendence and discipline of the Election Commission of India, New Delhi.
