Whereas, vide order dated 08/10/2020, the Revenue/NRW Sub-Divisions I, II, III & IV were created under WD XX (PHE), PWD (presently known as WD VI, DDW) at Curchorem, Sanguem, Quepem and Canacona respectively.

And whereas, the Revenue Office of SD-V under WD XX (PHE), PWD, Dharbandora was temporarily set up and has been functioning since September, 2023 in the existing premises, utilizing available manpower and resources, as per the directions of the then Hon'ble Minister for PWD, in view of the inconvenience caused to consumers of Sanvordem Constituency who otherwise have to travel a distance of approximately 20 km.

And whereas, ex-post facto approval has been obtained from the Government for the creation of an additional Sub-Division, namely Revenue/NRW, SD-V, WD-VI, DDW, Dharbandora.

Now, therefore, in consideration of the difficulties faced by the consumers of Sanvordem Constituency, the additional Sub-Division is hereby formally created and designated as Revenue/NRW, SD-V, WD-VI, DDW, which shall look after billing, revenue collection and allied matters pertaining to Sanvordem Constituency.

This issues with the approval of the Government.
