In exercise of the powers conferred by Section 5 of the Indian Registration Act, 1908 (Act 16 of 1908), as in force in the State of Goa, and in supersession of the Government Notification No. 8-17-2015-LD(Estt)/917 dated 29-04-2015, published in the Official Gazette, Series I No. 6, dated 07-05-2015, the Government of Goa, for the purposes of the said Act, hereby forms,-

(i) Districts as specified in column (2) of the Schedule I herein below and directs that the limits of such Districts shall be co-extensive with the revenue limits of the respective Districts as specified in the corresponding entries in column (3) of the said Schedule; and

(ii) sub-districts as specified in column (3) of the Schedule II herein below, in the respective Districts specified in column (2) thereof, and directs that the limits of such sub-districts shall be co-extensive with the revenue limits of the Districts as specified in the corresponding entries in column (4) of the said Schedule.
