- II) To streamline and reorganize the poultry sector by governing all the activities in the State of Goa by developing policies, establishing regulatory bodies, licensing, registration, bio-security measure, marketing research and public awareness.
- III) To implement CPCSEA (Committee for the Purpose of Control and Supervision of Experiments on Animals) Guidelines for Poultry/Birds Facility, 2020 and to adopt its directions/guidelines from time to time and to educate the poultry traders and to regularize the poultry/birds trade in Goa.
